

SENATE BILL NO. 2135

1 A BILL for an Act to create and enact a new section to chapter 13-05 of the North Dakota
2 Century Code, relating to removal from office of collection agency officers or employees by the
3 department of banking and financial institutions.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1.** A new section to chapter 13-05 of the North Dakota Century Code is
6 created and enacted as follows:

7 **Suspension and removal of collection agency officers or employees.**

- 8 1. The commissioner of banking and financial institutions may issue and serve upon
9 any collection agency officer or employee and upon the collection agency involved,
10 a complaint stating the basis for the commissioner's belief that the officer or
11 employee is engaging or has engaged in any of the following conduct:
- 12 a. Violating any law, rule, order, or written agreement with the commissioner;
 - 13 b. Engaging in any harassment or abuse, the making of false or misleading
14 representations, or engaging in unfair practices involving collection activity; or
 - 15 c. Performing any act of commission or omission or practice which is a breach of
16 trust or a breach of fiduciary duty.
- 17 2. The complaint must contain a notice of opportunity for hearing pursuant to chapter
18 28-32.
- 19 3. If no hearing is requested within twenty days of the date the complaint is served
20 upon the officer or employee, or if a hearing is held and the commissioner finds
21 that the record so warrants, the commissioner may enter an order suspending or
22 temporarily removing the employee or officer from office for a period not exceeding
23 three years from the effective date of the suspension or temporary removal.

- 1 4. A contested or default suspension or temporary removal order is effective
2 immediately upon service of the order on the officer or employee and upon the
3 collection agency. A consent order is effective as agreed. An officer or employee
4 suspended or temporarily removed from office pursuant to this section is not
5 eligible, while under suspension, for reinstatement to any position within a licensed
6 collection agency.
- 7 5. When an officer or employee, or other person participating in the conduct of the
8 affairs of a collection agency is charged with a felony in state or federal court, the
9 commissioner may immediately suspend the person from office or prohibit the
10 person from any further participation in the collection affairs, or both. The order is
11 effective immediately upon service of the order on the collection agency and the
12 person charged, and remains in effect until the criminal charge is finally disposed
13 of or until modified by the commissioner. If a judgment of conviction, federal
14 pretrial diversion, or similar state order or judgment is entered, the commissioner
15 may order that the suspension or prohibition be made permanent. A finding of not
16 guilty or other disposition of the charge does not preclude the commissioner from
17 pursuing administrative or civil remedies.
