HOUSE BILL NO. 1036 (Legislative Council) (Budget Committee on Government Services) (Representatives Martin, Kerzman)

AN ACT to amend and reenact section 50-06-06.13 of the North Dakota Century Code, relating to an out-of-home treatment program for children with serious emotional disorders.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1. AMENDMENT.** Section 50-06-06.13 of the 1995 Supplement to the North Dakota Century Code is amended and reenacted as follows:

50-06-06.13. Treatment services for severely emotionally disturbed child children with serious emotional disorders. The department may shall establish in all human service regions a program in up to three human service regions to provide out-of-home treatment services for a severely emotionally disturbed medicaid-eligible child with a serious emotional disorder. Before If a child may be is placed in an out-of-home treatment program established under this section, the juvenile court must make a judicial determination that as to whether the placement is in the best interests of the child. The department may not require a parent or legal guardian to transfer legal custody of the child in order to have the child placed in an out-of-home treatment program when the sole reason for the placement is the need to obtain services for the child's emotional or behavioral problems.
