1 A BILL for an Act to create and enact a new section to chapter 15-35 of the North Dakota

2 Century Code, relating to the inspection of schools by the state fire marshal or the state fire

3 marshal's designee; and to amend and reenact sections 15-35-01.1 and 18-01-02 of the North

4 Dakota Century Code, relating to required approval for school district construction projects and

5 the duties of the state fire marshal.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7 SECTION 1. AMENDMENT. Section 15-35-01.1 of the 1995 Supplement to the North
8 Dakota Century Code is amended and reenacted as follows:

9 15-35-01.1. Approval required for certain school district construction projects. 10 Notwithstanding the powers and duties of school boards of public school districts 1. 11 otherwise provided by law, all construction, purchase, repair, improvement, 12 renovation, or modernization of any school building or facility within a school 13 district estimated by the school boards to cost in excess of twenty-five thousand 14 dollars may not be commenced unless approved by the superintendent of public 15 instruction. No such construction, purchase, repair, improvement, renovation, or 16 modernization of any school building or facility may be approved unless the school 17 district proposing the project demonstrates the need, the educational utility of the 18 project, fiscal need, and the capacity to pay for the project under rules adopted by the superintendent of public instruction pursuant to chapter 28-32 after receiving 19 20 input from the state board of public school education. In the event of disagreement 21 between the superintendent of public instruction and the school board applying for 22 approval of a construction project under this section, the school board may appeal 23 the application to the state board of public school education and the decision of the 24 state board approving or disapproving the application is final.

10	<u>1.</u>	<u>The</u>	state fire marshal or the state fire marshal's designee shall inspect each public		
11		and	private elementary and secondary school in this state at least once every		
12		three	e years, prepare an inspection report, and provide copies of the report to the		
13	superintendent of the school district and the superintendent of public instruction.				
14	<u>2.</u>	<u>a.</u>	If a deficiency is noted, the superintendent of the school district shall submit a		
15			plan of correction to the state fire marshal or the state fire marshal's designee		
16			and shall remedy the deficiency within a time period acceptable to the state		
17			fire marshal or the state fire marshal's designee.		
18		<u>b.</u>	If the report discloses an imminent fire hazard, the state fire marshal or the		
19			state fire marshal's designee shall immediately notify the school district board,		
20			the superintendent of the school district, and the superintendent of public		
21			instruction of the hazard. Upon the recommendation by the superintendent of		
22			public instruction for immediate closure, the school district board and the		
23			superintendent of the school district may immediately close some or all of the		
24			school, until the fire hazard is eliminated. In the case of a closure, the		
25			superintendent of the school district in which the public school is located, or		
26			the administrator of the private school shall cooperate with the superintendent		
27			of public instruction to make adequate arrangements for the interim education		
28			of all affected students.

30	Dakota Century Code is amended and reenacted as follows:

2	fire marsha	I and deputy state fire marshals may enforce all the laws of the state providing for:
3	1.	The prevention of fires.
4	2.	The storage, sale, and use of combustibles and explosives.
5	3.	The installation and maintenance of automatic or other fire alarms and fire
6		extinguishing equipment.
7	4.	The means and adequacy of exits in case of fires from all public and private
8		elementary and secondary schools, from all public places, and from all other
9		places in which fifty or more persons congregate from time to time for any purpose.
10	5.	The suppression of arson and the investigation of the cause and origin of fires.
11	6.	The education of the citizens of North Dakota on the hazards of fire, through
12		organized programs.
