1 A BILL for an Act to provide for a postsecondary enrollment options program; and to amend

2 and reenact subdivision q of subsection 1 of section 28-32-01 of the North Dakota Century

3 Code, relating to the rulemaking authority of the superintendent of public instruction.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. Postsecondary enrollment options program. Any North Dakota 6 student enrolled in grade eleven or twelve in a public high school is eligible to receive high 7 school and postsecondary credit for the successful completion of an academic course offered 8 by any postsecondary institution accredited by a regional accrediting organization or a 9 vocational course offered by a postsecondary institution in a program accredited by a national 10 or regional accrediting organization recognized by the United States department of education. 11 SECTION 2. Permission to enroll - Notification - Credits. Before enrolling in a 12 course for credit under section 1 of this Act, the student must obtain written permission from the 13 student's school district superintendent. The student's school district superintendent shall 14 determine the number of credits for which the student is eligible and shall include the number 15 on the permission document granting permission required by this section. For purposes of 16 determining credit, a three-semester hour course offered by a postsecondary institution is 17 equivalent to a full semester high school course. Upon the student's successful completion of 18 the course, the postsecondary institution shall notify the student's school district superintendent 19 of that fact. 20 SECTION 3. Costs of attendance - Responsibility of student. The student and the 21 student's parent or legal guardian are responsible for all costs of attendance at a 22 postsecondary institution under sections 1 through 6 of this Act. For purposes of this section, 23 "costs" include tuition, fees, textbooks, materials, equipment, and other necessary charges

24 related to the course in which the student has enrolled.

1	SECTION 4. Transportation - Responsibility of student. The student and the
2	student's parent or legal guardian are responsible for transportation arrangements and all costs
3	of transportation associated with a student's attendance at a postsecondary institution under
4	sections 1 through 6 of this Act.
5	SECTION 5. Foundation aid - Extracurricular activities. A student attending a
6	postsecondary institution under sections 1 through 6 of this Act is deemed to be in attendance
7	at the student's school district of residence for purposes of calculating foundation aid and for
8	purposes relating to the student's eligibility to participate in high school extracurricular activities.
9	SECTION 6. Courses - Statutory and regulatory exemption. The courses for which
10	dual high school and postsecondary credit are available under sections 1 through 6 of this Act
11	are postsecondary courses and are exempt from any statutory or regulatory provisions
12	otherwise applicable to high school courses and to the persons by whom high school courses
13	are taught.
14	SECTION 7. AMENDMENT. Subdivision q of subsection 1 of section 28-32-01 of the
15	1995 Supplement to the North Dakota Century Code is amended and reenacted as follows:
16	q. The superintendent of public instruction, except with respect to rules
17	prescribed under section 15-21-07 and, rules implementing chapter 15-22,
18	and rules relating to sections 1 through 6 of this Act.
