## ENGROSSED SENATE BILL NO. 2316

- 1 A BILL for an Act to amend and reenact sections 16.1-08.1-01, 16.1-08.1-02, 16.1-08.1-03,
- 2 16.1-08.1-03.2, subsection 3 of section 16.1-08.1-03.3, sections 16.1-08.1-03.6, and
- 3 16.1-08.1-06 of the North Dakota Century Code, relating to campaign contribution statements.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 16.1-08.1-01 of the North Dakota Century Code 6 is amended and reenacted as follows:
- 7 16.1-08.1-01. Definitions. As used in this chapter, unless the context otherwise plainly
  8 requires:
- 9 1. "Association" means any club, association, union, brotherhood, fraternity, 10 organization, or group of any kind of two or more persons, including labor unions, 11 trade associations, professional associations, or governmental associations, which 12 is united for any purpose, business, or object and which assesses any dues, 13 membership fees, or license fees in any amount, or which maintains a treasury 14 fund in any amount. The term does not include corporations, cooperative 15 corporations, limited liability companies, political committees, or political parties. 16 "Candidate" means an individual who seeks nomination for election or election to 2. 17 public office. 18 "Contribution" means a gift, subscription, loan, advance, or deposit of money, 3. 19 made for the purpose of influencing the nomination for election, or election, of any 20 person to public office or aiding or opposing the circulation or passage of a 21 statewide initiative or referendum petition or measure. Contribution also means a 22 contract, promise, or agreement, express or implied, whether or not legally 23 enforceable, to make a contribution for any of the above purposes, and. 24 Contribution includes funds received by a candidate for public office or a political

1		party or committee which are transferred or signed over to that candidate, party, or
2		committee from another candidate, party, or political committee or other source
3		except as provided in subdivision d. This definition does not include:
4		a. A loan of money from a bank or other lending institution made in the regular
5		course of business.
6		b. Time spent by volunteer campaign or political party workers.
7		c. Money spent by a candidate on the candidate's own behalf.
8		d. Any money received from a district or state committee of a political party, as
9		established pursuant to sections 16.1-03-06 and 16.1-03-08, except for
10		contributions reported pursuant to section 16.1-08.1-03 by a candidate for
11		public office which is immediately transferred or signed over to a district or
12		state committee of a political party within ten days of the candidate receiving
13		the money. A transfer of this kind must be reported by the district or state
14		committee of the political party as a contribution according to section
15		16.1-08.1-03, and show the origin of the contribution.
16	4.	"Cooperative corporations", "corporations", and "limited liability companies" are as
17		defined in this code.
18	5.	"Expenditure" means a purchase, payment, distribution, loan, advance, deposit, or
19		gift of money or property, except a loan of money from a bank or other lending
20		institution made in the regular course of business, made for the purpose of
21		influencing the nomination for election, or election, of any person to office. The
22		term also means a contract, promise, or agreement, express or implied, whether or
23		not legally enforceable, to make any expenditure and includes the transfer of funds
24		by a political committee to another political committee.
25	6.	"Patron" means a person who owns equity interest in the form of stock, shares, or
26		membership or maintains similar financial rights in a cooperative corporation.
27	7.	"Person" means an individual, partnership, committee, association, corporation,
28		cooperative corporation, limited liability company, or other organization or group of
29		persons.
30	8.	"Political committee" means any committee, club, association, or other group of
31		persons which receives contributions or makes expenditures primarily for political

1		purposes and any committee organized in support of a candidate or several		
2		candidates seeking public office.		
3	9.	"Political party" means any association, committee, or organization which		
4		nominates a candidate for election to any office which may be filled by a vote of		
5		the electors of this state or any of its political subdivisions and whose name		
6		appears on the election ballot as the candidate of such association, committee, or		
7		organization.		
8	10.	"Political purpose" means any activity undertaken in support of or in opposition to		
9		the election or nomination of a candidate to public office whether the activity is		
10		undertaken by a candidate, a political committee, a political party, or any person.		
11		The term does not include activities undertaken in the performance of a duty of a		
12		state office.		
13	11.	"Public office" means every statewide or legislative office to which persons can be		
14		elected by vote of the people under the laws of this state.		
15	5 SECTION 2. AMENDMENT. Section 16.1-08.1-02 of the North Dakota Century Code

The candidate <u>or</u>		

1 appeared on the ballot for any office during that calendar year or whether the candidate did not

2 seek election at any election through write-in votes.

3 Statements of a legislative candidate must be filed in the office of the county auditor of
4 the candidate's county of residence. Statements of state office candidates must be filed in the
5 office of the secretary of state.

Even if the candidate <u>or political committee</u> has not received any contributions in excess
of one hundred dollars during the <del>calendar year</del> <u>reporting period</u>, the candidate <u>or political</u>
<u>committee</u> shall file a statement as required by this chapter.

9 SECTION 3. AMENDMENT. Section 16.1-08.1-03 of the North Dakota Century Code
10 is amended and reenacted as follows:

11 **16.1-08.1-03.** Contributions statement required of political parties. Any political 12 party that receives contributions in excess of one hundred dollars in the aggregate during the 13 reporting period shall file a statement containing a detailed list of all contributions received from 14 a person or political committee which exceed one hundred dollars in amount. The statement 15 must include the name and mailing address of all contributors listed, the amount of each 16 reportable contribution, and the date each reportable contribution was received.

A yearend statement covering the entire calendar year must be filed with the secretary of state no later than the thirty-first day of January of the following year. A preelection statement must be filed no later than the twelfth day before any election at which the party has endorsed or will nominate a candidate and must be complete from the beginning of that calendar year through the twentieth day before the election.

Even if the political party has not received any contributions in excess of one hundred dollars during the reporting period, the political party shall file a statement as required by this chapter.

25 SECTION 4. AMENDMENT. Section 16.1-08.1-03.2 of the North Dakota Century
26 Code is amended and reenacted as follows:

16.1-08.1-03.2. Political committee registration. A political committee, other than a political party and a committee organized in support of a legislative candidate, and a person aiding or opposing a measure to be voted upon by the voters of the state shall register its name, address, and its agent's name and address with the secretary of state each calendar year in which it receives any contribution. The registration must be completed within five days

1 of the receipt of any contribution and must be submitted with a registration fee of five dollars. 2 Political committees that organize and register according to federal law shall register within five 3 days of making a contribution to a nonfederal candidate seeking public office and in doing so 4 shall follow the reporting requirements provided in section 16.1-08.1-03.3. 5 SECTION 5. AMENDMENT. Subsection 3 of section 16.1-08.1-03.3 of the North 6 Dakota Century Code is amended and reenacted as follows: 7 3. All political committees formed for the purpose of administering the segregated 8 fund provided for in this section shall file a statement showing the name and 9 mailing address of each contributor of an amount in excess of two hundred dollars 10 in the aggregate for the reporting period and a listing of all expenditures of an 11 amount in excess of one hundred dollars in the aggregate made for political 12 purposes with the secretary of state. The statement must include the amount of 13 each reportable contribution and the date it was received and the amount of each 14 reportable expenditure and the date it was made. A yearend statement covering 15 the entire calendar year must be filed no later than the thirty-first day of the 16 following year. A preelection statement must be filed no later than the twelfth day 17 before any primary, special, or general election and must be complete from the 18 beginning of the calendar year through the twentieth day before the election. 19 Political committees that organize and register according to federal law and the 20 laws of this state must only report contributions received and expenditures made by the committee registered in this state as provided by this section. 21 22 SECTION 6. AMENDMENT. Section 16.1-08.1-03.6 of the North Dakota Century 23 Code is amended and reenacted as follows: 24 16.1-08.1-03.6. Contributions from federal campaign committee accounts or from

contributions made to other candidates or former candidates limited. A candidate or a
 political party may not accept a contribution in an amount exceeding two hundred dollars from
 another candidate's campaign contributions, from contributions made to a person who was a
 candidate within the previous six years, or from a federal campaign committee account unless:

The person who makes a contribution from such funds includes with the
 contribution a statement that the original contributors gave permission to contribute
 money to another candidate <u>or a political party</u>; and

1	2.	The receiving candidate or a political party files a disclosure statement with the	
2		same office as required under section 16.1-08.1-02 for campaign contribution	
3		statements within forty-eight hours after receiving the contribution. The statement	
4		must include a copy of the permission statement required of the donating person	
5		under subsection 1.	
6	<u>A contributi</u>	on requiring permission according to this section does not include any money	
7	received by	a candidate that is immediately transferred or signed over to a district or state	
8	committee	of a political party within ten days of the candidate receiving the contribution.	
9	SEC	CTION 7. AMENDMENT. Section 16.1-08.1-06 of the North Dakota Century Code	
10	is amended	and reenacted as follows:	
11	16.1	-08.1-06. Contributions statement requirements. A statement required by this	
12	chapter to b	be filed with the secretary of state or county auditor must be:	
13	1.	Deemed properly filed when deposited in an established post office within the	
14		prescribed time, postage affixed, and directed to the secretary of state or county	
15		auditor, but if it is not received, a duplicate of the statement must be promptly filed	
16		upon notice by the secretary of state or county auditor of its nonreceipt.	
17	2.	Preserved by the secretary of state or county auditor for a period of four years from	
18		the date of filing. The statement is to be considered a part of the public records of	
19		the secretary of state's or county auditor's office and must be open to public	
20		inspection.	
21	If the filing o	date falls on a Saturday or Sunday or a holiday on which the office of the secretary	
22	of state <del>or c</del>	county auditor is closed, the statement must be filed on the next available day on	
23	which the o	ffice of the secretary of state or county auditor is open. In determining the amount	
24	of individua	I contributions from any contributor, all amounts received from the same contributor	
25	during the r	eporting period must be aggregated to report an overall total contribution for the	
26	purposes of	f the statements required by this chapter. Aggregated contributions must reference	
27	the date of the most recent contribution. Contributions made separately from joint accounts		
28	<u>must be ag</u>	gregated and reported as originating from one source.
