- 2 governor; and to amend and reenact section 54-07-04 and 54-08-03 of the North Dakota
- 3 Century Code, relating to the salaries of the governor and lieutenant governor.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5	SECTION 1. APPROPRIATION. The funds provided in th	is section, or so much of the	
6	funds as may be necessary, are hereby appropriated out of any moneys in the general fund in		
7	the state treasury, not otherwise appropriated, to the office of the governor for the purpose of		
8	defraying the expenses of the governor, for the biennium beginning July 1, 1999, and ending		
9	June 30, 2001, as follows:

19 **SECTION 2. APPROPRIATION - AUTHORIZATION - GOVERNOR'S OFFICE.** The

20 governor's office is hereby authorized to receive and expend any federal or private funds which

- 21 are hereby appropriated which become available during the biennium beginning July 1, 1999,
- 22 and ending June 30, 2001.
- 23 **SECTION 3. AMENDMENT.** Section 54-07-04 of the 1997 Supplement to the North
- 24 Dakota Century Code is amended and reenacted as follows:

1 **54-07-04.** Salary of governor. The annual salary of the governor is seventy three 2 seventy-six thousand one eight hundred seventy-six seventy-nine dollars through June 30, 3 1998 2000, seventy-eight thousand four hundred seventeen dollars through December 31, 4 2000, and seventy-five eighty-three thousand three hundred seventy-two thirteen dollars 5 thereafter. 6 **SECTION 4. AMENDMENT.** Section 54-08-03 of the 1997 Supplement to the North 7 Dakota Century Code is amended and reenacted as follows: 8 **54-08-03. Salary of lieutenant governor.** The annual salary of the lieutenant 9 governor is sixty sixty-three thousand one hundred thirty-two eighty-three dollars through 10 June 30, <del>1998</del> <u>2000</u>, and <del>sixty-one</del> <u>sixty-four</u> thousand <del>nine</del> <u>four</u> hundred <del>forty-four</del> <u>forty-seven</u> 11 dollars thereafter.
