- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the various divisions
- 2 under the supervision of the director of the office of management and budget; to provide an
- 3 appropriation to agencies and institutions of state government; to provide for various transfers
- 4 and financial transactions; to provide an exemption from the provisions of section 54-44.1-11 of
- 5 the North Dakota Century Code; to provide statements of legislative intent relating to state
- 6 employee compensation adjustments, federal program termination, and performance-based
- 7 program budgeting; to authorize the transfer of special funds to the general fund; to provide for
- 8 transfers from the Bank of North Dakota to the state general fund; to provide for a legislative
- 9 council study; to create and enact a new section to chapter 54-23.2 of the North Dakota
- 10 Century Code, relating to mobile data terminal and 911 service fees; to amend and reenact
- 11 subsection 2 section 32-12.2-07, sections 54-16-04.1, 54-16-04.2, and 54-27.2-02 of the North
- 12 Dakota Century Code, relating to the risk management fund, emergency commission
- 13 approvals, and the budget stabilization fund; to provide for retroactive application; and to
- 14 declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
- 17 funds as may be necessary, are hereby appropriated out of any moneys in the general fund in
- 18 the state treasury, not otherwise appropriated, and from special funds derived from federal
- 19 funds and other income, to the various divisions under the supervision of the director of the
- 20 office of management and budget for the purpose of defraying their expenses, for the biennium
- 21 beginning July 1, 1999, and ending June 30, 2001, as follows:

SECTION 2. APPROPRIATION. There is hereby appropriated from federal funds \$6,000,000, or so much of the sum as may be necessary, to the director of the office of management and budget for the division of community services for flood-related disasters and the weatherization of low-income homes, for the period beginning with the effective date of this Act and ending June 30, 1999.

SECTION 3. APPROPRIATION - ADDITIONAL STATE EMPLOYEE

COMPENSATION. The sums hereinafter listed, or so much thereof as may be necessary, are hereby appropriated out of any moneys in the general fund in the state treasury, and from special funds derived from federal funds or other income as indicated to the agencies and institutions of state government named for the purpose of providing additional compensation to employees of the various agencies and institutions for the biennium beginning July 1, 1999,

SECTION 4. LINE ITEM TRANSFERS - EMERGENCY COMMISSION AND BUDGET SECTION APPROVAL. Upon approval of the emergency commission, the director of the office of management and budget may transfer between various line items in subdivisions 1, 2, and 3 of section 1 of this Act appropriation authority of up to ten percent of a given line item to adjust for changing circumstances in meeting established performance measures. Any further transfers must be approved by the budget section.

SECTION 5. CAPITOL BUILDING FUND. The amount of \$225,000, or so much of the sum as is necessary, included in the estimated income line item in subdivision 1 of section 1 of this Act, is to be spent by the facility management division from the capitol building fund during the biennium beginning July 1, 1999, and ending June 30, 2001. The amount of \$25,000, or so much of the sum as is necessary, included in the estimated income line item in subdivision 1 of section 1 of this Act, is to be spent by the administration division from the capitol building fund for capitol grounds planning during the biennium beginning July 1, 1999, and ending June 30, 2001.

SECTION 6. EXEMPTION. The fiscal management appropriation contained in subdivision 1 of section 1 of chapter 15 of the 1997 Session Laws is not subject to the provisions of section 54-44.1-11 for up to an amount of \$500,000 and any unexpended funds from this appropriation are available for continued development and operating costs of the accounting, management, and payroll systems during the biennium beginning July 1, 1999, and ending June 30, 2001.

SECTION 7. SPECIAL COMPENSATION ADJUSTMENTS FOR CLASSIFIED STATE

EMPLOYEES. It is the intent of the fifty-sixth legislative assembly that the statewide compensation plan appropriation included in subdivision 1 of section 1 of this Act be used for market equity compensation adjustments for classified state employees. The special market equity adjustments are to begin with the month of July 1999, to be paid in August 1999. The special market equity adjustments are to be independent of any general salary increase provided by this legislative assembly.

The special market equity increases are to be prioritized based on equity for employees whose salaries are furthest from their respective salary range midpoints effective July 1, 1999. Special market equity increases may not be given to employees whose salary exceeds the midpoints of their assigned salary range effective July 1, 1999.

Probationary employees are eligible for the special market equity increases.

Employees whose documented performance levels do not meet standards are not eligible for the special market equity increases.

The central personnel division shall provide a model base plan to each agency. Agencies may adopt the model plan, adopt the model plan with exceptions, or offer an alternative plan that meets the intent outlined in this section.

1 Upon adoption of an appropriate plan and application to the central personnel division, 2 the division shall transfer appropriated general funds or special fund spending authority for the 3 increases to the agencies. 4 SECTION 8. INTENT - STATE EMPLOYEE COMPENSATION ADJUSTMENTS -5 **GUIDELINES.** It is the intent of the fifty-sixth legislative assembly that 1999-2001 6 compensation adjustments for permanent state employees are to be increases of a minimum of 7 \$35 per month, beginning with the month of July 1999, to be paid in August 1999, and a 8 minimum of \$35 per month, beginning with the month of July 2000, to be paid in August 2000. 9 Any increases greater than \$35 per month may not be given across-the-board and must be 10 based on merit and equity. Agency salary funding is increased by 3.0 percent per year. 11 Probationary employees and employees whose documented performance levels do not 12 meet standards are not eligible for the general or additional increases. 13 During the biennium, no salary increase other than the \$35 per month in July 1999 and 14 \$35 per month in July 2000 may be given to an employee whose salary exceeds or would 15 exceed the salary range maximum. 16 It is the intent of the fifty-sixth legislative assembly that the workers compensation 17 bureau provide pay raises based on merit and performance throughout the 1999-2001 18 biennium. 19 **SECTION 9. INTENT.** Within the authority included in subdivision 1 of section 1 of this 20 Act, are the following grants and special items: 21 Boys and girls clubworks \$53,000 22 State contingencies 600,000 23 State memberships and related expenses 317,000 24 Firemen's association 63,000 25 Unemployment insurance 1,200,000 26 Capitol grounds planning commission 25,000 27 State lobbyist 120,000 28 **SECTION 10. TRANSFER.** During the biennium beginning July 1, 1999, and ending 29 June 30, 2001, the director of the office of management and budget is authorized to transfer 30 special funds to the general fund as follows:

\$3,000,000 1 Lands and minerals trust fund 2 Public employees life insurance program 1,500,000 3 200,000 Financial institutions regulatory fund 4 SECTION 11. FIRE AND TORNADO FUND. The amount of \$63,000, or so much of 5 the amount as is necessary, included in the estimated income line item in subdivision 1 of 6 section 1 of this Act, is from the fire and tornado fund. 7 SECTION 12. BANK OF NORTH DAKOTA TRANSFERS TO STATE GENERAL 8 **FUND.** During the biennium ending June 30, 2001, the industrial commission shall transfer to 9 the state general fund up to \$50,000,000 from the current earnings and the accumulated 10 undivided profits of the Bank of North Dakota. No more than \$15,000,000 of the amount 11 transferred may come from accumulated undivided profits. The moneys must be transferred in 12 the amounts and at such times as requested by the director of the office of management and 13 budget. 14 No transfers may be made that would reduce the Bank's capital structure below \$100,000,000. 15 SECTION 13. CONTINGENT BANK OF NORTH DAKOTA TRANSFERS TO STATE 16 17 GENERAL FUND - BUDGET SECTION APPROVAL. If, during the biennium ending June 30, 18 2001, the director of the office of management and budget determines via revised projections 19 that general fund revenue collections will not meet the revenues as forecast in the March 1999 20 legislative forecast, then the industrial commission shall transfer to the state general fund an 21 additional amount, as determined by the director of the office of management and budget and 22 as approved by the budget section, from the earnings and accumulated and undivided profits of 23 the Bank of North Dakota. Transfers made under the provisions of this section may not be 24 made before July 1, 2000, and may only be made to the extent that the transfer is necessary to 25 achieve a projected June 30, 2001, general fund balance of \$10,000,000. The moneys must 26 be transferred in amounts and at such times as requested by the director of the office of 27 management and budget. The additional amount transferred may not exceed the lesser of 28 \$40,000,000 or the revenue shortfall of actual collections compared to the March 1999 29 legislative forecast.

No transfers may be made that would reduce the Bank's capital structure below

1 SECTION 14. FEDERAL PROGRAM TERMINATIONS - BLOCK GRANT - FUNDING 2 **REDUCTIONS - RELATED PROGRAM REDUCTIONS - REPORTS TO THE BUDGET** 3 **SECTION.** If the federal government during the 1999-2001 biennium terminates funding for 4 any program administered by an agency, department, or institution of the state of North Dakota, 5 the agency, department, or institution, subject to budget section approval, may terminate the 6 program and not replace the reduction in federal funds with state funds, notwithstanding any 7 other provision of law. If the federal government combines funding for separate programs in a 8 block grant resulting in a reduction of total federal funds available for those programs, the 9 administering agency, department, or institution may, subject to budget section approval, 10 prioritize or reprioritize programs as necessary in making programmatic reductions. The 11 agency, department, or institution may administer funds available under a new federal block 12 grant or similar measure, consistent with the terms of that measure, notwithstanding any other 13 provisions of law intended to conform to or implement the provisions of the repealed federal 14 Act, and shall report any program terminations, reductions, or changes resulting from this 15 section to the budget section of the legislative council for its approval. 16 SECTION 15. PROGRAM-BASED PERFORMANCE BUDGETING. The office of 17 management and budget shall discontinue the program-based performance budgeting pilot 18 project when preparing the 2001-03 biennium budget documents and accompanying 19 appropriation bills. Budget documents for the 2001-03 biennium are to be based on the 20 standard line items and are not to contain agency performance measures. SECTION 16. LEGISLATIVE COUNCIL INTERIM STUDY OF PERFORMANCE 21 22 **INCENTIVE PILOT PROGRAMS.** The legislative council shall consider studying the 23 establishment of agency performance incentive pilot programs. If conducted, the study should 24 address how agencies could develop, implement, administer, maintain, and evaluate 25 performance incentive pilot programs. The study should also address the development of 26 personnel policies and procedure manuals and how pay raises which may not be across the 27 board are to be awarded as a reward and incentive for superior performance and the length of 28 time they may be in effect. The legislative council shall report its findings and 29 recommendations, together with any legislation required to implement the recommendations, to 30 the fifty-seventh legislative assembly.

- **SECTION 17. AMENDMENT.** Subsection 2 of section 32-12.2-07 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:
 - 2. The state risk management fund is a special fund in the state treasury administered by the director of the office of management and budget. The fund is a revolving fund consisting of contributions from participating state entities, all payments received by the fund from its activities, and other appropriations by the legislative assembly. The state investment board shall invest the fund in accordance with chapter 21-10. Funds received as contributions from state entities, all other payments deposited in the fund, and interest and income received on investments are hereby appropriated on a continuing basis for the purposes of the fund. Section 54-44.1-11 does not apply to the fund.
- **SECTION 18. AMENDMENT.** Section 54-16-04.1 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:
- 54-16-04.1. May authorize acceptance and disbursement of federal funds. The emergency commission with the advice and counsel of the executive office of the budget may authorize the state treasurer to receive any moneys not appropriated by the legislative assembly which are made available by any federal agency and which the legislative assembly has not indicated an intent to reject. The emergency commission may authorize pass-through federal funds from one state agency to another state agency. The emergency commission, with approval of the budget section of the legislative council if the amount under consideration exceeds fifty thousand dollars, may authorize any state officer to expend federal moneys from the date such moneys become available until June thirtieth following the next regular legislative session. The expenditures must be consistent with state law and with the terms of the grant and the program may not commit the legislative assembly for matching funds in the future unless the program has first been approved by the legislative assembly. A state officer may not expend funds received from the federal government which have not been specifically appropriated by the legislative assembly except as provided in this chapter. A state officer shall submit an expenditure plan with a request for approval under this section of expenditure of federal funds combined with or as part of a block grant for a new or existing program.
- **SECTION 19. AMENDMENT.** Section 54-16-04.2 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

ı	54-16-04.2. Commission may authorize acceptance and expenditure of moneys.
2	The emergency commission, upon the advice of the office of management and budget, with
3	approval of the budget section of the legislative council if the amount under consideration
4	exceeds fifty thousand dollars, may authorize a state officer to receive moneys from gifts,
5	grants, donations, or other sources, not otherwise appropriated by the legislative assembly, for
6	new or existing programs if the legislative assembly has not indicated an intent to reject the
7	moneys or the program. The emergency commission may authorize the state officer to expend
8	money received under this section from the date the money becomes available until June
9	thirtieth following the next regular legislative session.
10	SECTION 20. A new section to chapter 54-23.2 of the North Dakota Century Code is
11	created and enacted as follows:
12	Mobile data terminal and 911 service fees. State radio communications shall
13	establish and charge fees to provide mobile data terminal service to interested local law
14	enforcement agencies. The fees must be based on actual costs incurred by state radio
15	communications for providing the service.
16	State radio communications shall charge at least twenty cents per telephone for 911
17	services provided to political subdivisions. Each county currently receiving 911 services from
18	state radio communications shall abide by the standards established by the governor's
19	emergency services advisory committee.
20	SECTION 21. AMENDMENT. Section 54-27.2-02 of the 1997 Supplement to the North
21	Dakota Century Code is amended and reenacted as follows:
22	54-27.2-02. (Effective through June 30, 1999) Certain general fund revenues to be
23	deposited in the budget stabilization fund. Notwithstanding any other provision of law
24	except section 54-27.2-01, any amount in the state general fund in excess of sixty-five million
25	dollars at the end of any biennium must be transferred by the state treasurer to the budget
26	stabilization fund. For purposes of this section, "at the end of any biennium" means after
27	cancellation of unexpended appropriations under section 54-44.1-11.
28	(Effective July 1, 1999) Gertain general fund revenues to be deposited in the
29	budget stabilization fund. Netwithstanding any other provision of law except section
30	54-27.2-01, any amount in the state general fund in excess of forty million dollars at the end of
31	any biennium must be transferred by the state treasurer to the budget stabilization fund. For

- 1 purposes of this section, "at the end of any biennium" means after cancellation of unexpended
- 2 appropriations under section 54-44.1-11.
- 3 **SECTION 22. RETROACTIVE APPLICATION.** Section 17 of this Act is effective for all
- 4 funds received and deposited into the risk management fund on or after July 1, 1997.
- 5 **SECTION 23. EMERGENCY.** Section 2 of this Act is declared to be an emergency
- 6 measure.
