- 1 A BILL for an Act to establish a reserve fund to assure a source of compensation for the
- 2 consequences of the sale of cigarettes within the state; to provide an effective date; to provide
- 3 a penalty; and to declare an emergency.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1. Definitions.**

- 1. "Adjusted for inflation" means increased in accordance with the formula for inflation adjustment set forth in exhibit C to the master settlement agreement.
- 2. "Affiliate" means a person who directly or indirectly owns or controls, is owned or controlled by, or is under common ownership or control with, another person. Solely for purposes of this definition, the terms "owns", "is owned", and "ownership" mean ownership of an equity interest, or the equivalent thereof, of ten percent or more, and the term "person" means an individual, partnership, committee, association, corporation, or any other organization or group of persons.
- 3. "Allocable share" means allocable share as that term is defined in the master settlement agreement.
- 4. "Cigarette" means any product that contains nicotine, is intended to be burned or heated under ordinary conditions of use, and consists of or contains:
 - Any roll of tobacco wrapped in paper or in any substance not containing tobacco;
 - Tobacco, in any form, that is functional in the product, which, because of its appearance, the type of tobacco used in the filler, or its packaging and labeling, is likely to be offered to, or purchased by, consumers as a cigarette; or

c. Any roll of tobacco wrapped in any substance containing tobacco which, because of its appearance, the type of tobacco used in the filler, or its packaging and labeling, is likely to be offered to, or purchased by, consumers as a cigarette described in subdivision a.

The term "cigarette" includes "roll-your-own", which means any tobacco that, because of its appearance, type, packaging, or labeling is suitable for use and likely to be offered to, or purchased by, consumers as tobacco for making cigarettes. For purposes of this definition of "cigarette", 0.09 ounces [2.556 grams] of "roll-your-own" tobacco constitutes one individual "cigarette".

- "Master settlement agreement" means the settlement agreement and related documents entered on November 23, 1998, by the state and leading United States tobacco product manufacturers.
- 6. "Qualified escrow fund" means an escrow arrangement with a federally or state chartered financial institution having no affiliation with any tobacco product manufacturer and having assets of at least one billion dollars where the arrangement requires that the financial institution hold the escrowed funds' principal for the benefit of releasing parties and prohibits the tobacco product manufacturer placing the funds into escrow from using, accessing, or directing the use of the funds' principal except as consistent with subdivision b of subsection 2 of section 2 of this Act.
- 7. "Released claims" means released claims as that term is defined in the master settlement agreement.
- 8. "Releasing parties" means releasing parties as that term is defined in the master settlement agreement.
- 9. "Tobacco product manufacturer" means an entity that after the effective date of this Act directly, and not exclusively through any affiliate:
 - a. Manufactures cigarettes anywhere that the manufacturer intends to be sold in the United States, including cigarettes intended to be sold in the United States through an importer (except where the importer is an original participating manufacturer, as that term is defined in the master settlement agreement, which will be responsible for the payments under the master

12	10.	"Un	its sold" means the number of individual cigarettes sold in the state by the

1 (5) For each of 2007 and each year thereafter: \$.0188482 per unit sold. 2 b. A tobacco product manufacturer that places funds into escrow pursuant to 3 subdivision a shall receive the interest or other appreciation on the funds as 4 earned. The funds may be released from escrow only under the following 5 circumstances: 6 (1) To pay a judgment or settlement on any released claim brought against 7 the tobacco product manufacturer by the state or any releasing party 8 located or residing in the state. Funds must be released from escrow 9 under this paragraph in the order in which they were placed into escrow 10 and only to the extent and at the time necessary to make payments 11 required under the judgment or settlement; 12 (2) To the extent that a tobacco product manufacturer establishes that the 13 amount it was required to place into escrow in a particular year was 14 greater than the state's allocable share of the total payments that the 15 manufacturer would have been required to make in that year under the 16 master settlement agreement (as determined pursuant to 17 section IX(i)(2) of the master settlement agreement, and before any of 18 the adjustments or offsets described in section IX(i)(3) of that 19 agreement other than the inflation adjustment) had it been a 20 participating manufacturer, the excess must be released from escrow 21 and revert back to the tobacco product manufacturer; or 22 (3)To the extent not released from escrow under paragraph 1 or 2, funds 23 must be released from escrow and revert back to the tobacco product manufacturer twenty-five years after the date on which they were 24 25 placed into escrow. 26 Each tobacco product manufacturer that elects to place funds into escrow C. 27 pursuant to this subsection shall annually certify to the state tax commissioner 28 that it is in compliance with this subsection. The state tax commissioner shall 29 refer every instance of noncompliance to the attorney general. The attorney 30 general may bring a civil action on behalf of the state against any tobacco

product manufacturer that fails to place into escrow the funds required under

1 this section. Any tobacco product manufacturer that fails in any year to place 2 into escrow the funds required under this section must: 3 Be required within fifteen days to place the funds into escrow as will (1) 4 bring it into compliance with this section. The court, upon a finding of a 5 violation of this subdivision, may impose a civil penalty to be paid to the 6 general fund of the state in an amount not to exceed five percent of the 7 amount improperly withheld from escrow per day of the violation and in 8 a total amount not to exceed one hundred percent of the original 9 amount improperly withheld from escrow; 10 In the case of a knowing violation, be required within fifteen days to (2) 11 place the funds into escrow as will bring it into compliance with this 12 section. The court, upon a finding of a knowing violation of this 13 subdivision, may impose a civil penalty to be paid to the general fund of 14 the state in an amount not to exceed fifteen percent of the amount 15 improperly withheld from escrow per day of the violation and in a total 16 amount not to exceed three hundred percent of the original amount 17 improperly withheld from escrow; and 18 (3) In the case of a second knowing violation, be prohibited from selling 19 cigarettes to consumers within the state, whether directly or through a 20 distributor, retailer or similar intermediary, for a period not to exceed 21 two years. 22 Each failure to make an annual deposit required under this section constitutes a separate 23 violation. 24 **SECTION 3. EMERGENCY.** This Act is declared to be an emergency measure.
