## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1. AMENDMENT.** Section 12.1-31-03 of the North Dakota Century Code is amended and reenacted as follows:

## 12.1-31-03. Sale of tobacco to minors and use by minors prohibited.

- It is a class B misdemeanor an infraction for any person to sell or furnish to a
  minor, or procure for a minor, cigarettes, cigarette papers, cigars, snuff, or tobacco
  in any other form in which it may be utilized for smoking or chewing. As used in
  this subsection, "sell" includes dispensing from a vending machine under the
  control of the actor.
- 2. It is a class B misdemeanor an infraction for a minor to purchase, possess, smoke, or use cigarettes, cigars, cigarette papers, snuff, or tobacco in any other form in which it may be utilized for smoking or chewing. However, an individual under eighteen years of age may purchase and possess tobacco as part of a compliance survey program when acting with the permission of the individual's parent or guardian and while acting under the supervision of any law enforcement authority. A state agency, city, county, board of health, tobacco retailer, or association of tobacco retailers may also conduct compliance surveys, after coordination with the appropriate local law enforcement authority.
  - 3. A city or county may adopt an ordinance or resolution that deems a violation of subsection 2 a noncriminal violation with a fee of twenty-five dollars.

- 1 Any individual who has been cited for a violation that is designated a a. 2 noncriminal offense may appear before a court of competent jurisdiction and 3 pay the statutory fee by the time scheduled for a hearing, or if bond has been 4 posted, may forfeit the bond by not appearing at the scheduled time. An 5 individual appearing at the time scheduled in the citation may make a 6 statement in explanation of that individual's action and the judge may waive, 7 reduce, or suspend the statutory fee or bond, or both. If the individual cited 8 follows the procedures of this subdivision, that individual has admitted the 9 violation and has waived the right to a hearing on the issue of commission of 10 the violation. The bond required to secure appearance before the court must 11 be identical to the statutory fee. This subdivision does not allow a halting 12 officer to receive the statutory fee or bond. 13 If an individual cited for a violation that is designated a noncriminal offense <u>b.</u> 14 does not choose to follow any procedure provided under subdivision a, that 15 individual may request a hearing on the issue of the commission of the 16 violation charged. The hearing must be held at the time scheduled in the 17 citation or at some future time, not to exceed ninety days later, set at that first 18 appearance. At the time of a request for a hearing on the issue on 19 commission of the violation, the individual charged shall deposit with the court 20 an appearance bond equal to the statutory fee for the violation charged. The 21 state must prove the commission of a charged violation at the hearing under 22 this section by a preponderance of the evidence. 23 A law enforcement officer who cites a minor for violation of this section shall mail a
  - 4. A law enforcement officer who cites a minor for violation of this section shall mail a notice of the violation to the parent or legal guardian of the minor within ten days of the citation.
  - **SECTION 2. EMERGENCY.** This Act is declared to be an emergency measure.
