FIRST ENGROSSMENT with House Amendments

ENGROSSED SENATE CONCURRENT RESOLUTION NO. 4036

1	A concurrent resolution directing the Legislative Council to study the operation of the temporary
2	assistance for needy families program in North Dakota as it relates to the relationship between
3	the state and the federally recognized Indian tribes in the state.
4	WHEREAS, the Personal Responsibility and Work Opportunity Reconciliation Act of
5	1996 provides the state of North Dakota with an annual temporary assistance for needy
6	families block grant to assist needy families so that children may be cared for in their own
7	homes or in the homes of relatives; and
8	WHEREAS, the temporary assistance for needy families block grant allows states some
9	flexibility in the design of the program; and
10	WHEREAS, the temporary assistance for needy families block grant requires recipients
11	of assistance to meet certain work requirements and limits the number of months an adult may
12	receive such assistance; and
13	WHEREAS, an increasing percent of the recipients of assistance under the temporary
14	assistance for needy families block grant in North Dakota are members of a federally
15	recognized Indian tribe; and
16	WHEREAS, a large portion of these individuals resides on Indian reservations within
17	the state; and
18	WHEREAS, the Indian reservations are located in the rural areas of the state and are
19	economically depressed with an unemployment rate approaching sixty percent according to the
20	Bureau of Indian Affairs; and
21	WHEREAS, while federal law requires states to disregard the months of assistance
22	received by an adult while living on an Indian reservation with at least fifty percent
23	unemployment, a conflict has arisen as to the method to be used to determine unemployment
24	rate statistics; and

1	WHEREAS, the effective coordination and cooperation between the state, tribes, and
2	local governments are critical to the success of welfare, job and workforce training, and
3	economic development programs;
4	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF NORTH DAKOTA,
5	THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:
6	That the Legislative Council study the operation of the temporary assistance for needy
7	families program in North Dakota as it relates to the relationship between the state and the
8	federally recognized Indian tribes in the state; and
9	BE IT FURTHER RESOLVED, that the Legislative Council, in conducting its study,
10	evaluate the impact of the temporary assistance for needy families program on the federally
11	recognized Indian tribes within the state; and
12	BE IT FURTHER RESOLVED, that the Legislative Council, in conducting its study,
13	evaluate the use of the Bureau of Indian Affairs unemployment rate statistics to determine if
14	adults within an Indian reservation are exempt from the state's lifetime limit under the temporary
15	assistance for needy families program and evaluate and consider other methods of determining
16	the unemployment rate specifically as it applies to those areas; and
17	BE IT FURTHER RESOLVED, that the Legislative Council review the process through
18	which the Department of Human Services receives input from local governments and the
19	federally recognized Indian tribes within the state; and
20	BE IT FURTHER RESOLVED, that the Legislative Council study how state-sponsored
21	economic development, job training, and workforce training programs can be coordinated
22	between the state and federally recognized Indian tribes within the state; and
23	BE IT FURTHER RESOLVED, that the Legislative Council consider the impact of tribal
24	sovereignty on economic development and the implementation of the temporary assistance for
25	needy families program in areas under the jurisdiction of federally recognized Indian tribes
26	within the state; and
27	BE IT FURTHER RESOLVED, that the Legislative Council, in conducting its study,
28	request input from members of the federally recognized Indian tribes within the state and from
29	officials of the government of those tribes, especially tribal officials involved with human
30	services and economic development programs; and
