The House convened at 8:30 a.m., with Speaker Wald presiding.

The prayer was offered by Reverend George Walker, Chaplain for the Bismarck Law Enforcement Center, Bismarck.

The roll was called and all members were present.

A quorum was declared by the Speaker.

CORRECTION AND REVISION OF THE JOURNAL

MR. SPEAKER: Your **Committee on Correction and Revision of the Journal (Rep. DeKrey, Chairman)** has carefully reexamined the Journal of the Twenty-eighth Day and reexamined the Journal of the Twenty-ninth Day and recommends that they be corrected as follows and when so corrected, recommends that they be approved:

REQUEST

REP. DEKREY REQUESTED that the House divide the amendments to HB 1024.

ANNOUNCEMENT

SPEAKER WALD ANNOUNCED that in accordance with House Rule 603, page 129, that whenever the report of any committee, except a conference committee, contains several amendments, any member may have the amendments divided into separate divisions. The question of adoption must be taken separately on each amendment. All approved divisions comprise the report that is to be adopted, therefore Representative DeKrey's request was granted.

DIVISION A

Page 1, line 3, replace the second "and" with ", subsections 4 and 7 of section 28-32-02,"

Page 1, line 4, after "28-32-03.3" insert ", and section 28-32-04"

Page 1, line 5, replace "and" with ", administrative rulemaking procedures,"

Page 1, line 6, after "rules" insert ", and petitions for reconsideration of administrative rules" and remove "to repeal section 28-32-04 of the North Dakota Century Code, relating to"

Page 1, line 7, remove "petitions for reconsideration of administrative rulemaking;"

Page 1, line 13, remove the overstrike over "~~28-32-04~~" and remove "28-32-03.3"

Page 1, after line 15, insert:

"SECTION 2. AMENDMENT. Subsections 4 and 7 of section 28-32-02 of the 1997 Supplement to the North Dakota Century Code are amended and reenacted as follows:

4. The agency's notice of the proposed adoption, amendment, or repeal of a rule must include a short, specific explanation of the proposed rule and the purpose of the proposed rule, a determination of whether the proposed rulemaking is expected to have an impact on the regulated community in excess of fifty thousand dollars, identify at least one location where interested persons may review the text of the proposed rule, provide the address to which written data, views, or arguments concerning the proposed rule may be sent, provide a phone number at which a copy of the rules and regulatory analysis may be requested, and, in the case of a substantive rule, provide the time and place set for each oral hearing. The notice must be filed with the office of the legislative council and published at least twice in each daily newspaper of general circulation published in this state. The agency shall mail a copy of the notice to each person who has made a timely request to the agency for a mailed copy of the notice. The agency may mail or otherwise provide a copy of the notice to any person who is likely to be an interested person. The agency shall mail or deliver a copy of the rules to any person requesting a copy. The agency may charge for the actual cost of providing copies of the proposed rule. At least ~~thirty~~ fourteen days must elapse between the later of the date of the second publication of the notice or the date the legislative council mails copies of an agency's notice and the date of the hearing. ~~The thirty day period begins on the first business day of the month in which the notices must be mailed or on the date of the second publication, whichever is later. At least fourteen days before the hearing, the agency shall provide the attorney general a copy of the notice and the proposed rules.~~ Subject to subsection 5, notices filed on or before the last calendar day of the preceding month must be mailed by the legislative council on the first business day of the following month to any person making a request. The agency shall allow, after the conclusion of any rulemaking hearing, a comment period of not less than ~~thirty~~ fourteen days during which data, views, or arguments concerning the proposed rulemaking will be received by the agency and made a part of the rulemaking record to be considered by the agency.
7. Every rule ~~proposed~~ submitted to the attorney general by any administrative agency must be ~~submitted to reviewed by the attorney general~~ for an opinion as to its legality before final adoption, ~~and the~~. The attorney general shall promptly furnish each such the agency a preliminary opinion, based upon the rules as submitted, by the close of the comment period for those rules. After the close of the comment period, the agency shall advise the attorney general of each change to the proposed rules made in contemplation of final adoption and the attorney general shall promptly furnish an opinion as to legality of the rules contemplated for final adoption. The attorney general may not approve any rule as to legality when the rule exceeds the statutory authority of the agency or is written in a manner that is not concise or easily understandable, or when the procedural requirements for adoption of the rule in this chapter are not substantially met. The attorney general shall advise an agency of any revision or rewording of a rule necessary to correct objections as to legality."

Page 3, line 14, replace "The" with "Upon request of any person substantially interested in the effect of a rule who has previously petitioned the adopting agency for review of the rule under section 28-32-04 or upon request of the adopting agency, the"

Page 3, replace lines 21 and 22 with:

"SECTION 6. AMENDMENT. Section 28-32-04 of the North Dakota Century Code is amended and reenacted as follows:

28-32-04. Petition for reconsideration review of rule - Hearing by agency. Any person substantially interested in the effect of a rule adopted by an administrative agency may petition such agency for ~~a reconsideration~~ review of the effect and consideration of any such the rule or for an consideration of amendment or repeal thereof of the rule. ~~Such~~ The petition must state clearly and concisely the petitioners' alleged grounds for ~~such reconsideration the review,~~ or for the proposed repeal or amendment of ~~such the~~ rule. The agency ~~in its discretion~~ shall grant the petitioner a public hearing if the petitioner has not previously petitioned the agency under this section and otherwise may grant the petitioner a public hearing, upon such terms and conditions as the agency may prescribe."

Page 3, line 23, after the second period insert "Section 2 of this Act is effective for administrative rulemaking proceedings for which the notice of rulemaking is published after July 31, 1999.", replace "2" with "3", and replace "4" with "5"

Page 3, line 25, replace "3" with "4"

The question being on the adoption of Division A of the proposed amendments to HB 1024, which motion prevailed on a verification vote.

DIVISION B

Page 2, line 2, after the period insert "The membership of the administrative rules committee must include an equal number of members from each of the two political parties having the most members in the legislative assembly."

Page 3, line 20, after the underscored period insert "Notice of the time and place the rule will be reviewed must be published at least twice in each daily newspaper of general circulation published in this state."

The question being on the adoption of Division B of the proposed amendments to HB 1024, which motion failed on a verification vote.

REP. GULLESON MOVED that the remarks of the Honorable Byron L. Dorgan, U.S. Senator be printed in the Journal, which motion prevailed.

REMARKS OF HONORABLE BYRON L. DORGAN, UNITED STATES SENATOR

Mr. Speaker and members of the State House it's a pleasure for me to be here, in fact it's a pleasure to be anywhere. As you know if you have watched the U.S. Senate at the start of the sessions for the last five weeks the admonition by the sergeant-at-arms with a 160-year old admonition was "Hear Ye, Hear Ye, all Senators present know under the pain of imprisonment they shall remain silent during the conduct of the Senate's business." So I have remained silent for five weeks and your invitation was fortuitous because I have so much to say, but I won't say it all.

As all of us know this is the last year of this century and we look forward to the first year of the new century and those of us working in the U.S. Congress and those of you working in the state legislature know that there are two enduring truths that have been present for a quarter of a century as we have done the people's business. One is a cold war with the Soviet Union and the second is a crippling federal budget deficit, both are gone. There is no cold war, it's over and the federal budget deficit is gone. We have a surplus. That changes most of everything. Our economy is the strongest in the world and we have what every textbook in the field of economics would aspire to for every economy. The two twin economic goals of any economy is to have stable prices and full employment and this country has both.

The question that is what do we do, what is our new agenda, given all of this good news, and it is good news. This country is healthy and growing and its economy is the envy of the world. In every indices is positive, homeownership, up, up, way up, record highs. Crime down. Employment up. Inflation down. All of the indices represent good news. So what then is this partnership in the legislative process requiring us to do, you and the state legislature and those of us in the U.S. Congress. Well, there's a lot to do. We are spending more in block grants, sending money to the states with fewer restrictions and more flexibility for its spending, and I think that makes good sense.

We also have a common agenda--better schools. All of us want better schools for our children. We understand that better schools come from school boards and the funding for those schools comes largely from the state legislature. Well, we also understand that things like school construction, repair and maintenance of school buildings can be helped by federal legislation. At the end of the second world war when the American GIs came home we had the largest baby crop ever produced in our country. Those GIs went to school on the GI bill, got jobs, and began to build schools. And we built schools all over this country for those children. Many of those schools now are very old and they are showing wear and need repair and the money is not so easily available for school construction to rebuild and repair. We are going to pass a bill, I'm convinced, this year in the Congress and I think with bipartisan support that says we will offset most of the cost of interest on bonds issued for the purpose of investing and rebuilding schools that are in need of repair and we should do that. I know that your portion of that is required as well and I'm sure that you'll meet that objective, but we cannot shortchange our children and we must it seems. We need to continue to invest in those facilities so that when children walk through school doors they'll walk through the doors of a good school, a school we can be proud of.

Within driving distance from here, in about an hour, you can go to the Cannonball School I visited down there one day. That building desperately needs to be repaired. It's an old building, fairly well condemned. One of the areas, where they have chorus and band, they have to abandon it fairly frequently because sewer gas comes up and fills that room and a little third-grade girl said, "Mr. Senator, are you going to build us a new school?"--one hundred fifty students, two bathrooms, and one water faucet. The answer is no, I can't build a new school, but together we can put together the approach that will invest in these schools for those children and we should do that.

Second is good health care. We're going to pass, I think this year with bipartisan support, a patient's bill of rights so that in health care every patient in this country can be told and will be told by their HMO what all of their options for treatment are, not just the cheapest option for treatment. We're going to pass that in the Congress, I'm convinced this year, and we'll do that I

think with bipartisan support. One other piece, and I know it's controversial, and I know you are working on it, is the children's health insurance program. I do want to mention it because we passed in Congress some while ago some resources in order to start understanding we can't provide health insurance to everybody who doesn't have health insurance, some 40 million Americans, but start with children who are the most vulnerable, the uninsured, some 15,000 of whom live in North Dakota. And I hope you'll take full advantage of that 80 percent funding that is available under that children's health insurance program. Take full advantage of that in order to invest in these young children's lives here in North Dakota.

We will also work on Social Security and Medicare this year in Congress and I don't ring my hands about that because the problems in both of them are borne of success, people are living longer and better lives. We wouldn't have problems in Social Security and Medicare if we went back to the old life expectancy, but of course we wouldn't want to do that, people are living longer, better lives and you're now expected in this country of ours to live to be on average about 78 years of age. A century ago you were expected to live to be 48 years of age. So success, better lives, longer lives give us these challenges in Social Security and Medicare, but we can solve that and we will.

Finally, the budget surpluses that are predicted now for the many years in the future give us an opportunity to review what we should do with those budget surpluses and I happen to think the first priority for budget surpluses ought to be to begin to pay down some of the federal debt. During good economic times this country needs to make an investment by paying down the debt. What greater gift to give to American children than to leave them with a lesser debt load. We will also, I suppose, debate tax cuts and I happen to like the suggestion that we provide tax cuts for USA savings accounts, incentivised to tax cuts for individual savings for a person's retirement. Again, what better investment in this country's future?

I want to especially tell you that the work you have done to fund water projects, which I'm sure is not a pleasant job, I think is awfully good work. You are required to meet the obligations that are necessary for flood control in Grand Forks, you're required to meet the obligations in other parts of the state, you're required to deal with this question of Devils Lake. None of us invited these challenges, but they are there and you know that the federal money is only available if there is a state and local match and the reason for that is the federal government doesn't want to invest in projects the state and local governments don't support. And because of that, you were burdened with this responsibility. I have not paid detailed attention to what you've done, but my understanding is that you have moved legislation now that will make money available for these important projects and give I think some peace of mind to people who wonder about flood control and wonder about the flooding crisis in Devils Lake and Grand Forks and elsewhere. I think you give them the peace of mind that they need and deserve and I congratulate you for that.

One last point, we live in a rural state and most rural areas in America are losing population. And a central fact that threads its way through every decision you make about schools, about roads, about health care is the fact that this state is shrinking. Oh, it's not shrinking a lot, but we're not gaining population, we're losing population and if you go to some counties it's shrinking a lot. Roughly 43 counties are shrinking like prunes. My home county, 5,000 citizens when I left, 3,000 citizens now. And what do we do about all of that?

You might have read the story last week about Margaret Hanson. I did and I called Margaret Hanson. She was the 90-year old woman from Forman, North Dakota, who got up to go to the hairdresser, got in her car on a foggy morning and drove into a snowbank, got out of her car and began to walk. She walked a mile apparently, or perhaps a mile and a half, and then her legs gave out at age 90 in freezing temperatures and so she began to crawl on the gravel road. She couldn't crawl any longer, and about eight or nine hours later a man named David picked her up in his pickup truck. I read that in the paper and it said she was in the Oakes Hospital, so I picked up the phone and called the Oakes Hospital, and a nurse answered and I said "Is Margaret Hanson able to speak?" "Oh, sure." "Is there any chance I could visit with her?" "Oh, of course." And so she put Margaret on the phone. I said, "Margaret, I just read about you in the paper. How are you doing?" "Oh, I'm fine. My legs aren't so good," she said, "but I'm fine." And I thought to myself, you know that's kind of the spirit all of us understand about the folks here in our state, in our hometowns. I mean who would say "I'm fine" after having gone through that, but Margaret did. Now is that kind of spirit, is that rural lifestyle that breeds that kind of determination useful and valuable and important to this country? I sure think it is. And the fact is, we have a department in Washington called the Housing and Urban Development Department, and I was thinking about that. I thought, gosh you know, we've urban developed now for a good many years, we've got lots of money in urban development and I'm all for helping blighted cities, but what about rural development? What about taking that part of the country that's shrinking and saying you make a difference, you matter, and we want to help you as well. Is there nothing we can do? I think there are some things we can do. I think we can put together a program in Congress and I'm going to suggest one that talks

about a rural development program. How about housing and rural development? How about just rural development? Forty percent of our economic base is agriculture, so we have to start there, and I know this will be controversial, but I hope that you'd consider passing a piece of legislation saying that when prices collapse for farmers there needs to be a better price support program, a better safety net. Some of you won't like that, but I hope you'll consider doing it because I don't think when prices collapse family farmers can make it across the valley without some sort of basic safety net that is workable. Aside from that, and the reason I say that, I hope you might do that as you know we've got probably a dozen or more farm organizations in North Dakota and every one of them go to the Congress and they've got a different story. They say we're here supporting family farmers and they all have different stories, they're all supporting different things. There's no unifying voice and I hope you'll weigh in on this issue.

I hope you'll also do it on a subject of antitrust and mergers and monopolies and deregulation and restructuring. Every time we've been deregulated by and large, we've lost. Every time you talk about restructuring, interesting, we're going to have a big debate on restructuring in the U.S. Congress. We're a relatively low-cost state with respect to power. The whole purpose of restructuring is some of the biggest users in the country want access to cheap power. Well, if they find cheap power where cheap power exists and move it there, what comes here? I mean I've been restructured and deregulated about enough. And I've seen about enough monopolies in every direction you turn. You've got a Public Service Commission that sits up on top of this building that says a \$100 million is overcharged North Dakotans for shipping things on the railroad. A \$100 million a year. We can do something about that. We should in Congress and I hope you will. Let's give regulators some teeth where monopolies exist. Where we can, let's break up monopolies. Let's give the free market system a decent chance to work the way it ought to work and that is with price as a regulator for competition. I know some of you probably don't like those subjects, but they're subjects that will determine whose left and whether this economy grows and whether rural America has much of a future.

Now, if I might just in one final point say that we have a lot of work to do and we must do it together or it won't get done. I was given an award by the National Council of State Legislatures a week and a half ago and Representative Dorso was there and when I accepted the NCSL award, they gave me one of their legislators of the year award, I guess they gave it to three, four, or five legislators, and when I accepted I said I was really pleased and I was especially pleased Representative Dorso was there, because if he hadn't witnessed it he wouldn't believe it. But I care a great deal about the agenda of the state legislatures. I began my public service in this building, in a state capital, and I care a great deal about what you do and how you do it and the opportunities you have to make life better in this state. And I think the only way that we can succeed, all of us, is if we do things together. Now, we might have a different approach on how you get to the end point, but I don't think there ought to be any disagreement about what the end point is for our state. So, my hope is that we can be bold and we can be aggressive as we confront these many challenges.

Thomas Jefferson said when they were discussing the construction of the constitution and the U.S. Congress and so on, he was living in Europe at the time serving this country abroad, so he wasn't in the constitutional convention, but he wrote most of the Bill of Rights and then he was talking with his friends about how do you pay legislators. If you're going to set up a Congress, a U.S. House, and a U.S. Senate, how do you pay them? And Thomas Jefferson, a couple hundred years ago suggested that they be paid in wheat. And I was thinking about that the other day, you know I'll bet if we paid members of Congress in wheat, we'd have 100 percent parity. I'm not suggesting we change the method of remuneration, but if you look at the origin of who we are and where we came from and the principles of self-government that Thomas Jefferson, Madison, Mason, Hamilton, and many others had some enduring truths, some transcendental truths that have never changed and part of those truths are in evidence every day that you meet here and every day that you cast votes in the state legislature. And I hope that you can say the same thing about the votes that I and my colleagues cast in the U.S. Congress. Let me say thank you for inviting me to say a few words today to you and let me wish you well as you work towards, I guess crossover, and then towards completing your work for North Dakota and our country. Thank you very much.

HCR 3029: A concurrent resolution urging Congress to aggressively pursue legislation that will permit substantially similar crop protection products registered in Canada to be purchased and used by farmers in the United States; to direct the administrator of the Environmental Protection Agency to work toward the harmonization of crop protection product legislation, and in the event substantial progress is not made, to disallow the importation of any commodity into this country if the commodity contains any crop protection product not approved for use in this country; and to require that the manufacturers of crop protection products publicly justify any price discrepancies between similar products sold in Canada and in the United States.

HCR 3030: A concurrent resolution urging Congress to ensure the availability of as many crop protection products as possible, to use actual scientific data to determine the safety of crop protection products, to accept scientific data generated by the North Dakota State University Main Research Center and by the research extension centers regarding the safety of crop protection products, to establish uniform policies governing the implementation of the 1996 Food Quality Protection Act, and to ensure that implementation of the 1996 Food Quality Protection Act does not negatively impact agricultural production nor the availability and affordability of food.

HCR 3031: A concurrent resolution urging Congress to encourage the formation of new legislative or administrative initiatives to extend insurance options, similar to crop insurance options, to livestock producers.

HCR 3033: A concurrent resolution urging Congress to raise the cap on marketing loans available to farmers and to adopt a cost of production index adjustment mechanism.

HCR 3035: A concurrent resolution urging the Environmental Protection Agency and the Congress of the United States to increase resources for and efforts of the U.S.-Canada Technical Working Group to harmonize pesticide regulations between the two countries, to commit more resources and efforts toward establishing tolerances for pesticides registered for use in Canada but not in the United States, and to accept registration data currently accepted by Canadian officials in support of Canadian pesticide registrations.

HCR 3037: A concurrent resolution urging Congress to review the North American Free Trade Agreement and the General Agreement on Tariffs and Trade and amend those portions of the agreements that treat North Dakota agricultural producers inequitably or repeal the agreements in their entirety.

HCR 3045: A concurrent resolution directing the Legislative Council to study grain credit-sale contracts to determine the need to provide protection for farmers against grain warehouse and grain buyer insolvency.

HCR 3049: A concurrent resolution directing the Legislative Council to study taxation and regulatory incentives for the lignite industry in order to improve its competitive position in the energy marketplace and to identify federal and international impediments to development of the lignite industry and potential state actions to address such impediments.

HCR 3051: A concurrent resolution directing the Legislative Council to study the role and mission of the Milk Marketing Board.

HCR 3053: A concurrent resolution directing the Legislative Council to study the feasibility and impact of mental health and substance abuse parity in the state of North Dakota.

The highway patrol shall charge a fee of ten dollars per day for each person, excluding highway patrol personnel, attending law enforcement programs at the law enforcement training academy. The highway patrol shall charge a lodging fee of ten dollars per night for each person, excluding highway patrol personnel, staying overnight at the law enforcement training academy. Revenues from these fees must be deposited in the highway patrol operating fund."

SECTION 10. AMENDMENT. Section 4-05.1-02 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-05.1-02. Agricultural experiment station. The state board of agricultural research and education and the president of North Dakota state university shall control and administer the North Dakota agricultural experiment station subject to the supervision of the state board of higher education. Funds appropriated to the agricultural experiment station may not be commingled with funds appropriated to North Dakota state university. Appropriation requests to defray expenses of the agricultural experiment station must be separate from appropriation requests to defray expenses of North Dakota state university.

SECTION 11. AMENDMENT. Section 4-05.1-04 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-05.1-04. Reports. Each center director shall submit an annual report to the station director as directed by the state board of agricultural research and education. Each report must set forth in detail the investigations and experiments made during the preceding year, recommendations for the welfare of the center, the financial condition of the center, how all moneys have been expended, and the results of experiments. The station director shall submit these reports, with a report of the North Dakota state university main research center, to the state board of agricultural research and education and the state board of higher education on or before the first day of September of each year. If the state board of higher education submits a biennial report to the governor and the secretary of state in accordance with section 54-06-04, the report must include a composite of the reports from the main research center and each research extension center.

SECTION 12. AMENDMENT. Section 4-05.1-16 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-05.1-16. State board of agricultural research and education - Membership - Terms.

1. The state board of agricultural research and education consists of:
 - a. The president of North Dakota state university;
 - b. The vice president of agricultural affairs at North Dakota state university;
 - c. The administrator of the agricultural experiment station;
 - d. The five persons appointed to the agricultural consultation board by the ag coalition and serving in that capacity on July 1, 1997;

- e. The five persons appointed to the agricultural consultation board by the extension service's multicounty program units and serving in that capacity on July 1, 1997;
 - f. The two persons appointed to the agricultural consultation board by the president of North Dakota state university as representatives of the state's research extension centers and serving in that capacity on July 1, 1997;
 - g. The commissioner of agriculture, who serves in an ex officio nonvoting capacity; and
 - h. The director of the North Dakota state university extension service; ~~who serves in an ex officio capacity.~~
2. a. The initial five members appointed by the ag coalition shall select their terms by lot so that one member serves for one year, one member serves for two years, one member serves for three years, one member serves for four years, and one member serves for five years.
- b. The initial five members appointed by the extension service's multicounty program units shall select their terms by lot so that one member serves for one year, one member serves for two years, one member serves for three years, one member serves for four years, and one member serves for five years.
- c. The two persons appointed as representatives of the state's research extension centers shall serve only through June 30, 1998.
3. At the completion of each initial term, the term of office for each member is five years, beginning on July first. No person may be appointed to a second five-year term.
4. a. At least ninety days before the conclusion of the initial term of each member appointed by the ag coalition, the ag coalition shall provide to the state board of higher education a list of two or more names from which the state board of higher education shall appoint a successor. Future appointments to these five positions must be made in the same manner. The state board of higher education shall ensure that four out of the five seats are held by agricultural producers.
- b. At least ninety days before the conclusion of the initial term of each member appointed by the extension service's multicounty program units, the units through their advisory groups shall provide to the state board of higher education a list of two or more names from which the state board of higher education shall appoint a successor. Future appointments to these five positions must be made in the same manner. The state board of higher education shall ensure that four out of the five seats are held by agricultural producers.

SECTION 13. AMENDMENT. Section 4-05.1-17 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-05.1-17. Compensation of board members - Expenses. Each appointed member of the state board of agricultural research and education is entitled to receive sixty-two dollars and fifty cents per day as compensation for the time actually spent devoted to the duties of office and is entitled to receive necessary expenses in the same manner and amounts as state officials for attending meetings and performing other functions of office.

SECTION 14. AMENDMENT. Section 4-05.1-18 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-05.1-18. State board of agricultural research and education - Chairman - Meetings. The state board of agricultural research and education annually shall elect one of its members to serve as chairman. The board shall meet at the times and locations designated by the chairman in consultation with the vice president of agricultural affairs at North Dakota state university.

SECTION 15. AMENDMENT. Section 4-05.1-19 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-05.1-19. State board of agricultural research and education - Duties. Within the policies of the state board of higher education, the state board of agricultural research and education is responsible for the budgeting, supervision, and policymaking responsibilities associated with the supervision of the agricultural experiment station and the North Dakota state university extension services. The agricultural research and education board shall:

1. Determine the causes of any adverse economic impacts on crops and livestock produced in this state;
2. Develop ongoing strategies for the provision of research solutions to negate adverse economic impacts on crops and livestock produced in this state;
3. Make available financial resources, including grants and salaries, and make available equipment and facilities to implement the strategies developed under subsection 2, subject to approval by the state board of higher education;
4. Develop an annual budget for the operation of the agricultural experiment station and the North Dakota state university extension service;
5. Develop a biennial budget request and submit that request to the state board of higher education on or before March first of each even-numbered year;
6. Maximize the use of existing financial resources, equipment, and facilities to generate the greatest economic benefit from research and extension efforts and to promote efficiency;
7. Annually evaluate the results of research and extension activities and expenditures and report the findings to the legislative council and the state board of higher education;
8. Advise the administration of North Dakota state university regarding the recruitment and selection of the vice president of agricultural affairs, the extension service director, and the station director; and
9. ~~Advise the director of the extension service regarding~~ Develop ongoing strategies for the dissemination of research information and the best practices for management of the extension service.

SECTION 16. AMENDMENT. Section 4-05.1-21 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-05.1-21. State board of agricultural research and education - Apportionment of research funds.

1. The state board of agricultural research and education annually shall apportion the proceeds of the agricultural research fund as follows:
 - a. Seventy percent to research activities affecting North Dakota agricultural commodities that account for at least two percent of the gross sales of all agricultural commodities grown or produced in the state. The percentage of the dollars available for each agricultural commodity under this section may not exceed the percentage that the gross sales of the agricultural commodity bear to the North Dakota gross sales of all agricultural commodities grown or produced during the previous year, as determined by the agricultural statistics service;
 - b. Eighteen percent to research activities affecting North Dakota animal agriculture; and
 - c. Twelve percent to research activities affecting new and emerging crops in North Dakota.

2. The state board of agricultural research and education shall solicit proposals for research from the public and private sectors and shall appoint committees to review the proposals and award the agricultural research grants on a competitive basis. Each committee must consist of a majority of agricultural producers selected in consultation with the agricultural commodity groups representing commodities that are the subjects of the proposed research and may include researchers and other individuals knowledgeable about the proposed area of research. Whenever possible, the committees shall require that a grant recipient commit matching funds.
3. The state board of agricultural research and education shall develop policies regarding the award of research grants, including requirements for matching funds, cooperation with other in-state and out-of-state researchers, and coordination with other in-state and out-of-state proposed or ongoing research projects.

SECTION 17. AMENDMENT. Section 4-08-10 of the 1997 Supplement to the North Dakota Century Code is amended and reenacted as follows:

4-08-10. Extension agent to submit monthly account of expenditures. The extension agent shall submit monthly an accurate itemized account of all expenditures incurred by the agent in the regular conduct of duties to the North Dakota state university extension service for examination and audit. When charges are made by an extension agent for money expended in the performance of official duties, all items of one dollar or more expended and charged for must be covered by a subvoucher or receipt that must be signed by the person to whom the money was paid. The subvoucher or receipt must show at what place, on what date, and for what the money expended was paid. The extension agent shall forward the subvouchers or receipts with the bill, claim, account, or demand against the county. When charges are made for transportation expenses, they may not exceed the amounts provided by section 11-10-15, and must be in itemized form showing the mileage traveled, the days when and how traveled, and the purpose thereof, verified by affidavit. The account must be transmitted and recommended for payment by the North Dakota state university extension service which shall audit the same and which may approve or disallow any expense item therein. The state board of agricultural research and education and the president of North Dakota state university shall control and administer the North Dakota state university extension service ~~is under the control, and~~ subject to the supervision, of the state board of higher education. Funds appropriated to the North Dakota state university extension service may not be commingled with funds appropriated to North Dakota state university. An appropriation request to defray expenses of the North Dakota state university extension service must be separate from an appropriation request to defray expenses of North Dakota state university."

4. On or before February 1, 1999, the treasurer of each county shall determine and certify to the state treasurer and to all affected political subdivisions of the county:
 - a. The total amount of tax apportioned and distributed to the state, the county, and each political subdivision of the county under sections 57-35-13 and 57-35.1-06 in the years 1994 through 1998; and
 - b. The amount determined under subdivision a for each distributee as a percentage of the amount determined under subdivision a for all distributees.
5. On or before the tenth working day of March in 1999 and each subsequent year, the treasurer of each county shall determine and distribute to each distributee described in subsection 4 an amount equal to:
