Clayton A. Lodoen, who served in the 45th through the 51st Legislative Assemblies, from District 13, died May 8, 1998;

Frank A. Wenstrom, who served in the 35th and 36th Legislative Assemblies, from District 45, and in the 40th through the 49th Legislative Assemblies, from District 1, died May 12, 1997; and

WHEREAS, these legislators rendered outstanding service to the people of the state by their contributions to public service;

MEMORIAL ADDRESS BY FORMER SENATOR EVAN E. LIPS

Madam President, members of the Senate, and families of our former colleagues. When I was a member of this body for thirty-eight years, I served with six out of the seven that we are honoring here today. I enjoyed my service here, but if I said I didn't miss it, I probably wouldn't be truthful. The only one that I didn't serve with was Ralph Dewing.

I don't think the general public realizes what you people go through in a legislative session. Changes have taken place over the years and this legislative body is rated one of the best in the nation. I know firsthand what you people go through in order to arrive here. First you are nominated by your party--then you have to work your district, raise some money, and campaign all over, and merit the votes of the citizens.

Today, it is a great pleasure for me to say a few words about each of the former Senators.

Ralph Dewing served in the Senate from the northwest part of the state. He was a nonpartisan leader and he, along with Carrol Day who was a Democrat from Grand Forks, controlled the Senate with 25 votes on every major issue. The other faction of the party, the ROC, couldn't get anything passed. Ralph was known for his knowledge on fiscal matters, which of course was one of the important issues handled during the session. He was then appointed Director of Accounts and Purchases. This had been passed by the 1959 session and not activated. Governor Guy gave the job to Ralph Dewing. His last work was with the Impact Office and I guess you know how important that office was. Helen, you and your family can be certainly proud of Ralph's service here in the Senate and in the other departments in which he served.

Clayton Lodoen was an expert on city matters and business matters. He was the Mayor of West Fargo for a long time and a businessman in that city. His knowledge of these subjects was important in the business that comes before this body. Mrs. Lodoen, you and your family can certainly be proud of his service and we thank you for sharing him with us.

Emil Kautzmann came to us from Mandan with a background in banking, and we had plenty of banking bills before this body over the years. He had expertise in the banking business and the Senate looked to him for his recommendations. Mrs. Kautzmann, Emil served here with distinction.

Jim Berg only served here one session. We all knew he was ill in the 1997 session, but he served with distinction and expertise in the Higher Education and Extension Division. He was a Professor Emeritus from North Dakota State University. Mrs. Berg, our sympathy to you and your family.

Lloyd Erickson came to the Senate from the southwest part of the state. He was a great champion on agricultural and educational matters. He was a quiet person, but when he did speak on the floor everyone listened. Mrs. Erickson, you and your family can be proud of his work. He was well respected by everybody in the Senate.

John Garaas came to us from Watford City. He was a lawyer and I think that most of us think lawyers are trained to pick things apart one at a time. He left to become a United States attorney and then a district judge. His advice was appreciated by the Senate. He was a great

speaker, but everyone knows that lawyers make their money speaking. Mrs. Garaas, you and your family can be proud of his work in the Senate.

Frank Wenstrom--just what can I say about Frank? He was a kind and gentle person, honest and sincere, and dedicated to the people of North Dakota. He was my seatmate for some time. I think all of the members of the Senate considered him Mr. North Dakota. His advice and counsel was sought by many of the Senators. He was a parliamentarian who could keep us on the right track if we got off on a wild tangent. He was in the Senate for a couple of terms and then was Lieutenant Governor for the 1963 session. Then he came back again to serve in the Senate. Esther, we all appreciated Frank very much. His work was dedicated to the people of his district and North Dakota. I know I join all of the Senators to say thanks for his untiring effort as a member of this body.

I think it is important that everyone here today try and encourage young people to get involved in the political process. We need young talent to come forward and assume the responsibility of running for political office. People can complain about our government, but it is the best in the world and nobody has any better to offer. All of you started as young people and you are contributing everyday to the North Dakota government. Let's continue to elect good people to the North Dakota Senate.

So again today let me say thanks for the seven we honor and their work in the Senate. Their families can stand proud knowing that they did an outstanding job while here. Thanks again to the families for sharing them with us.

Thanks to the present members of this body for your continued work to serve the people of North Dakota. Thank you very much.
