1 A BILL for an Act to create and enact a new chapter to title 54 of the North Dakota Century
2 Code, relating to creation of a department of commerce; to amend and reenact sections
3 4-14.1-03, 4-14.1-04, and 6-12-02, subsection 6 of section 10-30-04, subsection 4 of section
4 10-30.5-02, section 10-30.5-05, subsection 6 of section 10-30.6-04, subsection 3 of section
5 20.1-02-17.1, sections 20.1-02-18.1, 21-11-02, 21-11-03, 21-11-04, 21-11-05, 21-11-06, and
6 24-03-21, subsection 4 of section 26.1-50-01, sections 26.1-50-02, 28-32-01, 40-57.1-04, and
7 49-10.1-17, subsection 4 of section 50-06-01.8, section 52-01-03, subsection 5 of section
8 52-02.1-01, section 54-01.1-08, subsection 1 of section 54-06-04, section 54-21.2-03,
9 subsection 1 of section 54-21.3-03, sections 54-21.3-04.1, 54-34-12, 54-34-15, 54-34.3-01,
10 54-34.3-02, 54-34.3-03, 54-34.3-04, 54-34.3-05, 54-34.3-06, 54-34.3-08, 54-34.3-10,
11 54-34.3-11, 54-34.4-01, 54-34.4-02, and 54-34.4-04, subsection 15 of section 54-44.3-20,
12 sections 54-44.5-01, 54-44.5-02, 54-44.5-03, 54-44.5-05, 54-53-02, 55-01-01, and 55-06-01,
13 subsection 1 of section 57-38.5-01, section 57-38.5-08, and subsection 6 of section 57-39.2-28
14 of the North Dakota Century Code, relating to merging the division of community services,
15 department of economic development and finance, department of labor, and tourism
16 department into a department of commerce; to repeal section 54-34.3-09 of the North Dakota
17 Century Code, relating to the department of economic development and finance; to provide an
18 appropriation; and to provide an effective date.

19 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

20 **SECTION 1. AMENDMENT.** Section 4-14.1-03 of the 1999 Supplement to the North
21 Dakota Century Code is amended and reenacted as follows:

22 **4-14.1-03. Agricultural products utilization commission - Composition -**
23 **Appointment.** The agricultural fuel tax fund must be administered by the agricultural products
24 utilization commission. The commission consists of nine members, five of whom must be

1 appointed by the governor for terms of two years each, arranged so that two terms expire in
2 odd-numbered years and three terms expire in even-numbered years. Three members
3 appointed by the governor must be actively engaged in farming in this state and two members
4 appointed by the governor must be actively engaged in business in this state. The
5 commissioner of agriculture shall appoint one member for a term of two years which expires in
6 odd-numbered years. The member appointed by the commissioner must be actively engaged
7 in farming in this state. Commission members may be reappointed to the commission. Terms
8 of commissioners shall run from the first day of July. The director of the department of
9 commerce division of economic development and finance, the president of North Dakota state
10 university, and the commissioner of agriculture, or their designees, are members of the
11 commission. The commission shall elect one of its members as chairman.

12 **SECTION 2. AMENDMENT.** Section 4-14.1-04 of the 1999 Supplement to the North
13 Dakota Century Code is amended and reenacted as follows:

14 **4-14.1-04. Agricultural products utilization commission - Meetings - Personnel -**
15 **Reports.** The agricultural products utilization commission, which is ~~a division~~ an office of the
16 department of commerce division of economic development and finance, shall meet as
17 necessary and shall report to each session of the legislative assembly. The commission may
18 secure office space, employ needed personnel for the performance of its duties, hire
19 consultants, spend any funds appropriated to the commission, and contract with public entities
20 or private parties for services.

21 **SECTION 3. AMENDMENT.** Section 6-12-02 of the 1999 Supplement to the North
22 Dakota Century Code is amended and reenacted as follows:

23 **6-12-02. (Effective for first four taxable years beginning after December 31, 1998)**
24 **Establishment - Organization.** Any financial institution or group of financial institutions may
25 establish a corporation or a limited liability company to own and operate the housing
26 development fund. Except as provided in this chapter, all authority regarding the articles of
27 incorporation or articles of organization is the province of the governing board, which must
28 include a representative of the Bank of North Dakota and a representative of the department of
29 commerce division of economic development and finance. The fund administrator shall
30 maintain the fund as an account at the Bank of North Dakota. The governing board is
31 responsible for adopting policies and procedures governing activities in connection with the

1 fund. The governing board may not distribute more than seventy-five percent of the net profit of
2 the fund in any of the first five years of operation.

3 **SECTION 4. AMENDMENT.** Subsection 6 of section 10-30-04 of the North Dakota
4 Century Code is amended and reenacted as follows:

5 6. Cooperate with and avail itself of the facilities of the department of commerce
6 division of economic development and finance and any other similar governmental
7 agencies; to cooperate with and assist, and otherwise encourage, local
8 organizations in the various communities of the state the purpose of which are the
9 promotion, assistance, and development of the business prosperity and economic
10 welfare of such communities and of this state.

11 **SECTION 5. AMENDMENT.** Subsection 4 of section 10-30.5-02 of the North Dakota
12 Century Code is amended and reenacted as follows:

13 4. The ~~director~~ commissioner of the department of ~~economic development and~~
14 ~~finance~~ commerce shall adopt rules, subject to the approval of the board of
15 directors, necessary to implement the administration of the fund. The rules to
16 implement the grant program must be developed to encourage local fundraising
17 initiatives for developing locations for businesses financed by the corporation.

18 **SECTION 6. AMENDMENT.** Section 10-30.5-05 of the North Dakota Century Code is
19 amended and reenacted as follows:

20 **10-30.5-05. Management.** The ~~deputy~~ director of the finance ~~division~~ office of the
21 department of commerce division of economic development and finance must be the chief
22 executive officer of the corporation. The board of directors shall determine minimum
23 qualifications of all other staff positions.

24 All investments, contracts, partnerships, limited liability companies, and business
25 transactions of the corporation are the responsibility of the deputy director and the board of
26 directors. The board may provide that normal operating costs anticipated in an approved
27 budget may be incurred and paid without prior board approval.

28 **SECTION 7. AMENDMENT.** Subsection 6 of section 10-30.6-04 of the 1999
29 Supplement to the North Dakota Century Code is amended and reenacted as follows:

30 6. Cooperate with and avail itself of the facilities of the department of ~~economic~~
31 ~~development and finance~~ commerce and any other similar governmental agencies;

1 and cooperate with, assist, and otherwise encourage local organizations in the
2 various communities of the state, the purpose of which are the promotion,
3 assistance, and development of the business prosperity and economic welfare of
4 the communities and of this state.

5 **SECTION 8. AMENDMENT.** Subsection 3 of section 20.1-02-17.1 of the 1999
6 Supplement to the North Dakota Century Code is amended and reenacted as follows:

7 3. A detailed impact analysis from the state game and fish department shall be
8 included with the acquisition proposal for board of county commissioner
9 consideration in making recommendations. The analysis by the game and fish
10 department shall include, but shall not be limited to, the recreational and wildlife
11 impacts. In addition, the county agent of the affected county or counties shall
12 prepare an impact analysis for board of county commissioner consideration which
13 shall include the fiscal, social, and agricultural impacts of the proposed acquisition.
14 The state game and fish department shall reimburse the county or counties for any
15 expenses incurred by the county agent in preparing the analysis. The analyses
16 shall also be forwarded to the department of commerce division of community
17 services which shall furnish copies to all interested state agencies and political
18 subdivisions, which agencies and political subdivisions shall have thirty days to
19 review the analyses and return their comments to the division of community
20 services. Upon expiration of the thirty-day period, all comments received by the
21 division of community services shall be forwarded to the state game and fish
22 department. The state game and fish department may, after consideration of such
23 comments, file a final impact analysis with the division of community services and
24 the board of county commissioners.

25 **SECTION 9. AMENDMENT.** Section 20.1-02-18.1 of the 1999 Supplement to the
26 North Dakota Century Code is amended and reenacted as follows:

27 **20.1-02-18.1. Federal wildlife area acquisitions - Submission to county**
28 **commissioners, opportunity for public comment, and impact analysis required.** The
29 governor, the director, or their designees, responsible under federal law for final approval of
30 land, wetland, and water acquisitions by the United States department of the interior, its
31 bureaus or agencies, for waterfowl production areas, wildlife refuges, or other wildlife or

1 waterfowl purposes, shall submit the proposed acquisitions by certified mail with return receipt
2 to the board of county commissioners of the county or counties in which the land, wetland, and
3 water areas are located for the board's recommendations.

4 The board of county commissioners of the county affected, or a designee or designees
5 of the board, shall, within twenty-one days of receipt of an acquisition proposal, physically
6 inspect the proposed acquisition areas. The board shall give public notice of the date, hour,
7 and place where the public may comment on the proposed acquisitions. The notice must be
8 published once each week for two successive weeks in the official newspaper of the county or
9 counties in which the land and water areas are located. The notice must set forth the
10 substance of the proposed action, and must include a legal description of the proposed
11 acquisitions. The board of county commissioners shall make its recommendations by certified
12 mail with return receipt within sixty days after receipt of an acquisition proposal.

13 A detailed impact analysis from the federal agency involved must be included with the
14 acquisition proposal for board of county commissioner consideration in making
15 recommendations. The analysis must include the recreational and wildlife impacts. In addition,
16 the county agent of the affected county or counties shall prepare an impact analysis for board of
17 county commissioner consideration which must include the fiscal, social, and agricultural
18 impacts of the proposed acquisitions. The department of the interior shall reimburse the county
19 or counties for any expenses incurred by the county agent in preparing the analysis. The
20 analyses must also be forwarded to the department of commerce division of community
21 services, which shall furnish copies to all interested state agencies and political subdivisions,
22 which agencies and political subdivisions have thirty days to review the analyses and return
23 their comments to the division of community services. Upon expiration of the thirty-day period,
24 all comments received by the division of community services must be forwarded to the federal
25 agency involved and to the state official or agency responsible for final acquisition approval.
26 The federal agency may, after consideration of the comments, file a final impact analysis with
27 the governor, the board of county commissioners, and any other state official or agency
28 responsible for final acquisition approval.

29 **SECTION 10. AMENDMENT.** Section 21-11-02 of the 1999 Supplement to the North
30 Dakota Century Code is amended and reenacted as follows:

- 1 **21-11-02. Application for loan - Form - Contents - Preference of applications.** Any
2 privately or cooperatively owned enterprise for the purpose of securing a loan from this state for
3 purposes of planning, constructing, acquiring, equipping, improving, or extending facilities for
4 the conversion of North Dakota's natural resources into low cost power and the generation and
5 transmission of such power, and the acquisition of real and personal property and water and
6 mineral rights needed for such facilities, or any of such purposes, may file an application with
7 the department of commerce division of economic development and finance. The application
8 must be in the form required by the ~~department~~ division and must be accompanied by a
9 complete and fully detailed outline and description of the applicant's plan of operation. In the
10 consideration of applications the ~~department~~ division shall consider the following factors:
- 11 1. Preference must be given to applicants with the following qualifications:
 - 12 a. Applicants who are experienced in the generation or transmission of power,
13 and who at the time of application have access to alternate markets for the
14 sale of such power.
 - 15 b. Applicants who are residents of North Dakota, or private or cooperative
16 enterprises incorporated under the laws of North Dakota and having their
17 headquarters in the state, whether or not a nonresident person, corporation,
18 or limited liability company owns part or all of the stock of the applicant or
19 limited liability companies organized under the laws of North Dakota and
20 having their headquarters in the state, whether or not a nonresident person,
21 limited liability company, or corporation owns part or all of the membership
22 interests of the applicant, or is engaged in a partnership or joint enterprise
23 with the applicant.
 - 24 2. The provisions of subsection 1 do not prohibit the ~~department~~ division from
25 approving loans to applicants not possessing the qualifications therein described, if
26 in the judgment of the ~~department~~ division such approval would better carry out the
27 objectives of this chapter as stated in section 21-11-01.
 - 28 3. Each application shall include information for the purpose of showing to the
29 ~~department~~ division and may be approved only if the ~~department~~ division
30 determines:

- 1 a. That the facilities proposed to be financed by the loan will result in significant
2 additional industrial or other economic activity in North Dakota which would
3 not occur in the absence of a state loan.
- 4 b. That the cost of power furnished by the facilities financed by the loan will be
5 significantly lower than it would be without a loan made under this chapter.
- 6 c. That the facilities financed will furnish power at the lowest possible cost to
7 stimulate industrial development, benefit the general public, and expand the
8 use of North Dakota fuel resources.
- 9 4. In considering applications the ~~department~~ division may establish additional
10 reasonable criteria with respect to the financial qualification of individuals and
11 organizations requesting loans.

12 **SECTION 11. AMENDMENT.** Section 21-11-03 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **21-11-03. Processing of application - Fee - Purpose.** The department of commerce
15 division of economic development and finance shall process each application and if it
16 determines the applicant is eligible for the loan and has complied with all requirements, it shall
17 request an application fee of not more than fifty thousand dollars. The fee must be deposited in
18 a special and separate fund in the state treasury and must be expended by the ~~department~~
19 division of economic development and finance for purposes of investigating the applicant and
20 evaluating the technical and economic feasibility of the plans and specifications as submitted by
21 the applicant. The ~~department~~ division may consult or contract with any person or private,
22 state, or federal department, agency, or entity, for purposes of that investigation or evaluation.
23 All departments, agencies, institutions, and officials of this state and its political subdivisions
24 shall provide to the ~~department~~ division of economic development and finance such aid,
25 information, and assistance as it may request in regard to any matter relative to the applicant or
26 such applicant's plans and specifications. The ~~department~~ division of economic development
27 and finance may conduct any private or public hearing it may deem necessary in the course of
28 that investigation or evaluation. Any unexpended portion of the funds received as an
29 application fee must be refunded to the applicant after the payment of all costs of investigation
30 and evaluation of the application. There is hereby appropriated from each application fee these

1 funds as may be necessary to pay all costs of investigation and evaluation and pay refunds as
2 provided in this section.

3 **SECTION 12. AMENDMENT.** Section 21-11-04 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **21-11-04. Approval or rejection of application.** Upon completion of all investigations
6 and evaluations of any matter relative to the applicant or the submitted application and plan, the
7 department of commerce division of economic development and finance shall either reject the
8 application as submitted, approve the application as submitted, or offer to approve the
9 application if modified in accordance with any recommendation made by the commission as a
10 result of any such investigation or evaluation. If the applicant fails or refuses to agree to those
11 modifications, the application must be rejected.

12 **SECTION 13. AMENDMENT.** Section 21-11-05 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **21-11-05. Approved application filed with industrial commission.** Upon approval of
15 the application, as submitted or modified, the department of commerce division of economic
16 development and finance shall file the application, along with its report and recommendations,
17 received by it as a result of any investigation and evaluation, with the ~~state~~ industrial
18 commission. The department of ~~economic development and finance~~ commerce shall prepare
19 and submit any necessary legislation for the appropriation of additional funds or the
20 authorization of the issuance of bonds at the following session of the legislative assembly, or at
21 a special session if called in accordance with the constitution.

22 **SECTION 14. AMENDMENT.** Section 21-11-06 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **21-11-06. Disbursements of loan - Inspection fee.** If the industrial commission finds
25 that the approved loan application has been filed and processed as required by this chapter and
26 the proposed loan agreement is in proper legal form and the amount to be disbursed
27 thereunder, with other previous disbursements, does not exceed the funds appropriated for that
28 purpose, it shall authorize the execution of the loan agreement with the applicant by the director
29 of the department of commerce division of economic development and finance on behalf of the
30 state. Prior to the disbursement of any funds pursuant to the loan agreement, the applicant
31 shall deliver to the director of the division of economic development and finance a supervision

1 fee in such amount as may be specified in the loan agreement, which fee must be deposited in
2 a special fund in the state treasury. The fee must be expended by the ~~department~~ division of
3 economic development and finance for the purpose of periodic inspection of the construction of
4 such power generation or transmission facilities, and disbursements to the borrower under the
5 loan agreement may be made only upon certification by the director or a person appointed by
6 the director ~~that~~ which the construction is being carried on in accordance with the loan
7 agreement and that the loan funds are due the borrower under the agreement. Upon the
8 completion of the construction of the facilities, any unexpended balance of the inspection fee
9 must be refunded to the borrower. There is hereby appropriated from each inspection fee those
10 funds as may be necessary to provide for the inspections and refunds as provided in this
11 section.

12 **SECTION 15. AMENDMENT.** Section 24-03-21 of the 1999 Supplement to the North
13 Dakota Century Code is amended and reenacted as follows:

14 **24-03-21. Preparation of road maps - Publication of tourist information.** The
15 commissioner shall prepare for general distribution; road maps of the state highway system and
16 other roads as the commissioner determines necessary. Any tourist-oriented material printed
17 on road maps must be prepared by the department of commerce division of tourism ~~department~~
18 at no cost to the department of transportation.

19 **SECTION 16. AMENDMENT.** Subsection 4 of section 26.1-50-01 of the 1999
20 Supplement to the North Dakota Century Code is amended and reenacted as follows:

21 4. "Primary sector business" means an individual, corporation, limited liability
22 company, partnership, or association that through the employment of knowledge or
23 labor adds value to a product, process, or service which results in the creation of
24 new wealth. Qualification as a primary sector business under this subsection must
25 be determined by the department of commerce division of economic development
26 and finance.

27 **SECTION 17. AMENDMENT.** Section 26.1-50-02 of the 1999 Supplement to the North
28 Dakota Century Code is amended and reenacted as follows:

29 **26.1-50-02. Establishment - Organization.** Any insurer or group of insurers may
30 establish a corporation or limited liability company to own and operate the North Dakota low-risk
31 incentive fund. Except as provided in this chapter, all authority regarding the articles of

1 incorporation or articles of organization is the province of the governing board, which must
2 include a representative of the Bank of North Dakota and the director of the department of
3 commerce division of economic development and finance. The Bank of North Dakota shall
4 administer the fund; however, the governing board is responsible for adopting fund policies and
5 procedures. The governing board may not distribute more than seventy-five percent of the net
6 profit of the fund in any of the first five years of operation.

7 **SECTION 18. AMENDMENT.** Section 28-32-01 of the 1999 Supplement to the North
8 Dakota Century Code is amended and reenacted as follows:

9 **28-32-01. (Effective through December 31, 2002) Definitions.** In this chapter, unless
10 the context or subject matter otherwise provides:

- 11 1. "Adjudicative proceeding" means an administrative matter resulting in an agency
12 issuing an order after an opportunity for hearing is provided or required. An
13 adjudicative proceeding includes administrative matters involving a hearing on a
14 complaint against a specific-named respondent; a hearing on an application
15 seeking a right, privilege, or an authorization from an agency, such as a
16 ratemaking or licensing hearing; or a hearing on an appeal to an agency. An
17 adjudicative proceeding includes reconsideration, rehearing, or reopening. Once
18 an adjudicative proceeding has begun, the adjudicative proceeding includes any
19 informal disposition of the administrative matter under section 28-32-05.1 or
20 another specific statute or rule, unless the matter has been specifically converted
21 to another type or proceeding under section 28-32-05.1. An adjudicative
22 proceeding does not include a decision or order to file or not to file a complaint, or
23 to initiate an investigation, an adjudicative proceeding, or any other proceeding
24 before the agency, or another agency, or a court. An adjudicative proceeding does
25 not include a decision or order to issue, reconsider, or reopen an order that
26 precedes an opportunity for hearing or that under another section of this code is
27 not subject to review in an adjudicative proceeding. An adjudicative proceeding
28 does not include rulemaking under this chapter.
- 29 2. "Administrative agency" or "agency" means each board, bureau, commission,
30 department, or other administrative unit of the executive branch of state
31 government, including one or more officers, or employees, or other persons directly

- 1 or indirectly purporting to act on behalf or under authority of the agency. An
2 administrative unit located within or subordinate to an administrative agency shall
3 be treated as part of that agency to the extent it purports to exercise authority
4 subject to this chapter. The term administrative agency does not include:
- 5 a. The office of management and budget except with respect to rules made
6 under section 32-12.2-14, rules relating to conduct on the capitol grounds and
7 in buildings located on the capitol grounds under section 54-21-18, ~~rules~~
8 ~~relating to the state building code as authorized or required under section~~
9 ~~54-21.3-03~~, rules relating to the Model Energy Code as required under section
10 ~~54-21.2-03~~, rules relating to the central personnel system as authorized under
11 section 54-44.3-07, rules relating to state purchasing practices as required
12 under section 54-44.4-04, rules relating to records management as authorized
13 or required under chapter 54-46, and rules relating to the central microfilm unit
14 as authorized under chapter 54-46.1.
 - 15 b. The adjutant general with respect to the division of emergency management.
 - 16 c. The council on the arts.
 - 17 d. The state auditor.
 - 18 e. The department of commerce with respect to the division of economic
19 development and finance.
 - 20 f. The dairy promotion commission.
 - 21 g. The education factfinding commission.
 - 22 h. The educational telecommunications council.
 - 23 i. The board of equalization.
 - 24 j. The board of higher education.
 - 25 k. The Indian affairs commission.
 - 26 l. The industrial commission with respect to the activities of the Bank of North
27 Dakota, the North Dakota housing finance agency, the North Dakota
28 municipal bond bank, the North Dakota mill and elevator association, and the
29 North Dakota farm finance agency.
 - 30 m. The department of corrections and rehabilitation except with respect to the
31 activities of the division of adult services under chapter 54-23.4.

- 15 3. "Agency head" means an individual or body of individuals in whom the ultimate
16 legal authority of the agency is vested by law.
- 17 4. "Complainant" means any person who files a complaint before an administrative
18 agency pursuant to section 28-32-05; and any administrative agency which, when
19 authorized by law, files such a complaint before such agency or any other agency.
- 20 5. "Hearing officer" means any agency head or one or more members of the agency
21 head when presiding in an administrative proceeding, or, unless prohibited by law,
22 one or more other persons designated by the agency head to preside in an
23 administrative proceeding, an administrative law judge from the office of
24 administrative hearings, or any other person duly assigned, appointed, or
25 designated to preside in an administrative proceeding pursuant to statute or rule.
- 26 6. "License" means a franchise, permit, certification, approval, registration, charter, or
27 similar form of authorization required by law.
- 28 7. "Order" means any agency action of particular applicability that determines the
29 legal rights, duties, privileges, immunities, or other legal interests of one or more
30 specific persons, but does not mean an executive order issued by the governor.

- 1 8. "Party" means each person named or admitted as a party or properly seeking and
2 entitled as of right to be admitted as a party. An administrative agency may be a
3 party. In a hearing for the suspension, revocation, or disqualification of an
4 operator's license under title 39, the term may include each city and each county in
5 which the alleged conduct occurred, but the city or county may not appeal the
6 decision of the hearing officer.
- 7 9. "Person" includes an individual, association, partnership, corporation, limited
8 liability company, state governmental agency or governmental subdivision, or an
9 agency of such governmental subdivision.
- 10 10. "Relevant evidence" means evidence having any tendency to make the existence
11 of any fact that is of consequence to the determination of the administrative action
12 more probable or less probable than it would be without the evidence.
- 13 11. "Rule" means the whole or a part of an agency statement of general applicability
14 that implements or prescribes law or policy, or the organization, procedure, or
15 practice requirements of the agency. The term includes the adoption of new rules
16 and the amendment, repeal, or suspension of an existing rule. The term does not
17 include:
- 18 a. A rule concerning only the internal management of an agency which does not
19 directly or substantially affect the substantive or procedural rights or duties of
20 any segment of the public.
- 21 b. A rule that sets forth criteria or guidelines to be used by the staff of an agency
22 in the performance of audits, investigations, inspections, and settling

8 the treasury, and information obtained in connection with the administration of the employment
9 service may be made available to persons or agencies for purposes appropriate to the
10 operation of a public employment service. Upon a request, the bureau shall furnish to any
11 agency of the United States charged with the administration of public works or assistance
12 through public employment, and may furnish to any state agency similarly charged, the name,
13 address, ordinary occupation, and employment status of each recipient of benefits and the

5 an alternative to a structural change in existing buildings or facilities is permitted only after it has
6 been documented, in accordance with regulations adopted under Public Law 101-336, that a
7 particular structural change is not readily achievable. A state agency or the governing body of a
8 political subdivision shall require from any person preparing plans and specifications for a
9 building or facility subject to the Americans with Disabilities Act of 1990 [Pub. L. 101-336; 104
10 Stat. 327], a statement that the plans and specifications are, in the professional judgment of
11 that person, in conformance with the Americans with Disabilities Act Accessibility Guidelines for
12 Buildings and Facilities found in the appendix to 28 CFR 36, subject to the exception stated in
13 this section. A statement of conformance must be submitted to the department of commerce
14 division of community services for recording.

7 government a comprehensive program of economic development consistent with

- 9 4. Coordinate that program of economic development with all other appropriate state
10 and local government departments, agencies, institutions, and organizations that
11 perform research, develop and administer programs, gather statistics, or perform
12 other functions relating to economic development, and those government entities
13 shall advise, cooperate, and provide reasonable assistance to the director in
14 carrying out ~~sections 54-34.3-01 through 54-34.3-08~~ this chapter;
- 15 5. Advise, and cooperate with, departments and agencies of the federal government
16 and of other states, private business and agricultural organizations and
17 associations, research institutions, and any individual or other private or public
18 entity, and call upon those entities or individuals for consultation and assistance in
19 their respective fields of endeavor or interest in order that the ~~department~~ division
20 and the state may benefit from up-to-date technical advice, information, and
21 assistance;
- 22 6. Cooperate with individuals and both public and private entities, including the state's
23 congressional delegation, in identifying and pursuing potential sources of funding
24 and to receive those funds to be expended for purposes consistent with ~~sections~~
25 ~~54-34.3-01 through 54-34.3-08~~ this chapter;
- 26 7. Have authority to enter into contracts upon terms and conditions as determined by
27 the director to be reasonable and to effectuate the purposes of ~~sections 54-34.3-01~~
28 ~~through 54-34.3-08~~ this chapter;
- 29 8. Report at least annually to an interim committee designated by the legislative
30 council on performance of all divisions of the ~~department~~ division of economic
31 development and finance. The report must include the amount of success and

1 satisfaction the ~~department~~ division of economic development and finance has in
2 meeting business-client, economic-developer, and community-client needs and
3 expectations. The report must also include a comparison of dollars spent to the
4 economic benefits created of all programs administered or supervised by the
5 director; and

6 9. Have authority to do any and all other things necessary and proper to carry out
7 ~~sections 54-34.3-01 through 54-34.3-08~~ this chapter.

8 **SECTION 35. AMENDMENT.** Section 54-34.3-05 of the 1999 Supplement to the North
9 Dakota Century Code is amended and reenacted as follows:

10 **54-34.3-05. Division office of finance - Deputy director.** The director shall appoint a
11 deputy director who shall administer the ~~division~~ office of finance. The deputy director shall
12 serve at the will of the director and receive a salary set by the director within the limits of
13 legislative appropriations. The purpose of the ~~division of finance~~ office is to identify and
14 coordinate sources of capital and financial assistance, including lending programs of the Bank
15 of North Dakota, and administer programs of financial assistance placed under the
16 administration of the ~~division~~ office, to business and industry, local governments, and other
17 entities and individuals in the state consistent with the mission of the ~~department~~ office. The
18 ~~division~~ office of finance shall:

- 19 1. Administer other programs of financial assistance assigned to it by law or
20 otherwise.
21 2. Perform such other duties as assigned to it by the director.

22 **SECTION 36. AMENDMENT.** Section 54-34.3-06 of the 1999 Supplement to the North
23 Dakota Century Code is amended and reenacted as follows:

24 **54-34.3-06. ~~Divisions~~ Division offices.** The director shall organize and establish
25 other ~~divisions~~ offices as necessary to carry out most efficiently and effectively the mission and
26 duties of the ~~department~~ division, except that the ~~department~~ division must contain:

- 27 1. ~~An office of~~ A North Dakota American Indian business development office to assist
28 North Dakota tribal and individual economic development representatives and
29 North Dakota American Indian entrepreneurs with access to state and federal
30 programs designed to assist them.

1 2. ~~An office of~~ A North Dakota women's business development office to develop and
2 administer the North Dakota women's business program, to establish and fund the
3 women's business leadership council, certify women-owned businesses for federal
4 or state contracting and to recruit, train, and assist women entrepreneurs to
5 develop and diversify their businesses. The office must have an administrator and
6 staff sufficient to implement ~~its~~ the office's programs.

7 **SECTION 37. AMENDMENT.** Section 54-34.3-08 of the 1999 Supplement to the North
8 Dakota Century Code is amended and reenacted as follows:

9 **54-34.3-08. Patents.** The ~~department~~ division of economic development and finance,
10 the North Dakota development fund, incorporated, and the North Dakota agricultural products
11 utilization commission may hold or assign for remuneration all or a portion of their interest in
12 patents or royalty rights acquired in the course of their operation and performance of duties as
13 provided by law.

14 **SECTION 38. AMENDMENT.** Section 54-34.3-10 of the 1999 Supplement to the North
15 Dakota Century Code is amended and reenacted as follows:

16 **54-34.3-10. Commission on the status of women - Appointment - Expenses -**
17 **Duties.** There is established a commission on the status of women. ~~The~~ This commission
18 consists of five members. The governor shall appoint each member for a term of four years,
19 staggered so that the term of at least one member expires July first of each year. A vacancy
20 occurring other than by reason of the expiration of a term must be filled in the same manner as
21 original appointments, except that the appointment may be made for only the remainder of the
22 unexpired term. The members are entitled to be paid for mileage and actual expenses incurred
23 in attending meetings and in performance of their official duties in amounts provided by law for
24 other state officers and employees. ~~The~~ This commission shall coordinate activities and serve
25 as a clearinghouse and an advisory group to the ~~department~~ division for information relating to
26 economic development programs that focus on career development for women. ~~The~~ This
27 commission shall prepare for and perform followup duties in connection with state, regional, and
28 national conferences, encourage interest, participation, and cooperation with state departments,
29 agencies, and other organizations in developing needed services, facilities, and opportunities,
30 and provide consultant help to local organizations created for the purpose of coordinating
31 activities for the economic and career development of women.

1 **SECTION 39. AMENDMENT.** Section 54-34.3-11 of the 1999 Supplement to the North
2 Dakota Century Code is amended and reenacted as follows:

3 **54-34.3-11. Mutual fund capital pool - Authorization.** The ~~department~~ division of
4 economic development and finance, in conjunction with the agricultural products utilization
5 commission, may establish a mutual fund capital pool to attract farm and nonfarm investments
6 in value-added processing projects.

7 **SECTION 40. AMENDMENT.** Section 54-34.4-01 of the 1999 Supplement to the North
8 Dakota Century Code is amended and reenacted as follows:

9 **54-34.4-01. ~~Tourism department~~ Division of tourism - Director.**

- 10 1. The division of tourism ~~department~~ is established to foster and promote tourism to,
11 and within, the state and the full development of the state's tourism resources, and
12 to serve as a planning and coordinating agency for tourism-related programs of the
13 state and the state's political subdivisions.
- 14 2. The ~~governor~~ commissioner of commerce shall appoint a director of the division of
15 tourism ~~department~~ who shall serve at the will of the ~~governor~~ commissioner. The
16 director shall supervise and control the division of tourism ~~department~~.

17 **SECTION 41. AMENDMENT.** Section 54-34.4-02 of the 1999 Supplement to the North
18 Dakota Century Code is amended and reenacted as follows:

19 **54-34.4-02. Duties of director.** The director of the department of commerce division
20 of tourism ~~department~~, within the limits of legislative appropriations, shall:

- 21 1. Implement the state's tourism policy;
- 22 2. Prepare and update annually a tourism master plan for the development of tourism
23 in the state which identifies the state's tourism resources, estimates the impact of
24 tourism on the state's economy, and proposes a five-year plan for activities of the
25 division;
- 26 3. Measure and forecast visitor volume, receipts, and related social and economic
27 impacts;
- 28 4. Work with the private sector and local, state, and federal agencies to develop the
29 state's tourism-related infrastructure, facilities, services, and attractions, including
30 the state's highways and parks;

- 1 5. Organize and coordinate programs designed to promote tourism to, and within, the
2 state through various means. Those means may include:
 - 3 a. Display advertising in magazines and newspapers;
 - 4 b. Advertising on radio and television or other advertising media;
 - 5 c. Publishing pamphlets, brochures, and other graphic and pictorial materials;
 - 6 and
 - 7 d. Aiding and assisting representatives of the media to ensure greater coverage
8 of the state's visitor attractions;
- 9 6. Participate in travel shows;
- 10 7. Supervise and administer visitor information centers that receive funding from the
11 state;
- 12 8. Develop opportunities for professional and technical education and training in the
13 visitor industry;
- 14 9. Foster an understanding among the state's residents of the economic importance
15 to the state of hospitality and tourism;
- 16 10. Cooperate with local, state, and federal agencies and organizations and the private
17 sector for the promotion and development of tourism to, and within, the state;
- 18 11. Provide advice and technical assistance to local, public, and private tourism
19 organizations in promoting and developing tourism; and
- 20 12. Monitor the policies and programs of state agencies that significantly affect the
21 visitor industry, notify those agencies of the effects of their actions on travel to, and
22 within the state, and if necessary recommend programs or policy changes to those
23 agencies.

24 **SECTION 42. AMENDMENT.** Section 54-34.4-04 of the 1999 Supplement to the North
25 Dakota Century Code is amended and reenacted as follows:

26 **54-34.4-04. North Dakota motion picture development office - Advisory board.**

27 The North Dakota motion picture development office is a part of the department of commerce
28 division of tourism ~~department~~. The office shall promote North Dakota as a location for
29 shooting films, television shows, documentaries, and commercials, and shall provide technical
30 expertise to persons desiring to use the state as a filming location. The director of the division
31 of tourism ~~department~~ shall appoint staff necessary to fulfill the functions and duties of the office

1 and shall appoint an advisory board of no more than ten members to assist in advising the
2 office and to provide technical expertise to offer prospective film companies seeking locations
3 and advice. The board shall serve without compensation, except reimbursement for actual and
4 necessary expenses at the same rate as allowed other state officers to be paid from funds
5 available to the office within the limits of legislative appropriations.

6 **SECTION 43.** A new chapter to title 54 of the North Dakota Century Code is created
7 and enacted as follows:

8 **Definitions.** In this chapter, unless the context or subject matter otherwise requires:

- 9 1. "Cabinet" means the North Dakota commerce cabinet.
- 10 2. "Commissioner" means the commissioner of commerce.
- 11 3. "Department" means the department of commerce.
- 12 4. "Foundation" means the North Dakota economic development foundation.

13 **Department of commerce - Divisions.** The North Dakota department of commerce is
14 created. All records, materials, supplies, and equipment used by the division of community
15 services, department of economic development and finance, and the department of tourism are
16 transferred to the department.

- 17 1. The department must consist of:
 - 18 a. A division of community services;
 - 19 b. A division of economic development and finance;
 - 20 c. A division of tourism;
 - 21 d. A division of international trade;
 - 22 e. A division of workforce development; and
 - 23 f. Any division the commissioner deems necessary to carry out this chapter.
- 24 2. Each division director serves at the will of the commissioner and receives a salary
25 set by the commissioner within the limits of legislative appropriations.

26 **Commissioner of commerce - Duties.** With the advice and counsel of the North
27 Dakota development foundation, the governor shall appoint a commissioner to supervise,
28 control, and administer the department. The commissioner serves at the pleasure of the
29 governor and receives a salary set by the governor within the limits of legislative appropriations.
30 The commissioner:

- 1 1. Shall file an oath of office in the usual form before commencing to perform the
- 2 duties of the commissioner;
- 3 2. Shall serve as chairman of the cabinet;
- 4 3. Shall prepare the cabinet's coordinated plan identifying economic development
- 5 moneys in budget requests of cabinet agencies;
- 6 4. Shall appoint directors to administer each of the department divisions;
- 7 5. Shall appoint personnel as may be determined necessary to carry out the duties of
- 8 the department;
- 9 6. Shall manage the operations of the department and oversee each of the divisions;
- 10 7. Shall assume central responsibilities to develop, implement, and coordinate a
- 11 working network of commerce service providers;
- 12 8. Shall coordinate the department's services with commerce-related services of
- 13 other state agencies;
- 14 9. Shall advise and cooperate with departments and agencies of the federal
- 15 government and of other states; private businesses, agricultural organizations, and
- 16 associations; and research institutions; and with any individual or other private or
- 17 public entity;
- 18 10. May enter into contracts upon terms and conditions as determined by the
- 19 commissioner to be reasonable and to effectuate the purposes of this chapter;
- 20 11. Shall report between the first and tenth legislative days of each regular legislative
- 21 session to a standing committee of each house of the legislative assembly as
- 22 determined by the legislative council and shall report annually to the foundation on
- 23 the department's goals and objectives since the last report, on the department's
- 24 goals and objectives for the period until the next report, on the department's
- 25 long-term goals and objectives, and summarizing the department's activities and
- 26 measurable results occurring since the last report;
- 27 12. Shall adopt rules necessary to implement this chapter; and
- 28 13. May take any actions necessary and proper to implement this chapter.

29 **North Dakota economic development foundation - Executive committee -**

30 **Purpose.** The North Dakota economic development foundation is created.

- 1 1. The foundation is composed of a minimum of fifteen and a maximum of thirty
2 members appointed by the governor for two-year terms, except the governor shall
3 appoint approximately one-half of the initial foundation members to one-year terms
4 in order to initiate a cycle of staggered terms. Appointment of the foundation
5 members must ensure a cross section of business and economic development
6 representation.
- 7 2. The foundation members shall elect an executive committee with a minimum of five
8 and a maximum of nine foundation members. The executive committee members
9 shall elect a chairman, vice chairman, and a secretary.
- 10 3. The purpose of the foundation is to:
 - 11 a. Provide the governor advice and counsel in selecting the commissioner;
 - 12 b. Serve in an advisory role to the commissioner, including counsel in the
13 development of the division of economic development and finance's strategic
14 plan;
 - 15 c. Monitor economic development activities and initiatives of the department;
16 and
 - 17 d. Set accountability measurements for the department.
- 18 4. The foundation shall seek funding for administrative expenses from private sector
19 sources and shall seek and distribute private sector funds for use in
20 commerce-related activities in the state.

21 **Compensation of foundation members.** A foundation member is entitled to receive
22 compensation in the amount of sixty-two dollars and fifty cents per day for days spent in
23 attendance at foundation meetings or other business as approved by the foundation. A
24 foundation member is entitled to reimbursement for mileage and expenses as provided for state
25 officers.

26 **Commerce cabinet.** The North Dakota commerce cabinet is created. The cabinet is
27 composed of the executive heads, or other authorized representatives, of the state board for
28 vocational and technical education, the state board of higher education, the Bank of North
29 Dakota, the department of agriculture, the workers compensation bureau, and of any other state
30 agency appointed by the commissioner. The commissioner is the chairman of the cabinet and
31 shall determine which agencies are members of the cabinet. The cabinet shall:

- 1 1. Coordinate and communicate economic development efforts of the agencies
2 represented.
- 3 2. Meet a minimum of four times and a maximum of twelve times each year.
- 4 3. Develop and make available before each regular session of the legislative
5 assembly a coordinated plan that identifies economic development moneys
6 included in budget requests of cabinet agencies.

7 **Cooperation with other agencies or private entities to jointly publish or mail**
8 **publications.** The department may cooperate with other state agencies or with a private entity
9 for the purpose of jointly publishing or distributing information or publications as provided in
10 section 54-06-04.3.

11 **SECTION 44. AMENDMENT.** Subsection 15 of section 54-44.3-20 of the 1999
12 Supplement to the North Dakota Century Code is amended and reenacted as follows:

- 13 15. Officers and employees of the department of commerce division of economic
14 development and finance.

15 **SECTION 45. AMENDMENT.** Section 54-44.5-01 of the 1999 Supplement to the North
16 Dakota Century Code is amended and reenacted as follows:

17 **54-44.5-01. Definitions.** In this chapter, unless the context or subject matter otherwise
18 requires:

- 19 1. "Community action agency" means a not-for-profit corporation that has authority
20 under its charter and bylaws to receive funds to administer community action
21 programs and which was officially designated as a community action agency or a
22 community action program under section 210 of the Economic Opportunity Act of
23 1964 [Pub. L. 88-452; 78 Stat. 508; 42 U.S.C. 2701 et seq.], unless the community
24 action agency or a community action program lost its designation as a result of
25 failure to comply with the provisions of the federal act.
- 26 2. "Community action program" means a community-based and operated program
27 that includes an intake assessment and referral capability in each of its counties
28 and is designed to include a number of projects or components to provide a range
29 of services and activities having a measurable and potentially major impact on
30 causes and conditions of poverty in the community or those areas of the
31 community where poverty is a particularly acute problem. These services and

- 1 activities may include activities designed to provide opportunities for eligible
2 persons to:
- 3 a. Secure and retain meaningful employment;
 - 4 b. Attain an adequate education;
 - 5 c. Make better use of available income;
 - 6 d. Obtain and maintain adequate housing and suitable living environment;
 - 7 e. Obtain emergency assistance through grants and loans to meet immediate
8 and urgent individual and family needs, including the need for health services,
9 nutritious food, housing, and employment-related assistance;
 - 10 f. Maximize the role community action agencies play in supportive mechanisms
11 available to North Dakota families;
 - 12 g. Remove obstacles and solve problems that block achievement of
13 self-sufficiency;
 - 14 h. Achieve greater participation in the affairs of the community; and
 - 15 i. Make more effective use of other programs.
- 16 3. "Department" means the department of commerce.
- 17 ~~4. "Director" means the director of the division of community services.~~
- 18 ~~4.~~ 5. "Division" means the department division of community services.

19 **SECTION 46. AMENDMENT.** Section 54-44.5-02 of the 1999 Supplement to the North
20 Dakota Century Code is amended and reenacted as follows:

21 **54-44.5-02. Division of community services - Creation.** The division of community
22 services is established in the ~~office of management and budget~~ department to provide technical
23 assistance to local governments, state agencies, and the executive branch in the area of
24 community and rural planning and development, policy research and development, and grant
25 program implementation. The ~~director of the office of management and budget~~ commissioner
26 shall appoint a director of the division upon the basis of education and experience. The position
27 of director is not a classified position and the director shall serve at the pleasure of the ~~director~~
28 ~~of the office of management and budget~~ commissioner. The director of the division may
29 employ such other professional, technical, and clerical persons as may be necessary and may
30 fix their compensation within the limits of legislative appropriation. All personnel within the

1 division must be allowed their actual and necessary travel expenses at the same rate as for
2 other employees of the state.

3 **SECTION 47. AMENDMENT.** Section 54-44.5-03 of the 1999 Supplement to the North
4 Dakota Century Code is amended and reenacted as follows:

5 **54-44.5-03. Powers and duties of the director.** The director shall direct and
6 supervise, with the approval of the ~~director of the office of management and budget~~
7 commissioner, all the administrative and technical activities of the division.

8 **SECTION 48. AMENDMENT.** Section 54-44.5-05 of the 1999 Supplement to the North
9 Dakota Century Code is amended and reenacted as follows:

10 **54-44.5-05. Continuing appropriation.** There is hereby appropriated as a standing
11 and continuing appropriation to the ~~division of community services~~ department for the purpose
12 of carrying out the provisions of this chapter, including the administration of such provisions, all
13 moneys returned as repayments of federal or other funds granted under the community
14 development loan fund, and all earnings from the investment of such moneys, which may be
15 received from time to time by the division. Administrative expenses may only be charged
16 against such moneys to the extent permitted by federal law or regulations.

17 **SECTION 49. AMENDMENT.** Section 54-53-02 of the 1999 Supplement to the North
18 Dakota Century Code is amended and reenacted as follows:

19 **54-53-02. Advisory transportation council - Composition.** There is hereby
20 established a transportation council which shall serve in an advisory capacity to the upper great
21 plains transportation institute. The director of the institute shall serve as the executive secretary
22 of the council and it shall elect its own chairman. The council membership shall consist of one
23 representative from and appointed by the following organizations:

- 24 1. The greater North Dakota association.
- 25 2. The public service commission.
- 26 3. The North Dakota farm bureau.
- 27 4. The North Dakota farmers union.
- 28 5. The livestock industry council.
- 29 6. The North Dakota wheat commission.
- 30 7. The North Dakota department of commerce division of economic development and
31 finance.

- 1 8. The North Dakota farmers grain dealers association.
- 2 9. The North Dakota railway lines.
- 3 10. The North Dakota motor carriers association.
- 4 11. The North Dakota aeronautics commission.
- 5 12. A traffic counsel selected by the members of the council appointed by the
- 6 above-named organizations.

7 Members of the council shall serve without pay, but they may receive reimbursement for
8 actual and necessary expenses incurred in the performance of their duties, if authorized by the
9 director.

10 The council shall consult with the institute in matters of policy affecting the
11 administration of this chapter and in the development of transportation in the state of North
12 Dakota. The council shall meet at the call of the executive director or upon the written request
13 of three or more members of the council.

14 **SECTION 50. AMENDMENT.** Section 55-01-01 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **55-01-01. State historical board.** There is a state historical society of North Dakota
17 which is under the supervision and control of the state historical board. The board consists of
18 seven members who are appointed by the governor. Each member appointed to the board
19 must be a citizen and resident of the state of North Dakota. Appointments are for a term of
20 three years from the first day of July to the thirtieth day of June of the third year or until a
21 successor has been appointed and qualified. The governor shall appoint two members for
22 terms commencing in 1996, two members for terms commencing in 1997, and three members
23 for terms commencing in 1998. Vacancies occurring other than by the expiration of an
24 appointive term must be filled by appointment for the remainder of the term only in the same
25 manner as regular appointments. The board of directors shall select from its membership a
26 president, vice president, and secretary to serve as officers of the board. The secretary of
27 state, director of the parks and recreation department, director of the department of
28 transportation, director of the department of commerce division of tourism department, and
29 state treasurer are ex officio members of the board and shall take care that the interests of the
30 state are protected. Each ex officio member may appoint a designee to attend meetings with
31 full voting privileges.

1 **SECTION 51. AMENDMENT.** Section 55-06-01 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **55-06-01. Yellowstone-Missouri-Fort Union commission.** There is a
4 Yellowstone-Missouri-Fort Union commission, hereinafter referred to as the "commission",
5 declared to be a governmental agency with the authority to exercise the powers specified
6 herein, or which may be reasonably implied, composed of the governor as chairman, the
7 president of the senate, the speaker of the house, the superintendent of the state historical
8 board, the ~~director~~ commissioner of the department of ~~economic development and finance~~
9 commerce, all ex officio, and five citizens of the state to be appointed by the governor who shall
10 serve without compensation for the purpose of investigating, in cooperation with the state of
11 Montana and the national park service, the historical importance and significance of the area
12 and for formulating and executing plans for the preservation of the historic sites illustrative of
13 the history of the United States. The commission may expend its operating expenses and other
14 funds provided by legislative appropriations, and public and private grants, for programs,
15 improvements, and facilities to preserve and improve the Yellowstone-Missouri confluence
16 area.

17 **SECTION 52. AMENDMENT.** Subsection 1 of section 57-38.5-01 of the North Dakota
18 Century Code is amended and reenacted as follows:

19 1. "Director" means the director of the department of commerce division of economic
20 development and finance.

21 **SECTION 53. AMENDMENT.** Section 57-38.5-08 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **57-38.5-08. Rules and administration.** The tax commissioner is charged with
24 administration of this chapter as it relates to an income tax credit and has the same powers as
25 provided under section 57-38-56 for purposes of this chapter. The director is charged with
26 administration of this chapter as it relates to certification of qualified businesses and the ~~director~~
27 commissioner of commerce may adopt rules for that purpose.

28 **SECTION 54. AMENDMENT.** Subsection 6 of section 57-39.2-28 of the North Dakota
29 Century Code is amended and reenacted as follows:

1 6. Notwithstanding section 57-39.2-23, the commissioner may provide names and
2 addresses of Canadian residents claiming a North Dakota sales tax refund to the
3 director of the department of commerce division of tourism ~~department~~.

4 **SECTION 55. REPEAL.** Section 54-34.3-09 of the North Dakota Century Code is
5 repealed.

6 **SECTION 56. APPROPRIATION - TRANSFER.** As of the effective date of this Act, the
7 division of community services, department of economic development and finance, and tourism
8 department are abolished and any funds appropriated to these agencies by the fifty-sixth
9 legislative assembly and fifty-seventh legislative assembly are transferred to the department of
10 commerce.

11 **SECTION 57. EFFECTIVE DATE.** This Act becomes effective on August 1, 2001.

NOTE: This bill draft provides the Governor shall appoint:

1. A Commissioner of Commerce who:
 - a. Appoints directors for the following statutory divisions of the Department of Commerce:
 - (1) Division of Community Services;
 - (2) Division of Economic Development and Finance, the director of which appoints deputy directors for the following offices:
 - (a) Finance Office;
 - (b) North Dakota American Indian Business Development Office;
 - (c) North Dakota Women's Business Development Office; and
 - (d) Any other offices deemed necessary;
 - (3) Division of Tourism, which must include the North Dakota Motion Picture Development Office;
 - (4) Division of International Trade;
 - (5) Division of Workforce Development; and
 - (6) Any additional divisions deemed necessary; and
 - b. Determines additional member agencies for the North Dakota Commerce Cabinet.
2. Members of North Dakota Development Foundation (15-30 members).
