SECTION 1. APPROPRIATION FOR THE LEGISLA	TIVE BRANCH OF STATE

6 necessary, are hereby appropriated out of any moneys in the general fund in the state treasury,	
7 not otherwise appropriated, to the legislative branch of the state government for the purpose of	
8 defraying the expenses of that branch, for the fiscal period beginning with the effective date of	
9 this Act and ending June 30, 2001, as follows:

1 **SECTION 2. TRANSFERS.** Notwithstanding section 54-16-04, the director of the office 2 of management and budget and the state treasurer shall make transfers of funds between line 3 items of appropriations for the legislative council as may be requested by the chairman of the council or the chairman's designee upon the finding by the chairman or designee that the 4 5 nature of studies and duties assigned to the council requires the transfers in properly carrying on the council's functions and duties. The director of the office of management and budget and 6 the state treasurer shall similarly make transfers of funds between the line items for the 7 fifty-sixth and fifty-seventh legislative assemblies, upon request by the chairman of the 8 9 legislative council or the chairman's designee upon the finding by the chairman or designee that 10 the transfers are required for the legislative assembly to carry on its functions and duties.

**SECTION 3. EMERGENCY.** This Act is declared to be an emergency measure.
