## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 11-33-02 of the North Dakota Century Code is

amended and reenacted as follows: 11-33-02. Board of county commissioners to designate districts. For any or all of

the purposes designated in section 11-33-01, the board of county commissioners may divide by

resolution divide all or any parts of the county, subject to the provisions of section 11-33-20,

into districts of such number, shape, and area as may be deemed determined necessary, and

may likewise may enact suitable regulations to carry out the purposes of this chapter. These

12 regulations shall must be uniform in each district, but the regulations in one district may differ

from those in other districts. No A regulation or restriction, however, shall may not prohibit or

14 prevent the use of land or buildings for farming or ranching or any of the normal incidents of

farming or ranching. For purposes of this section, "farming or ranching" means cultivating land 15

16 for production of agricultural crops or livestock, or raising, feeding, or producing livestock or

17 livestock products, poultry or poultry products, milk or dairy products, or fruit or horticultural

18 products. The term does not include producing timber or forest products, nor does the term

19 include a contract whereby a processor or distributor of farm products or supplies provides

20 grain, harvesting, or other farm services. The provisions of this This chapter shall does not be

construed to include any power relating to the establishment, repair, and maintenance of

22 highways or roads.

> SECTION 2. AMENDMENT. Section 58-03-11 of the North Dakota Century Code is amended and reenacted as follows:

1 58-03-11. Establishment of zoning districts - Limitation - Scope of zoning 2 regulations and restrictions. For the purpose of promoting the health, safety, morals, or the 3 general welfare, or to secure the orderly development of approaches to municipalities, the 4 board of township supervisors may establish one or more zoning districts and within such 5 districts may, subject to the provisions of chapter 54-21.3, regulate and restrict the erection, 6 construction, reconstruction, alteration, repair, or use of buildings and structures, the height, 7 number of stories, and size of buildings and structures, the percentage of lot that may be 8 occupied, the size of courts, yards, and other open spaces, the density of population, and the 9 location and use of buildings, structures, and land for trade, industry, residence, or other 10 purposes. All such regulations and restrictions must be uniform throughout each district, but 11 the regulations and restrictions in one district may differ from those in other districts. No A 12 regulation or restriction, however, may not prohibit or prevent the use of land or buildings for 13 farming or ranching or any of the normal incidents of farming or ranching. For purposes of this 14 section, "farming or ranching" means cultivating land for production of agricultural crops or livestock, or raising, feeding, or producing livestock or livestock products, poultry or poultry 15 16 products, milk or dairy products, or fruit or horticultural products. The term does not include 17 producing timber or forest products, nor does the term include a contract whereby a processor 18 or distributor of farm products or supplies provides grain, harvesting, or other farm services. 19 The provisions of sections Sections 58-03-11 through 58-03-15 may do not be construed to 20 include any power relating to the establishment, repair, and maintenance of highways or roads.
