5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Subsection 2 of section 54-05.1-03 of the 1997
7 Supplement to the North Dakota Century Code is amended and reenacted as follows:

- 8 2. Each person so registering to act as a lobbyist shall, on or before August first 9 following the expiration of the registration period, file with the secretary of state a 10 detailed report. The report must include a statement as to each expenditure, if 11 any, of twenty-five dollars or more expended on any single occasion during the 12 legislative session or the interim, as the case may be, on any individual in carrying 13 out the lobbyist's work or include a statement that no reportable expenditures were 14 made during the reporting period. No <u>A</u> state official or agency may <u>not</u> require 15 reporting of lobbyist expenditures other than is required under this subsection. 16 The secretary of state shall provide a prescribed form for reporting pursuant to this 17 chapter. The secretary of state shall charge and collect fees for late filing of the 18 detailed expenditure report as follows: Within sixty days after the date provided in this subsection for filing the 19 a. 20 detailed expenditure report, twenty-five dollars; 21 Thereafter, fifty dollars; and b. 22 If any currently registered lobbyist fails to file a detailed expenditure report <u>C.</u>
 - and pay any late fee by October first, the lobbyist's registration is
- 24 automatically revoked. The lobbyist's registration may be reinstated if the

5	1.	It is t	he duty and responsibility of the secretary of state:
6		a.	To grant a certificate of registration and to design and furnish a distinctive
7			lobbyist identification badge to any person registering under section
8			54-05.1-03 who supplies the information therein required.
9		b.	To revoke the certificate of registration of any person who has been convicted
10			of violating any of the provisions of this chapter.
11		c.	To refer on his the secretary of state's own motion or on the verified complaint
12			of any member of the legislative assembly or on the verified complaint of any
13			state official, board, commission, department, or agency, or on the verified
14			complaint of any other person, to the attorney general for investigation, the
15			activities of any person who he the secretary of state has reason to believe
16			has been acting as a lobbyist and who may be in violation of the requirements
17			of this chapter.
18		d.	To make available upon request of any citizen expenditures by categories
19			reported by registered lobbyists to have been expended on each individual in
20			carrying out his that person's work.
21		e.	To supply a current list of registered lobbyists for each legislator upon
22			request. A current list of lobbyists must be posted in the legislative chambers
23			during the legislative session.
