1 A BILL for an Act to provide fire sprinkler system license; and to provide a penalty.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 3 **SECTION 1. Definitions.** As used in this Act, unless the otherwise requires:
  - 1. "Apprentice fire sprinkler fitter" means an individual, other than a journeyman fire sprinkler fitter, who:
    - a. Has paid the annual fee;
    - Is engaged in learning and assisting in the practical installing, testing, inspecting, dismantling to terminate, and repairing of fire sprinkler systems, under the supervision of a licensed journeyman fire sprinkler fitter and a fire sprinkler contractor;
    - c. Is in a registered apprenticeship program under state or federal law; and
    - d. Is registered with the state fire marshal.
    - 2. "Board" means the fire sprinkler license examining board.
    - 3. "Fire sprinkler contractor" means any person who has paid the annual fee and obtained a license to conduct a business in the designing, installing, inspecting, testing, dismantling to terminate service, maintaining, or repairing of fire sprinkler systems. Who employs any licensed professional engineer in the appropriate field of competence or any person who:
      - Submits to the state fire marshal satisfactory proof of having successfully completed an accredited course in fire sprinkler engineering technologies or design;
      - Submits a letter from the national institute for certification in engineering technologies or other accredited school verifying successful completion of the examination for level III fire sprinkler engineering technologies or design; and

- 1 Holds a current fire sprinkler designer's license issued by any other state or C. 2 Canadian province and has registered with the state fire marshal. 3 4. "Fire sprinkler system" means an integrated overhead piping system designed in 4 accordance with fire protection engineering standards, including: 5 The system includes at least one automatic water supply. a. 6 b. The aboveground portion of the system is a scheduled or hydraulically 7 designed piping installed in a building, structure, or area, generally overhead, 8 to which sprinklers are attached in a systematic pattern. 9 The valve controlling each system riser is located in a system riser or its C. 10 supply piping. 11 d. Each system riser includes a device for activating an alarm when the system 12 is in operation. 13 The system is usually activated by heat from a fire and discharges water over e. 14 the fire area. 15 "Journeyman sprinkler fitter" means any individual: 5. 16 With a minimum of ten thousand hours of experience as a fire sprinkler fitter; a. 17 b. Who has paid the annual fee for license as a journeyman fire sprinkler fitter; 18 C. Has obtained a license as a journeyman fire sprinkler fitter; and 19 d. Is engaged in the practical installing, inspecting, testing, dismantling to 20 terminate service, maintaining, and repairing of fire sprinkler systems. 21 **SECTION 2.** Fire sprinkler system license examining board. The board consists of 22 five members appointed by the Governor. One member must be an employee of the state fire 23 marshal, and that member shall serve as secretary of the board; one member must be selected 24 from local fire service jurisdiction; one member must be a licensed journeyman fire sprinkler 25 fitter; one member must be a fire sprinkler contractor or an employee of a fire sprinkler 26 contractor; and one member must be a consumer at large. Board members shall serve 27 four-year terms, except the Governor shall appoint the initial members to terms of four years or 28 less so the terms of no more than two members expire each year. is entitled to reimbursement for actual expenses incurred in performance of official duties as

- 1 1. The board shall adopt rules governing:
  - Initial and subsequent competence, qualifications, examinations, and
    licensing of fire sprinkler contractors and journeyman fire sprinkler fitters;
  - b. Fees and fines; and
  - c. System design and criteria.
  - 2. The state fire marshal is responsible for registration of fire sprinkler journeyman sprinkler fitters, designers, contractors, and apprentice fire sprinkler fitters.

**SECTION 4.** License requirement. A person may not install, test, dismantle to terminate service, modify, alter, maintain, or make a maintenance inspection on a fire sprinkler system or offer to do so unless licensed as a journeyman sprinkler fitter or a fire sprinkler contractor. A license is not required to perform emergency repairs on exiting installations. An emergency repair must be inspected by a licensed journeyman fire sprinkler fitter as soon as possible.

**SECTION 5. Issuances of licenses.** The state fire marshal shall issue licenses and register persons under this Act. A license or registration expires on December thirty-first of each year unless otherwise revoked. Annual renewal must be submitted on forms provided by the state fire marshal.

**SECTION 6.** Apprentice fire sprinkler fitter registration. An apprentice fire sprinkler fitter is not required to apply for a license, but shall register with the state fire marshal before engaging in assisting and learning of the installing, testing, inspecting, dismantling to terminate service, maintaining, and repairing of a fire protection system. Upon registration, the apprentice shall provide proof of being in an approved apprenticeship program.

SECTION 7. Conceptual drawing, plan, or design for system requirements. A fire sprinkler contractor must be licensed or registered with the state fire marshal before preparing a conceptual drawing, plan, or design for a fire sprinkler system. The drawing, plan, or design must include the license or registration number of the contractor and designer. A designer may not be a qualifier or license holder for more than one fire sprinkler contractor at a time. A fire sprinkler contractor may obtain design services from any designer registered with the state fire marshal.

**SECTION 8.** Journeyman fire sprinkler fitter licenses. Journeyman fire sprinkler fitter license reciprocity may be available with other states if the other state reciprocates with

1 North Dakota, the other state has equal or more stringent requirements, the journeyman fire 2 sprinkler fitter has applied for a North Dakota license and has paid the required fee to the state 3 of North Dakota. The state fire marshal may not restrict any licensed journeyman fire sprinkler 4 fitter's work to any geographical territory. 5 SECTION 9. Fire protection contractor bond requirements. A fire sprinkler 6 contractor must have: 7 A general liability insurance policy meeting these requirements: 8 The policy must include products and complete operation coverage. 9 The limits of the insurance coverage for the policy must be at least two b. 10 hundred thousand dollars per person, five hundred thousand per occurrence, 11 and property damage with limits of one million dollars. 12 C. Proof of insurance must be provided at the time of license application; and 13 2. A bond meeting the following requirements: 14 The bond must be for the total penal sum of thirty thousand dollars a. conditioned upon the faithful and lawful performance of all work within the 15 16 state. 17 The bond must be for the benefit of persons injured or suffering financial loss b. 18 by reason of failures of performance. 19 The term of the bond must be concurrent with the term of the license. C. 20 d. The bond must be written by a corporate surety licensed to do business in the 21 state, be a cash bond, or be an irrevocable line of credit. 22 The bond must contain stipulation that the bond may not be canceled, e. 23 terminated, or changed in a way so that it no longer meets the requirements 24 of this subdivision, except upon thirty days prior written notice to the state fire 25 marshal. 26 SECTION 10. Fees. Fees, fines, and permits must fund all enforcement and 27 administrative costs for issuing licenses and registrations under this Act. The following fees 28 must be paid to the state fire sprinkler board: 29 Fire sprinkler contractor annual license fee, two hundred fifty dollars.

Fire sprinkler contractors permit fee, due upon application, two percent of the 2 actual cost of the material, labor and components of the fire sprinkler system on 3 each contract installation, service contracts, and fire sprinkler work performed. 4 3. Journeyman sprinkler fitter annual license fee, seventy-five dollars. 5 4. Apprentice fire sprinkler fitter annual registration fee, fifteen dollars. 6 5. Fire sprinkler designer annual registration fee, fifteen dollars. 7 **SECTION 11. Penalty and fines.** Any person willfully violating this Act is guilty of a 8 class B misdemeanor. A separate violation occurs each day the violation continues. Fines and 9 penalties for violations are: 10 First violation, suspension of license or class B misdemeanor, with a fine not to 11 exceed five hundred dollars. 12 2. Second violation, suspension of license or class A misdemeanor, with a fine not to 13 exceed one thousand dollars. 14 3. Third violation, revocation of license or fine not to exceed one thousand dollars or 15 imprisonment not to exceed thirty days, or both, may be imposed plus actual court 16 costs. 17 SECTION 12. Suspension or revocation of license. The board may suspend or 18 revoke a license following notice and opportunity for hearing, if the holder has: 19 1. Obtained or attempted to obtain a license by fraudulent misrepresentation. 20 2. Committed malpractice or exhibited incompetency in the installation or servicing of 21 any fire sprinkler equipment. 22 3. Serviced and failed to provide written notification to the owner and the authority 23 having jurisdiction of any deficiencies found in the fire system.

- 4. Employed a person who installs or services fire sprinkler equipment without the required license.
- 5. Violated any of the conditions, qualifications, or limitations set forth in the license or allows the license to be used by anyone other than the person or entity to whom the license was issued.
- SECTION 13. Continuing education requirements. During each calendar year, all fire sprinkler fitter designers, journeyman fire sprinkler fitters, and apprentice fire sprinkler fitters are required to attend eight hours of continuing education courses on the performance of fire

- 1 sprinkler-related work. All continuing education courses must be in the form of a workshop,
- 2 seminar, or educational conference approved by the board.
