# FIRST ENGROSSMENT with Conference Committee Amendments ENGROSSED HOUSE BILL NO. 1099

## Introduced by

Government and Veterans Affairs Committee

(At the request of the Public Employees Retirement System)

## 1 A BILL for an Act to create and enact a new subsection to section 54-52-04 of the North Dakota

- 2 Century Code, relating to state retirement board authority over excess uniform group insurance
- 3 program funds; to amend and reenact subsection 4 of section 54-52.1-01, subsection 3 of
- 4 section 54-52.1-03, and sections 54-52.1-03.3, 54-52.1-06, and 54-52.1-11 of the North Dakota
- 5 Century Code, relating to the definition of eligible employee, retiree eligibility for the group
- 6 health insurance program and retiree health benefits, and excess funds and confidentiality of
- 7 records under the uniform group insurance program; and to provide a transfer.

## 8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

9	SEC	CTION 1. A new subsection to section 54-52-04 of the 1999 Supplement to the
10	North Dako	ta Century Code is created and enacted as follows:
11		The board may use any amount credited to the separate uniform group insurance
12		program fund created by section 54-52.1-06 in excess of the costs of
13		administration of the uniform group insurance program to reduce the amount of
14		premium amounts paid monthly by enrolled members of the uniform group
15		insurance program, to reduce any increase in premium amounts paid monthly by
16		enrolled members, or to provide increased insurance coverage to the members, as
17		the board may determine.
18	SEC	CTION 2. AMENDMENT. Subsection 4 of section 54-52.1-01 of the 1999
19	Supplemen	t to the North Dakota Century Code is amended and reenacted as follows:
20	4.	"Eligible employee" means every permanent employee who is employed by a
21		governmental unit, as that term is defined in section 54-52-01. "Eligible employee"
22		includes members of the legislative assembly, judges of the supreme court, paid
23		members of state or political subdivision boards, commissions, or associations,
24		full-time employees of political subdivisions, elective state officers as defined by

1 subsection 2 of section 54-06-01, and disabled permanent employees who are 2 receiving compensation from the North Dakota workers' compensation fund. As 3 used in this subsection, "permanent employee" means one whose services are not 4 limited in duration, who is filling an approved and regularly funded position in a 5 governmental unit, and who is employed at least seventeen and one-half hours per 6 week and at least five months each year. For purposes of sections 54-52.1-04.1, 7 54-52.1-04.7, 54-52.1-04.8, and 54-52.1-11, "eligible employee" includes retired 8 and terminated employees who remain eligible to participate in the uniform group 9 insurance program pursuant to applicable state or federal law. 10 SECTION 3. AMENDMENT. Subsection 3 of section 54-52.1-03 of the 1999 11 Supplement to the North Dakota Century Code is amended and reenacted as follows: 12 3. A retiree who has accepted a periodic distribution from the defined contribution 13 retirement plan pursuant to section 54-52.6-13 who the board determines is 14 eligible for participation in the uniform group insurance program or has accepted a retirement allowance from the public employees retirement system, the highway 15 16 patrolmen's retirement system, the teachers' insurance and annuity association of 17 America - college retirement equities fund (TIAA-CREF) for service credit earned 18 while employed by North Dakota institutions of higher education, the retirement 19 system established by job service North Dakota under section 52-11-01, the 20 judges' retirement system established under chapter 27-17, or the teachers' fund 21 for retirement may elect to participate in the uniform group under this chapter 22 without meeting minimum requirements at age sixty-five, when the member's 23 spouse reaches age sixty-five, upon the receipt of a benefit, or when the spouse 24 terminates employment. If a retiree or surviving spouse does not elect to 25 participate at the times specified in this subsection, the retiree or surviving spouse 26 must meet the minimum requirements established by the board. Subject to 27 sections 54-52.1-03.2 and 54-52.1-03.3, each retiree or surviving spouse shall pay 28 directly to the board the premiums in effect for the coverage then being provided. 29 SECTION 4. AMENDMENT. Section 54-52.1-03.3 of the 1999 Supplement to the

30 North Dakota Century Code is amended and reenacted as follows:

## 1 54-52.1-03.3. Eligibility for retiree health benefits - Fixed contribution and

- 2 reduction factors.
- The following persons are entitled to receive credit for hospital and medical
   benefits coverage under subsection 2:
- a. A member of the highway patrolmen's retirement system receiving retirement
  benefits, or the surviving spouse of a member of the highway patrolmen's
  retirement system who was eligible to receive or was receiving retirement
  benefits, under section 39-03.1-11.
- 9 b. A member of the public employees retirement system receiving retirement
  10 benefits, or the surviving spouse of a member of the public employees
  11 retirement system who was eligible to receive or was receiving retirement
  12 benefits, under section 54-52-17.
- c. A member of the retirement program established by job service North Dakota
  under section 52-11-01 receiving retirement benefits, or the surviving spouse
  of a member of that retirement program who was eligible to receive or was
  receiving retirement benefits, under the plan provisions of that retirement
  program.
- 18d.A retired judge receiving retirement benefits under the retirement program19established under chapter 27-17, or the surviving spouse of a retired judge20who was eligible to receive or was receiving retirement benefits, under21section 27-17-01.
- e. <u>A former participating member of the defined contribution retirement plan is</u>
   eligible as determined by the board pursuant to its rules.
- 24 2. The board shall calculate the allowable monthly credit toward hospital and medical 25 benefits coverage for a person eligible under subsection 1 in an amount equal to 26 four dollars and fifty cents multiplied by the member's or deceased member's 27 number of years of credited service under the highway patrolmen's retirement 28 system, the public employees retirement system, the retirement program 29 established by job service North Dakota under section 52-11-01, or the judges 30 retirement program established under chapter 27-17. For a member of the public 31 employees retirement system receiving an early retirement benefit or the surviving

1 spouse of that member, or a former participating member of the defined 2 contribution retirement plan who is receiving a periodic distribution and would not 3 meet the normal retirement provisions of the public employees retirement system, 4 the allowable monthly credit must be reduced by three percent if the member 5 terminates employment within one year prior to attaining the age of sixty-five and 6 an additional reduction factor of six percent shall apply for each year the member 7 terminates employment prior to attaining the age of sixty-four. For a member of 8 the highway patrolmen's retirement system receiving an early retirement benefit or 9 the surviving spouse of that member, the allowable monthly credit must be 10 reduced by three percent if the member terminates employment within one year 11 prior to attaining the age of fifty-five and an additional reduction factor of six 12 percent shall apply for each year the member terminates employment prior to 13 attaining the age of fifty-four. For a member of the retirement program established 14 by job service North Dakota under section 52-11-01 receiving an early retirement 15 benefit or a discontinued service annuity under the plan provisions of that 16 retirement program or the surviving spouse of that member, the allowable monthly 17 credit must be reduced by three percent if the member terminates employment 18 within one year prior to attaining the age of sixty-five and an additional reduction 19 factor of six percent applies for each year the member terminates employment 20 prior to attaining the age of sixty-four.

- The board shall apply the credit allowable under subsection 2 to the payment of
   monthly premiums required of each person eligible under subsection 1 for hospital
   benefits coverage and medical benefits coverage under the uniform group
   insurance program. However, if the allowable credit exceeds the monthly premium
   in effect for selected coverage, that amount of the credit which exceeds the
   premium is forfeited and may not be used for any other purpose.
- 4. The board may, as an alternative to the calculation of the allowable monthly credit
  under subsection 2, provide actuarially reduced benefit options for the member
  and the member's surviving spouse including a one hundred percent joint and
  survivor option, a fifty percent joint and survivor option, or a five-year or ten-year
  certain option.

SECTION 5. AMENDMENT. Section 54-52.1-06 of the North Dakota Century Code is
 amended and reenacted as follows:

3 54-52.1-06. State contribution. Each department, board, or agency shall pay to the 4 board each month from its funds appropriated for payroll and salary amounts a state 5 contribution in the amount as determined by the primary carrier of the group contract for the full 6 single rate monthly premium for each of its eligible employees enrolled in the uniform group 7 insurance program and the full rate monthly premium, in an amount equal to that contributed 8 under the alternate family contract, including major medical coverage, for hospital and medical 9 benefits coverage for spouses and dependent children of its eligible employees enrolled in the 10 uniform group insurance program pursuant to section 54-52.1-07. The board shall then pay the 11 necessary and proper premium amount for the uniform group insurance program to the proper 12 carrier or carriers on a monthly basis. Any refund, rebate, dividend, experience rating 13 allowance, discount, or other reduction of premium amount must be credited at least annually 14 to a separate fund of the uniform group insurance program to be used by the board to 15 reimburse the administrative expense and benefit fund of the public employees retirement 16 program for the costs of administration of the uniform group insurance program. Any amount 17 credited to the separate fund in excess of the costs of administration of the program must be 18 held in the separate fund to be used by the board to reduce the amount of premium amounts 19 paid monthly by enrolled eligible employees, to reduce any increase in premium amounts paid 20 monthly by enrolled eligible employees or to provide increased insurance coverage, as the 21 board may determine. In the event an enrolled eligible employee is not entitled to receive 22 salary, wages, or other compensation for a particular calendar month, he that employee may 23 make direct payment of the required premium to the board to continue his the employee's 24 coverage, and the employing department, board, or agency shall provide for the giving of a 25 timely notice to the employee of his that person's right to make such payment at the time such 26 the right arises.

SECTION 6. AMENDMENT. Section 54-52.1-11 of the North Dakota Century Code is
 amended and reenacted as follows:

54-52.1-11. Confidentiality of <u>employee</u> records. Information pertaining to an
 eligible employee's group medical records for claims, <u>employee premium payments made</u>,
 <u>salary reduction amounts taken</u>, <u>history of any available insurance coverage purchased</u>, and

- 1 amounts <u>and types of insurance</u> applied for under the supplemental life insurance coverage
- 2 under this chapter is confidential and is not a public record. The information and records may

3 be disclosed, under rules adopted by the board, only to:

4	1.	A person to whom the eligible employee has given written consent to have the	
5		information disclosed.	
6	2.	A person legally representing the eligible employee, upon proper proof of	
7		representation, and unless the eligible employee specifically withholds consent.	
8	3.	A person authorized by a court order.	
9	<u>4.</u>	A person or entity to which the board is required to disclose information pursuant	
10		to federal statutes or regulations.	
11	<u>5.</u>	If involved in a dissolution proceeding, the member's spouse or former spouse,	
12		that person's legal representative, and the judge presiding over the member's	
13		dissolution proceeding.	
14	SECTION 7. TRANSFER BETWEEN UNIFORM GROUP INSURANCE PROGRAM		
15	FUNDS. F	or the biennium beginning July 1, 2001, and ending June 30, 2003, the executive	
16	director of the public employees retirement system shall transfer \$475,000 from the public		
17	employee life insurance program fund to the uniform group health insurance program fund for		
18	the purpose of increasing the health insurance reserve.
