## FIRST ENGROSSMENT with House Amendments ENGROSSED SENATE BILL NO. 2042

1 A BILL for an Act to amend and reenact sections 15-10-17, 15-11-15, 15-11-32, 15-11-35,

2 15-11-36, and 15-12-22 of the North Dakota Century Code, relating to the powers and duties of

3 the state board of higher education, state mineral tests, the child welfare research bureau, the

4 fetal alcohol syndrome center, and the economic feasibility institute; and to repeal sections

5 15-10-14, 15-10-15, 15-10-25, 15-11-03, 15-11-19, 15-11-27, 15-11-28, 15-11-34, 15-12-03,

6 15-12-04, and 15-13-04 and chapter 47-28 of the North Dakota Century Code, relating to

7 university system faculty, accounts and records, budget requests, expenditure abstracts,

8 patents, university presidents, the university law library, the university radio station, hockey

9 admission receipts, and gifts and grants.

## 10 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 15-10-17 of the 1999 Supplement to the North
 Dakota Century Code is amended and reenacted as follows:

13 15-10-17. Specific powers and duties of <u>the state</u> board of higher education. The
14 state board of higher education has all the powers and shall perform all the duties necessary to
15 the control and management of the institutions described in this chapter, <u>including</u>. In addition
16 to the powers and duties specified in section 6 of article VIII of the Constitution of North Dakota,
17 the board may:

18	1.	<u>a.</u>	To appoint Appoint and remove the president or other faculty head, and the
19			professors, instructors, teachers, officers, and other employees of the several
20			institutions under its control, and to fix their salaries within the limits of
21			legislative appropriations therefor, and to fix the terms of office and to
22			prescribe the duties thereof, provided that the consideration of the
23			appointment or removal of any such personnel shall be in executive session if
24			the board chooses unless the person or persons individual involved request

1		requests that the meeting shall be open to other persons or individuals or to
2		the public.
3		b. Appoint and remove the commissioner of higher education, fix the
4		commissioner's salary within the limits of legislative appropriations, and
5		prescribe the commissioner's duties.
6		c. Appoint and remove all university system office personnel, fix their salaries
7		within the limits of legislative appropriations, fix their terms of office, and
8		prescribe their duties.
9	2.	To control the grounds, buildings, and all other property of such institutions,
10		regulate the conduct of students, staff, faculty, and visitors, and authorize
11		Authorize the employment of law enforcement officers, with having concurrent
12		jurisdiction with other law enforcement officers to enforce laws and regulations at
13		its institutions.
14	3.	To adopt rules and regulations for the government of each of the institutions and of
15		all their departments and branches.
16	<del>4.</del>	To determine the qualifications of applicants for admission to the various courses
17		of instruction, to prescribe by rule criteria for the admission of students, and to
18		ensure that the criteria for admission are applied to all applicants in a uniform and
19		nondiscriminatory manner, regardless of the school or educational setting from
20		which an applicant obtained a high school diploma or its equivalent. No
21		instruction, either sectarian in religion or partisan in politics, shall ever be allowed
22		in any department of such institutions, and no sectarian or partisan test shall ever
23		be allowed or exercised in the election of professors, teachers, or other officers of
24		the institutions, or in the admission of students, or for any other purpose.
25	<del>5.</del>	To prescribe courses of instruction and to confer such degrees and grant such
26		certificates or diplomas for the work done as are usual or appropriate in similar
27		institutions.
28	<del>6.</del>	To delegate to institution officers and faculty the power to suspend or expel
29		students for misconduct or for other causes prescribed in such bylaws.

1 7. To provide for the needs and proper development of each institution in harmony 2 with the best interests of the people of the state, and to improve higher and 3 technical education in the state. 4 <del>8.</del> To coordinate and correlate the work in the different institutions to prevent wasteful 5 duplication and to develop cooperation among the institutions. 6 To fix Set tuition and fees. <del>9.</del> 7 To make recommendations in regard to needed legislation for the institutions <del>10.</del> 8 under its control. 9 <del>11.</del> 4. a. To establish Establish a retirement program as an alternative to chapter 10 15-39.1 for university system employees of institutions under its control 11 subject to the following guidelines: 12 <del>a.</del> (1) Benefits under the program must be provided through annuity contracts 13 purchased by the board but which become the property of the 14 participants; 15 b. (2) The cost of the annuity contracts must be defrayed by contributions 16 made pursuant to rules of the state board of higher education; 17 (3) Eligible employees appointed before July 1, 1973, shall participate in <del>6.</del> 18 the alternate retirement program only by their individual election. When 19 the electing eligible employee is a member of the teachers' fund for 20 retirement, the employee's assessments and employer's contributions 21 together with interest credited at the current rate for one-year 22 certificates then being paid by the Bank of North Dakota must be 23 transferred to the employee's account in the alternate program. The 24 election must be made before July 1, 1980, and shall relinguish all 25 rights the eligible employee or the employee's beneficiary may have to 26 benefits provided in chapters 15-39 and 15-39.2; and 27 <del>d.</del> (4) Employees of institutions under the control of the state board of higher 28 education the university system who are members of the public 29 employees retirement system and who become entitled to participate in 30 the alternate retirement program are entitled to a special annuity 31 purchase in the alternate retirement program in accordance with this

1		subdivision. An eligible employee who consents to have that
2		employee's contribution included is entitled to have that employee's
3		contribution and employer's contribution, with interest, in the public
4		employees retirement system fund, used by the retirement board of the
5		public employees retirement system to purchase for that employee an
6		annuity in the alternate retirement program in lieu of any other rights
7		under the public employees retirement fund. However, before the
8		employer's contribution may be used for an annuity purchase, the
9		employee's combined years of service with the public employees
10		retirement system and the alternate retirement program must equal or
11		exceed the years of service necessary to be eligible for retirement
12		benefits under the public employees retirement system. An employee
13		who transferred from the public employees retirement system before
14		March 30, 1987, and who received a refund of that employee's
15		contribution is entitled to have the employer's contribution, with interest,
16		used to purchase an annuity even if that employee did not purchase an
17		annuity in the alternate employee program with the employee's
18		contribution. If an employee makes the election allowed under this
19		subdivision, that employee relinquishes all rights the employee or any
20		of the employee's beneficiaries may have had to benefits provided
21		under chapter 54-52.
22		b. The board shall provide Provide for the administration of the alternate
23		retirement program and establish rules for the program consistent with this
24		subsection. This subsection does not derogate any existing retirement
25		programs approved by the board.

- To authorize <u>Authorize</u> and encourage institutions of higher education under its
   control <u>university system entities</u> to enter into partnerships, limited liability
   companies, joint ventures, or other contractual arrangements with private business
   and industry for the purpose of business or industrial development or fostering
   basic and applied research or technology transfer.
- 129.Adopt rules promoting research, encouraging development of intellectual property13and other inventions and discoveries by university system employees, and14protecting and marketing the inventions and discoveries. The rules must govern15ownership or transfer of ownership rights and distribution of income that may be16derived from an invention or discovery resulting from research or employment in17the university system. The rules may provide for transfer of ownership rights or18distribution of income to a private, nonprofit entity created for the support of the
- 19 <u>university system or one of its institutions.</u>
- 20 SECTION 2. AMENDMENT. Section 15-11-15 of the North Dakota Century Code is 21 amended and reenacted as follows:

22 15-11-15. Tests of state mineral and other resources - Duty of state board of 23 higher education - Bulletins published. The state board of higher education shall provide at 24 the university of North Dakota suitable means for experimentation and practical testing of the 25 mineral and other allied resources of the state in order to demonstrate their fitness for mining 26 and manufacturing industries. The dean of the school of mines shall make, or cause to be 27 made, as rapidly as may be, exhaustive and practical tests of all mineral and allied resources of 28 the state. Investigations and practical tests must be made to obtain a cheap and efficient 29 method of lignite coal briquetting and to show, by actual tests, the best methods of burning 30 lignite, to determine the possibility of utilizing lignite as a gas producing material and for power 31 and lighting, to determine the value of sandstones and other stones for building material, to test

1	clays for tableware, carthenware, stoneware, sewer pipe, and other products, and to make		
2	practical tests of other resources as opportunity is afforded. Bulletins may be published from		
3	time to time by the school of mines announcing the progress and results of all tests and		
4	investigations and giving as much aid as possible relative to the best methods of mining,		
5	handling, treating, and manufacturing the various mineral products of the state. A biennial		
6	report must be issued.		
7	SECTION 3. AMENDMENT. Section 15-11-32 of the North Dakota Century Code is		
8	amended and reenacted as follows:		
9	15-11-32. Child welfare research bureau - Establishment - Director.		
10	1. A child welfare research bureau is hereby established to. The bureau must be		
11	administered and funded by and in conjunction with the university of North Dakota.		
12	2. A The university shall appoint a director must be appointed by the university. The		
13	director shall manage the bureau, hire necessary personnel, and prepare a		
14	biennial budget. The university shall fix the salaries of the director and bureau		
15	personnel, and may remove the director for cause.
