- 2 and a new subsection to section 57-38-30.3 of the North Dakota Century Code, relating to an

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1.** A new subdivision to subsection 1 of section 57-38-01.2 of the North Dakota Century Code is created and enacted as follows:

Reduced by the amount of any taxable income on the federal return which is income of an individual who is less than thirty years of age at the end of the individual's taxable year. For a husband and wife filing a joint federal income tax return, only one of whom qualifies for the reduction under this subdivision, their taxable income must be recomputed by preparing a pro forma federal return to exclude the exemption, credits, and deduction attributable only to, and the income earned only by, the spouse who is less than thirty years of age at the end of their taxable year.

**SECTION 2.** A new subsection to section 57-38-30.3 of the North Dakota Century Code is created and enacted as follows:

Federal income tax liability under this section must be reduced to zero for a resident individual who is less than thirty years of age at the end of the individual's taxable year. For a husband and wife filing a joint federal income tax return, only one of whom qualifies for the reduction under this subsection, federal income tax liability for purposes of this section must be recomputed by preparing a pro forma federal return to exclude the exemption, credits, and deductions attributable only to, and the income earned only by, the spouse who is less than thirty years of age at the end of their taxable year.
