- 1 A BILL for an Act to amend and reenact section 15-38-17 of the North Dakota Century Code or
- 2 in the alternative to amend and reenact section 15.1-13-02 and subsection 2 of section
- 3 15.1-13-29 of the North Dakota Century Code, relating to the membership of the education
- 4 standards and practices board; and to provide an effective date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. If House Bill No. 1045 does not become effective, section
 15-38-17 of the 1999 Supplement to the North Dakota Century Code is amended and
 reenacted as follows:
- 9 15-38-17. Education standards and practices board and administrator's professional practices board.
- 11 <u>1.</u> The education standards and practices board consists of nine members. The
 12 governor shall appoint four classroom teachers from public schools, one classroom
 13 teacher from a private school, one school board member, two school
 14 administrators,:
- 15 a. Three individuals who hold teaching licenses;
 - b. One individual who holds a degree in law, medicine, or engineering;
- 17 <u>c. One individual who is a business owner or manager;</u>
- 18 <u>d. Two individuals who are the parents of students enrolled in an elementary or</u>
 19 high school in this state;
- 20 e. One member of the legislative assembly; and one
- 21 f. One dean of a college of education or chairman of a department of education.
- 22 <u>2.</u> The superintendent of public instruction or the superintendent's designee shall serve as a nonvoting ex officio member.

- 3. The administrator's professional practices board consists of five members from of the education standards and practices board. The administrator's professional practices board includes the two school administrators who are members of the education standards and practices board, the one school board member who is a member of the education standards and practices board, and two teacher members who are members of and are selected by the education standards and practices board.
- 4. The term of office of members of the education standards and practices board and the administrator's professional practices board shall be three years commencing on July first of the year of the appointment.
- <u>5.</u> Vacancies must be filled for an unexpired term in the same manner as original appointments.
- 6. A person may not serve for more than two consecutive terms as a member of either board. Members of the current teachers' professional practices commission may serve out their remaining terms.

The education standards and practices board and the administrator's professional practices board shall each annually select a chairman and vice chairman, and the executive director of the education standards and practices board or the executive director's designee shall serve as secretary. Meetings of either board must be held after ten days' notice to all members at the call of the chairman or upon request in writing of a majority of either board. A majority constitutes a quorum and a majority of the quorum has authority to act upon any matter properly before either board. Each board shall adopt its own rules of order and procedure not inconsistent with sections 15-38-16 through 15-38-19 and shall hold meetings pursuant to the provisions of sections 15-38-16 through 15-38-19.

The members of each board are entitled to receive twenty-five dollars for each day actually engaged in the service of the appropriate board and must be paid actual and necessary traveling and other expenses at the same rate as for employees of the state. A member of either board may not lose the member's regular salary or the above compensation while serving on official business of the appropriate board.
