1 A BILL for an Act to create and enact a new section to chapter 35-30 and a new section to

2 chapter 35-31 of the North Dakota Century Code, relating to notices for priority of agricultural

3 processor's liens and agricultural supplier's liens; and to amend and reenact sections 35-30-01

4 and 35-31-01 of the North Dakota Century Code, relating to agricultural processor's liens and

5 agricultural supplier's liens.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7 SECTION 1. AMENDMENT. Section 35-30-01 of the 1999 Supplement to the North
8 Dakota Century Code is amended and reenacted as follows:

9 35-30-01. Agricultural processor's lien authorized. Any person who processes any 10 crop or agricultural product is entitled to a lien upon the crop or product processed for the 11 reasonable value of the services performed. A lien taken pursuant to this section upon 12 anything other than the crop or product processed is void. As used in this chapter, the term 13 "processor" includes persons threshing, combining, drying, or harvesting any crop or 14 agricultural product. The agricultural processor's lien is effective from the date the processing 15 is completed. An agricultural processor's lien filed as a security interest created by contract to 16 secure money advanced or loaned for any purpose is not effective to secure a priority over 17 liens filed under section 35-05-01. In a civil action brought under this section in which it is 18 alleged that an agricultural processor's lien is filed to secure an extension of credit for money 19 advanced or loaned for any purpose, the court shall award to the prevailing party reasonable 20 actual and statutory costs and reasonable attorneys' fees. 21 SECTION 2. A new section to chapter 35-30 of the North Dakota Century Code is

22 created and enacted as follows:

23 Notice of services provided - Requirement to secure priority.

1	<u>1.</u>	To be eligible for priority status under section 35-30-03, a processor shall deliver to	
2		a lender, which must be a person in the business of lending money and which	
3		must have a prior perfected security interest in the collateral at issue, written notice	
4		that lists the services provided which are eligible for a processor's lien. Delivery of	
5		a notice under this section must be made by certified mail, facsimile transmission,	
6		or other verifiable method. The processor shall deliver the notice to the lender	
7		within forty-five days after the services are performed.	
8	<u>2.</u>	The notice must include the:	
9		a. Name and business address of the lender receiving notification;	
10		b. Name and address of the processor claiming the lien;	
11		c. Price agreed upon for processing, or if a price is not agreed upon, the	
12		reasonable value of the processing; and	
13		d. Name and residential address of the person to whom the services were or will	
14		be furnished.	
15	<u>3.</u>	The processor shall deliver a copy of the notice to the person to whom the services	
16		were or will be furnished.	
17	<u>4.</u>	If a processor fails to give a lender notice as provided under this section, a lien on	
18		the services is not eligible for priority under section 35-30-03.	
19	SEC	CTION 3. AMENDMENT. Section 35-31-01 of the 1999 Supplement to the North	
20	Dakota Cer	ntury Code is amended and reenacted as follows:	
21	35-3	31-01. Agricultural supplier's lien authorized. Any person who furnishes	
22	supplies used in the production of crops, agricultural products, or livestock is entitled to a lien		
23	upon the crops, products produced by the use of the supplies, and livestock and their products		
24	including milk. As used in this chapter, the term "supplies" includes seed, petroleum products,		
25	fertilizer, fa	rm chemicals, insecticide, feed, hay, pasturage, veterinary services, or the	
26	furnishing c	of services in delivering or applying the supplies. An agricultural supplier's lien filed	
27	in accordance with section 35-31-02 is effective from the date the supplies are furnished or the		
28	services performed. An agricultural supplier's lien filed as a security interest created by		
29	contract to secure money advanced or loaned for any purposes is not effective to secure a		
30	priority over liens filed under section 35-05-01. In a civil action brought under this section in		
31	which it is a	alleged that an agricultural supplier's lien is filed to secure an extension of credit for

1	money advanced or loaned for any purpose, the court shall award to the prevailing party		
2	reasonable	actual and statutory costs and reasonable attorneys' fees.	
3	SEC	CTION 4. A new section to chapter 35-31 of the North Dakota Century Code is	
4	created and	l enacted as follows:	
5	Not	ice of services provided - Requirement to secure priority.	
6	<u>1.</u>	To be eligible for priority status under section 35-31-03, a supplier shall deliver to a	
7		lender, which must be a person in the business of lending money and which must	
8		have a prior perfected security interest in the collateral at issue, written notice that	
9		lists the supplies furnished and services performed which are eligible for a	
10		supplier's lien. Delivery of the notice must be made by certified mail, facsimile	
11		transmission, or other verifiable method. The supplier shall deliver the notice	
12		within forty-five days after the supplies are furnished or the services are performed.	
13	<u>2.</u>	The notice must include the:	
14		a. Name and business address of the lender receiving notification;	
15		b. Name and address of the supplier claiming the lien;	
16		c. Description of the transaction;	
17		d. Date or anticipated date of the transaction;	
18		e. Retail cost or anticipated cost of the supplies furnished and services	
19		performed; and	
20		f. Name and residential address of the person to whom the supplies and	
21		services were or will be furnished or performed.	
22	<u>3.</u>	The processor shall deliver a copy of the notice to the person to whom the supplies	
23		and services were or will be furnished or performed.	
24	<u>4.</u>	If a supplier fails to give a lender notice as provided under this section, a lien on	
25		the supplies or services is not eligible for priority under section 35-31-03.
