- 1 A BILL for an Act to create and enact a new section to chapter 50-24.1 of the North Dakota
- 2 Century Code, relating to reimbursements from medical assistance; and to amend and reenact
- 3 sections 23-27-04 and 23-27-04.1 of the North Dakota Century Code, relating to nonmedically
- 4 necessary ambulance transports.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. AMENDMENT.** Section 23-27-04 of the North Dakota Century Code is 7 amended and reenacted as follows:

- 8 23-27-04. Standards for operators.
- 9 <u>1.</u> No <u>A</u> surface ambulance service within this state may <u>not</u> be operated unless the
 10 service is licensed in accordance with this chapter and regulations promulgated by
 11 the state health council. The regulations must include, but not be limited to, the
 12 following:
- 13 <u>4.</u> <u>a.</u> Time when ambulance service shall <u>must</u> be available.
- 14 2. <u>b.</u> Type of driver's <u>motor vehicle operator's</u> license needed for drivers of <u>an</u>
 15 ambulance.
- 16 3. <u>c.</u> Training standards for <u>an</u> ambulance driver and attendant.
- 17 <u>4.</u> Equipment needs and equipment certification.
- 18 5. <u>e.</u> Annual license fees.
- 19 6. <u>f.</u> Number of personnel required for each ambulance run.
- 20 7. g. Such other Other requirements as may be found necessary to carry out the
 21 intent of this chapter.
- An officer, employee, or agent of any prehospital emergency medical service may
 refuse to transport an individual for which transport is not medically necessary and
 may recommend an alternative course of action to that individual if the prehospital

emergency medical service has developed protocols that include direct medical
 control to refuse transport of an individual.

3 SECTION 2. AMENDMENT. Section 23-27-04.1 of the 1999 Supplement to the North
4 Dakota Century Code is amended and reenacted as follows:

23-27-04.1. Emergency care or services rendered by officers, employees, or
 agents of prehospital emergency medical service - Physician medical direction. No

An officer, employee, or agent of any prehospital emergency medical service and 8 no a physician licensed in this state who provides medical direction to any 9 prehospital emergency medical service, who is a volunteer, who in good faith 10 renders emergency care, services, or medical direction, is not liable to the recipient 11 of the emergency care, services, or medical direction for any civil damages 12 resulting from any acts or omissions by the person in rendering the emergency 13 care, services, or medical direction provided the person is properly trained 14 according to law.

 2. For the purpose of this section, "volunteer" means an individual who receives no
 compensation or who is paid expenses, reasonable benefits, nominal fees, or a
 combination of expenses, reasonable benefits, and nominal fees to perform the
 services for which the individual volunteered, provided that the fees do not exceed
 twenty-four hundred dollars in any calendar year.
- 3. For volunteer physicians providing medical direction to prehospital emergency
 medical services, the twenty-four hundred dollar maximum fees amount is to be
 calculated separately for each prehospital emergency medical service for which
 the physician volunteered medical direction. This section does not relieve a
 person from liability for damages resulting from the intoxication, willful misconduct,
 or gross negligence of the person rendering the emergency care or services.
- An officer, employee, or agent of any prehospital emergency medical service and a
 physician licensed in this state who provides medical direction to any prehospital
 emergency medical service who in good faith does not render emergency care,
 service, or medical direction to an individual based on a determination that
- 30 transport of that individual to a hospital is not medically necessary is not liable to

- that individual for damages unless the damages resulted from intoxication, willful
 misconduct, or gross negligence.
- 3 SECTION 3. A new section to chapter 50-24.1 of the North Dakota Century Code is
 4 created and enacted as follows:
- 5 **Reimbursement of ambulance services.** Medical assistance coverage must include
- 6 reimbursement of ambulance services for responding to calls to assist covered individuals
- 7 which do not result in transport. The reimbursement must be at a rate negotiated by the
- 8 department and the ambulance service.
