- 1 A BILL for an Act to amend and reenact sections 45-11-01 and 47-25-01 of the North Dakota
- 2 Century Code, relating to fictitious and trade names.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 45-11-01 of the 1999 Supplement to the North
 Dakota Century Code is amended and reenacted as follows:
- 6 45-11-01. Partnership Use of fictitious partnership name.
 - 1. As used in this section, "fictitious name" means a name assumed to identify a partnership and which does not include in its name:
 - a. The true name of each organizational partner;
 - b. The first name and surname of each partner; or
 - <u>c.</u> The surname of each partner, repeating a surname if more than one partner
 <u>has the same surname.</u>
 - 2. Any partnership transacting business in this state under a fictitious name or under a designation that does not show the names of the persons interested as partners must file a fictitious name certificate with the secretary of state, together with a filing fee of twenty-five dollars. When a partnership has more than two members, an additional three dollars must be paid for each additional member not to exceed two hundred fifty dollars. A limited partnership or a foreign limited partnership transacting business under a name filed under chapter 45-10.1 and as provided in section 45-11-03 or a partnership transacting business under a name filed under section 45-13-05 is not required to file a fictitious name certificate under this section.
 - 3. The fictitious name:

1 1. May not contain the word "corporation", "company", "incorporated", "limited a. 2 liability company", or "limited", or an abbreviation of any of those words. This 3 subsection does not preclude the word "limited" from being used in 4 conjunction with the word "partnership". 5 2. May not be the same as or deceptively similar to any corporate name, limited b. 6 liability company name, trade name, partnership name on file with the 7 secretary of state, limited partnership name, foreign limited partnership name, 8 or fictitious name certificate on file with the secretary of state, unless there is 9 filed with the fictitious name certificate a written consent of the holder of the 10 similar name to use the proposed name and a filing fee of ten dollars. 11 SECTION 2. AMENDMENT. Section 47-25-01 of the North Dakota Century Code is 12 amended and reenacted as follows: 13 47-25-01. Trade name defined - Registration. Every name under which any person 14 or organization shall hereafter do or transact any business in this state, other than the true 15 name of such person or organization, is hereby declared to be a "trade name". 16 As used in this section, a "trade name" is a name assumed to identify the 1. a. 17 business or activities of an individual or organization and which does not 18 include in the name: 19 (1) The true name of the organization using the name; 20 (2) The first name and surname of each individual using the business 21 name; or 22 (3)The surname of each individual, repeating a surname if more than one 23 owner has the same surname. 24 <u>b.</u> A name assumed under paragraph 3 or a name of an organization or 25 association not otherwise registered with the secretary of state is a trade 26 name if a license or permit to conduct business or operations is required by 27 this state. 28 A person or organization that has registered a trade name hereunder under this <u>2.</u> 29 section may institute a civil suit prohibiting any other person from using such the 30 name.

 business under a trade name prior to before July 1, 1959, from continuing
 business under such that name.
- 4. Notwithstanding any other provision of law, an individual or organization may
 5 register as a trade name under section 47-25-04 any name listed in paragraph 1,
 6 2, or 3 of subdivision a of subsection 1.
