- 1 A BILL for an Act to provide for property service contracts; to amend and reenact sections
- 2 26.1-40-18 and 26.1-40-22 of the North Dakota Century Code, relating to automobile
- 3 warranties; and to repeal sections 26.1-40-19, 26.1-40-20, and 26.1-40-21 of the North Dakota
- 4 Century Code, relating to automobile warranty insurance.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6	SEC	CTION 1. Property service contracts - Exemption.
7	<u>1.</u>	The marketing, selling, offering for sale, issuing, making, providing, or proposing to
8		make and the administering of a property service contract is not subject to the
9		provisions of title 26.1.
10	<u>2.</u>	A property service contract is a contract or agreement for a separately stated
11		consideration, for a specific duration, to provide for the repair, replacement, or
12		maintenance or for the indemnification for the repair, replacement, or maintenance
13		of new or used property if an operational or structural failure is due to a defect in
14		materials, manufacturing, or normal wear and tear. Property covered under a
15		property service contract may include motor vehicles; residential appliances;
16		residential systems, including plumbing, electrical, heating, cooling, and ventilation;
17		and other residential property. The contract may provide coverage for:
18		a. Damage to property resulting from power surges;
19		b. Accidental damage to property resulting from handling; and
20		c. Payment of indemnity for incidental damages, such as food spoilage, towing,
21		and rental and emergency road service.
22	SEC	CTION 2. AMENDMENT. Section 26.1-40-18 of the North Dakota Century Code is
23	amended and reenacted as follows:

1 **26.1-40-18.** Automobile warranties construed. An automobile dealer or a third-party administrator who issues an automobile warranty issued by anyone other than the automobile 2 3 manufacturer or dealer is a contract of insurance and all warranties must be on a contract form 4 prescribed or approved by the commissioner, automobile mechanical breakdown contract, or 5 automobile service contract shall maintain a policy of insurance which provides coverage for 6 the dealer's or administrator's contractual obligation. 7 SECTION 3. AMENDMENT. Section 26.1-40-22 of the North Dakota Century Code is amended and reenacted as follows: 8 9 26.1-40-22. Penalty. Any person violating sections section 26.1-40-18 through 10 26.1-40-21 is guilty of a class A misdemeanor. 11 SECTION 4. REPEAL. Sections 26.1-40-19, 26.1-40-20, and 26.1-40-21 of the North
