1 A BILL for an Act to amend and reenact subsection 2 of section 16.1-08.1-02, subsection 1 of
2 section 16.1-08.1-03, subsection 1 of section 16.1-08.1-03.1, and subsection 3 of section
3 16.1-08.1-03.3 of the North Dakota Century Code, relating to campaign contribution statements.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Subsection 2 of section 16.1-08.1-02 of the 1999
6 Supplement to the North Dakota Century Code is amended and reenacted as follows:

7 2. The candidate shall include in the statement the name and mailing address,
8 occupation, and employer of all contributors each contributor who contributed in
9 excess of two hundred dollars in the aggregate during the reporting period to the
10 candidate, the amount of each reportable contribution, and the date each
11 reportable contribution was received.

12 **SECTION 2. AMENDMENT.** Subsection 1 of section 16.1-08.1-03 of the 1999
13 Supplement to the North Dakota Century Code is amended and reenacted as follows:

14 1. Any political party that receives contributions in excess of two hundred dollars in
15 the aggregate during the reporting period shall file a statement containing a
16 detailed list of all contributions received from a person or political committee which
17 exceed two hundred dollars in amount. The statement must include the name and
18 mailing address, occupation, and employer of all contributors each contributor
19 listed, the amount of each reportable contribution, and the date each reportable
20 contribution was received.

21 **SECTION 3. AMENDMENT.** Subsection 1 of section 16.1-08.1-03.1 of the North
22 Dakota Century Code is amended and reenacted as follows:

23 1. Any person who is soliciting or accepting a contribution for the purpose of aiding or
24 opposing the circulation or passage of a statewide initiative or referendum petition

1 or measure at any election shall file a statement in accordance with this section if
2 the person has received any contributions from a person in excess of one hundred
3 dollars. The statement must include the name and mailing address, occupation,
4 and employer of ~~all contributors~~ each contributor who contributed in excess of one
5 hundred dollars to the person, the amount of each reportable contribution, and the
6 date each reportable contribution was received.

7 **SECTION 4. AMENDMENT.** Subsection 3 of section 16.1-08.1-03.3 of the 1999
8 Supplement to the North Dakota Century Code is amended and reenacted as follows:

- 9 3. All political committees formed for the purpose of administering the segregated
10 fund provided for in this section shall file a statement showing the name and
11 mailing address, occupation, and employer of each contributor of an amount in
12 excess of two hundred dollars in the aggregate for the reporting period and a listing
13 of all expenditures of an amount in excess of two hundred dollars in the aggregate
14 made for political purposes with the secretary of state. The statement must include
15 the amount of each reportable contribution and the date it was received and the
16 amount of each reportable expenditure and the date it was made. A yearend
17 statement covering the entire calendar year must be filed no later than the
18 thirty-first day of the following year. A preelection statement must be filed no later
19 than the twelfth day before any primary, special, or general election and must be
20 complete from the beginning of the calendar year through the twentieth day before
21 the election.
