## ENGROSSED HOUSE BILL NO. 1013

(At the request of the Governor)

- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
- 2 public instruction, the school for the deaf, the school for the blind, and the state library; to
- 3 provide statements of legislative intent; to amend and reenact subsection 4 of section
- 4 15-40.1-07.8 or in the alternative to amend and reenact subsection 4 of section 15.1-27-11, and
- 5 section 15.1-02-02 of the North Dakota Century Code, relating to supplemental payments and
- 6 the salary of the superintendent of public instruction; and to declare an emergency.

#### 7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

8 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the

funds as may be necessary, are appropriated out of any moneys in the general fund in the state

treasury, not otherwise appropriated, and from special funds derived from federal funds and

other income, to the department of public instruction, the school for the deaf, the school for the

12 blind, and the state library for the purpose of defraying the expenses of their various divisions,

13 for the biennium beginning July 1, 2001, and ending June 30, 2003, as follows:

19	intent of the legislative assembly that the amount of \$20,000, or so much	of the sum as may be
20	necessary, included in the national board certification and total general for	und appropriation line
21	items in subdivision 1 of section 1 of this Act be distributed by the depart	ment of public
22	instruction to the education standards and practices board for the implem	nentation of the
23	national board certification program.	
24	SECTION 5. NATIONAL BOARD CERTIFICATION - USE OF F	UNDS
25	APPROPRIATED BY THE FIFTY-SIXTH LEGISLATIVE ASSEMBLY. N	lotwithstanding
26	section 4 of chapter 35 of the 1999 Session Laws, the education standar	ds and practices board
27	may use up to \$7,000 of the amount appropriated by the fifty-sixth legisla	ative assembly for the
28	national board certification program to provide stipends to teachers recei	ving national board
29	certification during the biennium beginning July 1, 1999, and ending June	e 30, 2001.
30	SECTION 6. LEGISLATIVE INTENT - POSITION TRANSFERS	- DIVISION OF
31	INDEPENDENT STUDY. It is the intent of the fifty-seventh legislative as	sembly that for the

- 1 biennium beginning July 1, 2001, and ending June 30, 2003, the department of public
- 2 instruction be authorized to have no more than 130.95 full-time equivalent positions and that no
- 3 more than 37.7 of these positions be allocated to the division of independent study. The
- 4 department of public instruction may not transfer any positions between the division of
- 5 independent study and other divisions of the department without first obtaining approval of the
- 6 budget section of the legislative council.

**SECTION 7. LEGISLATIVE INTENT - FULL-TIME EQUIVALENT POSITIONS.** It is the intent of the fifty-seventh legislative assembly that the department of public instruction base budget request for the biennium beginning July 1, 2003, and ending June 30, 2005, include no more than 129.95 full-time equivalent positions.

SECTION 8. LEGISLATIVE INTENT - DISTRIBUTION OF SPECIAL EDUCATION

AID. It is the intent of the legislative assembly that the amount included in the grants - special education line item in subdivision 1 of section 1 of this Act be distributed as follows:

- Twelve million six hundred sixty-five thousand dollars to reimburse school districts
  or special education units for excess costs incurred relating to contracts for
  students with disabilities.
- 2. Four hundred thousand dollars to reimburse school districts or special education units for gifted and talented programs upon the submission of an application that is approved in accordance with guidelines adopted by the superintendent of public instruction. The superintendent of public instruction shall encourage cooperative efforts for gifted and talented programs among school districts and special education units.
- 3. Any amount remaining in the line item must be distributed on a per student basis as required by section 15-40.1-07.6 or 15.1-27-10, excluding reimbursements for student contracts, boarding care, and gifted and talented programs. State special education payments distributed as required by section 15-40.1-07.6 or 15.1-27-10 must be reduced by the amount of matching funds required to be paid by school districts or special education units for students participating in the medicaid program. Special education funds equal to the amount of the matching funds required to be paid by the school district or special education unit must be paid by

1 the superintendent of public instruction to the department of human services on 2 behalf of the school district or unit. 3 SECTION 9. LEGISLATIVE INTENT - TECHNOLOGY GRANTS. It is the intent of the 4 legislative assembly that the funds appropriated in subdivision 1 of section 1 of this Act include 5 \$4,037,500 for grants to schools for technology or teacher professional development-related 6 expenditures. These grants must be administered under the direction of the educational 7 telecommunications council. 8 SECTION 10. PAYMENTS FOR LIMITED ENGLISH PROFICIENT STUDENTS. 9 Payments to school districts educating limited English proficient students, as required by 10 section 15-40.1-07.7 or 15.1-27-12, must be paid using up to \$450,000 of the amount 11 appropriated in subdivision 1 of section 1 of this Act for grants - foundation aid and 12 transportation. 13 **SECTION 11. INDIRECT COST ALLOCATION.** Notwithstanding section 54-44.1-15, 14 the department of public instruction may deposit indirect cost recoveries in its operating 15 account. 16 SECTION 12. DISPLACED HOMEMAKER FUND. The amount of \$251,747, or so 17 much of the sum as may be necessary, included in the estimated income line item in 18 subdivision 1 of section 1 of this Act is from the displaced homemaker fund for the purpose of 19 providing services for displaced homemakers as provided in chapter 14-06.1 for the biennium 20 beginning July 1, 2001, and ending June 30, 2003. SECTION 13. GRANTS. The line item entitled grants in subdivision 2 of section 1 of 21 22 this Act includes \$888,745 for aid to public libraries of which no more than one-half is to be 23 expended during the fiscal year ending June 30, 2002. 24 SECTION 14. FEES DEPOSITED IN OPERATING FUND. Any moneys included in 25 estimated income in subdivision 4 of section 1 of this Act, collected for subscription fees or 26 brailling fees, must be deposited in the school for the blind operating fund in the state treasury 27 and must be spent subject to appropriation by the legislative assembly. 28 **SECTION 15. AMENDMENT.** If House Bill No. 1045 does not become effective, 29 subsection 4 of section 15-40.1-07.8 of the 1999 Supplement to the North Dakota Century 30 Code is amended and reenacted as follows:

11	six four hundred nineteen thirty-four dollars thereafter.		
12	SEC	CTION 17. AMENDMENT. Subsection 4 of section 15.1-27-11 of the North Dakota	
13	Century Code as created by House Bill No. 1045, as approved by the fifty-seventh legislative		
14	assembly, is amended and reenacted as follows:		
15	4.	Multiply the result determined under subsection 3 by thirty percent a factor	
16		determined by the superintendent of public instruction. The result is the	
17		supplemental payment to which a high school district is entitled, in addition to any	
18		other amount provided under chapter 15.1-27.	
19	SEC	CTION 18. EMERGENCY. Sections 5, 15, and 17 of this Act are declared to be an	
20	emergency measure.
