- 2 fish department.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4	SECTION 1. APPROPRIATION.	The funds provided in this section, or so much of the

- funds as may be necessary, are appropriated out of any moneys in the game and fish fund in
- 6 the state treasury, not otherwise appropriated, and from special funds derived from federal
- 7 funds and other income, to the state game and fish department for the purpose of defraying the
- 8 expenses of the various divisions of the department, for the biennium beginning July 1, 2001,
- 9 and ending June 30, 2003, as follows:

SECTION 2. LAND HABITAT AND DEER DEPREDATION. The amount of

\$2,930,036, or such lesser amount as may be available, for the line item entitled land habitat

- 1 and deer depredation in section 1 of this Act, is from the habitat and depredation fund, to lease
- 2 privately owned lands for wildlife habitat to reestablish wildlife population, to improve wildlife
- 3 habitat on private lands, and to alleviate big game and furbearer depredation for the biennium
- 4 beginning July 1, 2001, and ending June 30, 2003. These funds may be spent only for the
- 5 purposes and using guidelines contained in sections 20.1-02-05 and 20.1-03-12.1.
- 6 **SECTION 3. NONGAME WILDLIFE.** The amount of \$75,000, or such lesser amount
- 7 as may be available, for the line item entitled nongame wildlife in section 1 of this Act, is from
- 8 the nongame wildlife fund for the purpose of preservation, inventory, perpetuation, and
- 9 conservation of nongame wildlife, natural areas, and nature preserves in this state for the
- 10 biennium beginning July 1, 2001, and ending June 30, 2003.
- 11 SECTION 4. WATERBANK PROGRAM DEPARTMENT OF AGRICULTURE. The
- amount of \$200,000, or such lesser amount as may be available, for the line item entitled
- 13 waterbank program in section 1 of this Act, is from the game and fish department operating
- 14 fund and must be used to increase water storage and enhance wildlife habitat in North Dakota.
- 15 Contracts and agreements relating to the waterbank program may be entered into by the
- 16 director of the game and fish department, in cooperation with the agriculture commissioner.
- 17 SECTION 5. WILDLIFE SERVICES DEPARTMENT OF AGRICULTURE. The
- amount of \$400,000, or such lesser amount as may be available, for the line item entitled
- 19 wildlife services in section 1 of this Act, is from the game and fish department operating fund
- 20 and must be used to alleviate wildlife depredation and damage in North Dakota. Projects
- 21 funded may include projects to alleviate waterfowl depredation and damage and must be
- 22 approved by the director of the state game and fish department. Contracts and agreements
- 23 relating to the wildlife services program may be entered into by the director of the state game
- and fish department, in cooperation with the agriculture commissioner.
- 25 **SECTION 6. PRIVATE LAND HABITAT AND ACCESS IMPROVEMENT PROGRAM.**
- 26 The amount of \$400,000 or such lesser amount as may be available, from the line item entitled
- 27 land habitat and deer depredation in section 1 of this Act, is from the additional revenue
- 28 generated by hunting license fee increases contained in House Bill No. 1468. It is the intent of
- 29 the fifty-seventh legislative assembly that these funds be spent to carry out the private land
- 30 habitat and access improvement program by providing access to private land, establishing food

- 1 plots, alleviating depredation, and enhancing habitat pursuant to subsection 19 of section
- 2 20.1-02-05, for the biennium beginning July 1, 2001, and ending June 30, 2003.
