## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5	SECTION 1. APPROPRIATION. The funds provided in t	his section, or so much of the	
6	funds as may be necessary, are appropriated out of any moneys in the general fund in the state		
7	treasury, not otherwise appropriated, and from special funds derived from federal funds and		
8	other income, to the veterans' home and the department of veterans' affairs for the purpose of		
9	defraying their expenses, for the biennium beginning July 1, 2001, and ending June 30, 2003,		
10	as follows:

4	SECTION 2. NORTH DAKOTA VETERANS' HOME - PERFORMANCE AUDIT. The		
5	state auditor shall conduct a performance audit of the veterans' home during the biennium		
6	beginning July 1, 2001, and ending June 30, 2003. The state auditor may use the services of a		
7	consultant, as needed, and the cost of such consultant may be assessed to the veterans'		
8	home. The performance audit may include a review of the contractual arrangements for		
9	physician services at the veterans' home. The results of the performance audit must be		
10	presented to the appropriations committees during the agency's budget presentation during the		
11	fifty-eighth legislative assembly.		
12	SECTION 3. LEGISLATIVE COUNCIL STUDY - VETERANS' HOME MANAGEMENT		
13	STRUCTURE AND OVERSIGHT. The legislative council shall consider studying during the		
14	2001-02 interim the management structure and oversight of the veterans' home and the		
15	selection process for the commandant or administrator of the home. The study, if conducted,		
16	may review the timing of expenditures by the veterans' home from the gene	eral fund.	
17	SECTION 4. VETERANS' POSTWAR TRUST FUND - REPORT.	The department of	
18	veterans' affairs shall report on the use of moneys in the veterans' postwar	trust fund to the	
19	appropriations committees of the fifty-eighth legislative assembly. The report must be		
20	presented during the agency's budget presentation.
