- 1 A BILL for an Act to create and enact section 26.1-36-09.11 of the North Dakota Century Code,
- 2 relating to insurance coverage for breast reconstruction surgery; and to amend and reenact
- 3 subsection 5 of section 26.1-36.3-05 and subsection 5 of section 26.1-36.4-05 of the North
- 4 Dakota Century Code, relating to renewability of health insurance coverage.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. Section 26.1-36-09.11 of the North Dakota Century Code is created and enacted as follows:
- 8 **26.1-36-09.11. Breast reconstruction surgery.** An insurance company, nonprofit
- 9 <u>health service corporation, or health maintenance organization may not deliver, issue, execute,</u>
- 10 or renew any health insurance policy, health service contract, or evidence of coverage unless
- 11 the policy, contract, or evidence of insurance provides the benefit provisions of the federal
- 12 Women's Health and Cancer Rights Act of 1998 [Pub. L. 105-277; 112 Stat. 2681-337; 42
- 13 U.S.C. 300gg-6]. This section does not apply to individually guaranteed renewable
- 14 supplemental, specified disease, long-term care, or other limited benefit policies.
- 15 **SECTION 2. AMENDMENT.** Subsection 5 of section 26.1-36.3-05 of the 1999
- 16 Supplement to the North Dakota Century Code is amended and reenacted as follows:
- 5. At the time of coverage renewal, a health insurance carrier may modify the health
- insurance coverage for a product offered to a group health plan, if for coverage that
- is available in such market other than only through one or more bona fide
- 20 associations, the modification is <u>reasonable</u>, consistent with state law and effective
- on a uniform basis among group health plans with that product. <u>If coverage is</u>
