1 A BILL for an Act to create and enact section 26.1-36-09.11 of the North Dakota Century Code,

2 relating to insurance coverage for breast reconstruction surgery; and to amend and reenact

3 subsection 5 of section 26.1-36.3-05 and subsection 5 of section 26.1-36.4-05 of the North

4 Dakota Century Code, relating to renewability of health insurance coverage.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1.** Section 26.1-36-09.11 of the North Dakota Century Code is created and 7 enacted as follows:

8 **26.1-36-09.11.** Breast reconstruction surgery. An insurance company, nonprofit 9 health service corporation, or health maintenance organization may not deliver, issue, execute, 10 or renew any health insurance policy, health service contract, or evidence of coverage on an 11 individual, group, blanket, or franchise basis unless the policy, contract, or evidence of 12 insurance provides the benefit provisions of the federal Women's Health and Cancer Rights Act 13 of 1998 [Pub. L. 105-277; 112 Stat. 2681-337; 42 U.S.C. 300gg-6]. This section does not apply 14 to individual or group supplemental, specified disease, long-term care, or other limited benefit 15 policies. 16 SECTION 2. AMENDMENT. Subsection 5 of section 26.1-36.3-05 of the 1999 17 Supplement to the North Dakota Century Code is amended and reenacted as follows: 18 5. At the time of coverage renewal, a health insurance carrier may modify the health 19 insurance coverage for a product offered to a group health plan, if for coverage 20 that is available in such market other than only through one or more bona fide 21 associations, the modification is reasonable, consistent with state law and effective 22 on a uniform basis among group health plans with that product. If coverage is 23 modified, the carrier shall:
