(At the request of the State Board of Respiratory Care)

- 1 A BILL for an Act to amend and reenact sections 43-42-01, 43-42-02, 43-42-03, 43-42-04,
- 2 43-42-05, 43-42-06, and 43-42-07 and subsection 1 of section 43-46-01 of the North Dakota
- 3 Century Code, relating to the practice of respiratory care; and to provide a penalty.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 43-42-01 of the 1999 Supplement to the North 6 Dakota Century Code is amended and reenacted as follows:
- 7 **43-42-01. Definitions.** In this chapter, unless the context otherwise requires:
- 8 1. "Board" means the state board of respiratory care.
 - "Bona fide respiratory care training program" means a program of respiratory care
 education which is accredited by the committee commission on accreditation of
 allied health educational programs, or the committee's commission's successor
 organization.
 - "Certification examination" means the <u>entry level</u> examination for respiratory therapy technicians therapists administered by the national board for respiratory care.
 - "Certified respiratory eare practitioner therapist" means a person licensed by the board to practice respiratory care under the direction or supervision of a physician or registered respiratory eare practitioner therapist.
 - "National board for respiratory care" means the body issuing credentials for the respiratory care profession, or the board's successor organization.
- 21 6. "Registered respiratory care practitioner therapist" means a person licensed by the 22 board to practice respiratory care.
- 7. "Registry examination" means the <u>advanced level</u> examination for respiratory therapists administered by the national board for respiratory care.

- 1 8. "Respiratory care" means the health specialty involving the treatment, 2 management, control, and care of patients with deficiencies and abnormalities of 3 the cardiorespiratory systems. Respiratory care is implemented on an order from a 4 licensed physician, and includes the use of medical gases, air and oxygen 5 administering apparatuses, environmental control systems, humidification and 6 aerosols, drugs and medications, apparatuses for cardiorespiratory support and 7 control, postural drainage, chest percussion and vibration and breathing exercises, 8 respiratory pulmonary rehabilitation, assistance with cardiopulmonary 9 resuscitation, maintenance of natural and mechanical artificial airways, and 10 insertion and maintenance of artificial airways. The term also includes testing 11 techniques to assist in diagnosis, monitoring, treatment, and research, including 12 the measurement of cardiorespiratory volumes, pressures and flows, and the 13 drawing and analyzing of samples of arterial, capillary, and venous blood. 14 9. "Respiratory therapist" means a certified respiratory therapist or a registered 15 respiratory therapist. 10. "Respiratory therapy" means respiratory care.

"Temporary respiratory eare practitioner therapist" means any individual who is 18 enrolled in or has successfully completed a bona fide respiratory care training 19 program and is licensed by the board to practice respiratory care under the 20 supervision or direction of either a physician, certified respiratory care practitioner 21 therapist, or registered respiratory care practitioner therapist.
 - **SECTION 2. AMENDMENT.** Section 43-42-02 of the 1999 Supplement to the North Dakota Century Code is amended and reenacted as follows:

43-42-02. State board of respiratory care.

- The state board of respiratory care is responsible for the enforcement and administration of this chapter and for the adoption of any rules necessary to govern the practice of respiratory care in this state.
- The board consists of seven members appointed by the governor. Two Four 2. members must be registered respiratory care practitioners and two members must be certified respiratory care practitioners therapists, chosen from a list of four registered eight respiratory care practitioners and four certified respiratory care

- practitioners therapists supplied to the governor by the North Dakota society for respiratory care. One member must be a physician chosen from a list of two physicians supplied to the governor by the North Dakota medical association. The governor shall appoint two members to be representatives of the general public. Members are appointed for terms of three years. Each member holds office until the member's successor is duly appointed and qualified. A vacancy in the office of any member may be filled for the unexpired term only. No member may serve more than two successive complete terms.
- The board shall annually select a chairman from among its members. The board shall meet at least twice each year and also shall meet upon the call of the chairman.
- 4. The board shall consult with the North Dakota society for respiratory care before adopting any rules.
- **SECTION 3. AMENDMENT.** Section 43-42-03 of the 1999 Supplement to the North Dakota Century Code is amended and reenacted as follows:

43-42-03. Respiratory care practitioner therapist licensing - Fees.

- 1. The board shall license as a registered respiratory eare practitioner therapist any applicant whom the board determines to be qualified to perform the duties of a registered respiratory eare practitioner therapist. In making this determination, the board shall require evidence that the applicant has successfully completed a bona fide respiratory care training program and has passed the registry examination. The board shall establish fees not in excess of fifty dollars for the issuance and renewal of a registered respiratory eare practitioner therapist license.
- 2. The board shall license as a certified respiratory eare practitioner therapist any applicant whom the board determines to be qualified to perform the duties of a certified respiratory eare practitioner therapist. In making this determination, the board shall require evidence that the applicant has successfully completed a bona fide respiratory care training program and has passed the certification examination. The board shall establish fees not in excess of thirty five dollars for the issuance and renewal of a certified respiratory eare practitioner therapist license.

1 The board shall license as a temporary respiratory care practitioner therapist any 2 applicant whom the board determines to be qualified to perform duties as a 3 temporary respiratory eare practitioner therapist. In making this determination, the 4 board shall require evidence that the applicant is enrolled in or has successfully 5 completed a bona fide respiratory care training program. The board shall establish 6 fees not in excess of thirty five dollars for the issuance and renewal of a temporary 7 respiratory care practitioner therapist license. 8 4. The board may assess a late fee for all license renewal applications that are 9 postmarked after December thirty-first of the year prior to the year of renewal. 10 The board shall refuse to license any applicant or shall suspend or revoke any <u>5.</u> 11 license after proper notice and a hearing, if the applicant: 12 a. Is not qualified or competent to perform the duties of a registered respiratory 13 eare practitioner therapist, a certified respiratory eare practitioner therapist, or 14 a temporary respiratory care practitioner therapist. Has attempted to obtain or has obtained licensure under this chapter by fraud 15 b. 16 or material misrepresentation. 17 Has been found guilty by the board of gross negligence to have been grossly C. 18 <u>negligent</u> as a registered respiratory care practitioner therapist, certified 19 respiratory care practitioner therapist, or a temporary respiratory care 20 practitioner therapist. 21 d. Has engaged in conduct as a registered respiratory care practitioner 22 therapist, certified respiratory eare practitioner therapist, or a temporary 23 respiratory care practitioner therapist which is unethical, unprofessional, or 24 detrimental to the benefit health of the public. 25 Has failed to demonstrate satisfactory completion of such continuing courses e. 26 of study in respiratory care as the board may require. 27 f. Has been convicted or adjudged guilty of an offense, as defined by section 28 12.1-01-04, determined by the board to have a direct bearing upon that

individual's ability to practice respiratory care and is not sufficiently

rehabilitated as determined by the board in accordance with section

- g. Is habitually drunk or is addicted to the use of a controlled substance as defined in chapter 19-03.1.

 h. Has been declared mentally incompetent by a court of competent jurisdiction, and who has not thereafter been lawfully declared competent.
 - 6. The board may impose a fee on any person subject to regulation under this chapter to reimburse the board for all or part of the costs of administrative actions resulting in disciplinary action, including the amount paid by the board for services from the office of administrative hearings, attorney's fees, court costs, witness fees, staff time, and other expenses.
 - 5. 7. Licenses issued under this chapter expire annually, but may be renewed upon application to the board and payment of the annual renewal fee established by the board. Licenses which have expired, been suspended, or been revoked may be renewed or reissued upon satisfaction of any conditions that may be established by the board, and after payment of a fee established by the board. Temporary licenses may not be renewed.
 - 6. 8. The board shall require as a condition of renewal and relicensure that the applicant demonstrate satisfactory completion of continuing courses of study in respiratory care.
 - **SECTION 4. AMENDMENT.** Section 43-42-04 of the North Dakota Century Code is amended and reenacted as follows:
 - 43-42-04. Respiratory care practice. The practice of respiratory care may be performed in hospitals, as ambulatory or in-home care, and in other settings where respiratory care is provided in accordance with a prescription of a licensed physician. In addition, respiratory care may be provided during the transportation of a patient, and under any circumstances where an epidemic or public disaster necessitates respiratory care. No person may practice, nor represent oneself as able to practice, as a registered respiratory eare practitioner therapist without being licensed as a registered respiratory eare practitioner therapist, or as a certified respiratory eare practitioner therapist, in accordance with this chapter.
 - **SECTION 5. AMENDMENT.** Section 43-42-05 of the 1999 Supplement to the North Dakota Century Code is amended and reenacted as follows:

43-42-05. Application of chapter.

- 1. This chapter does not prohibit a person enrolled in a bona fide respiratory care training program from performing those duties essential for completion of a student's clinical service; provided, that the duties are performed under the supervision or direction of a physician or registered respiratory eare practitioner therapist and the person is identified as a "student respiratory eare practitioner therapist".
- 2. A graduate of a bona fide respiratory care training program, who has applied for licensure under this chapter may practice respiratory care under the supervision or direction of a physician or a registered or certified respiratory eare practitioner therapist; provided, that the graduate holds a temporary respiratory eare practitioner's therapist's license and is identified as a "graduate respiratory eare practitioner therapist". An applicant shall take one of the next three immediately available entry level certification examinations examination within six months following eligibility. Failure to pass any examination that is taken results in termination of the privileges provided under this subsection.
- If examinations prepared by the national board for respiratory care are no longer available or become unacceptable to the board, the board may develop, approve, and use examinations for the licensure of registered respiratory eare practitioners therapists and certified respiratory eare practitioners therapists.
- 4. This chapter does not prevent a licensed and qualified member of another health care profession from performing any of the duties of a registered respiratory eare practitioner therapist or a certified respiratory eare practitioner therapist that are consistent with the accepted standards of that person's profession, provided the person is not represented as a registered respiratory eare practitioner therapist or certified respiratory eare practitioner therapist.
- 5. This chapter does not prohibit self-care by a patient or the gratuitous care by a friend or member of the family who does not represent or hold oneself out to be a registered or certified respiratory care practitioner therapist.

9	chapter, and upon payment of the annual license fee.

11	amended and reenacted as follows:
