- 1 A BILL for an Act to create and enact two new sections to chapter 54-59 of the North Dakota
- 2 Century Code, relating to the establishment, powers, and duties of an educational technology
- 3 council; to amend and reenact sections 15-19-02 and 15-19-06, subsection 1 of section
- 4 15.1-02-07, subdivision h of subsection 2 of section 28-32-01, and subsection 1 of section
- 5 54-07-01.2 of the North Dakota Century Code, relating to the administration of the division of
- 6 independent study and the appointment of members of the educational telecommunications
- 7 council; to repeal chapter 15.1-05 of the North Dakota Century Code, relating to the educational
- 8 telecommunications council; and to provide for a transfer of funds.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 10 SECTION 1. AMENDMENT. Section 15-19-02 of the North Dakota Century Code is amended and reenacted as follows:
- 12 15-19-02. Administration - Director of division of independent study -
- 13 Appointment and duties. The program of and all activities related to the division of
- 14 independent study are the responsibility of and under the supervision of the superintendent of
- 15 public instruction educational technology council. The educational technology council shall hire
- 16 a state director of the division of independent study must be appointed by the superintendent of
- 17 public instruction who must be classified under the state personnel merit system. The director,
- 18 under the supervision of the superintendent of public instruction shall carry out the director's
- 19 responsibilities in the administration of the division of independent study in the manner
- 20 approved by the state board of public school education. The board shall determine the
- 21 director's qualifications and fix his compensation within limits of legislative appropriations. The
- 22 director is responsible to and must carry out all policies and directives of the state board of
- 23 public school education in the administration of the program of the division of independent
- 24 study.

SECTION 2. AMENDMENT. Section 15-19-06 of the North Dakota Century Code is amended and reenacted as follows:

15-19-06. Special funds - Deposit of collections - Transfers from general fund appropriations.

- 1. A special operating fund for the division of independent study must be maintained within the state treasury and all income and fees collected by the division of independent study from any source must be remitted monthly by the director to the state treasurer and credited to such the special operating fund. All expenditures from such the fund must be within the limits of legislative appropriations and must be made upon vouchers, signed and approved by the superintendent of public instruction technology director appointed by the educational technology council. Upon approval of such the vouchers by the office of the budget, warrant-checks must be prepared by the office of management and budget. The state treasurer shall make periodic transfers upon order of the director of the office of management and budget from the division of independent study general fund appropriation to such the special operating fund whenever its balance falls so low as to require supplementation.
 - The superintendent of public instruction educational technology council may establish an administrative operational fund, of not to exceed ten thousand dollars, out of the special operating fund for the division of independent study. The administrative operational fund must be deposited in the Bank of North Dakota and may be drawn upon by the state director of the division of independent study for the payment of necessary expenses in the administration and operation of the division of independent study within the limits and rules prescribed by the superintendent of public instruction educational technology council. The director shall submit a full, minute, and itemized statement of every expenditure made during the month to the superintendent of public instruction council in accordance with the rules adopted by the superintendent of public instruction council may periodically authorize additional transfers to the administrative operational fund, but the balance in such the fund may never exceed ten thousand dollars, and any

- 1 unencumbered balance therein at the end of any biennium must revert to the state 2 treasury. The administrative operational fund may not be used to pay salaries or 3 expenses of the director. The superintendent of public instruction council shall 4 determine the amount of the bond to be posted by the director. 5 3. The state board of public school education may establish a scholarship fund to 6 provide financial grants to students enrolled in courses offered through the division 7 of independent study. The scholarship fund may consist only of those funds 8 specifically appropriated by the legislative assembly and property received by the 9 board or the division of independent study as a gift, devise, or beguest. Any gift, 10 devise, or bequest of property received by the board or division of independent 11 study which is designated by the board and donor for the scholarship fund must be 12 deposited in the scholarship fund at the Bank of North Dakota. The state director 13 of the division of independent study may draw only on the interest earned by the 14 scholarship fund for the award of scholarships within the limits and rules adopted 15 by the state board of public school education. The interest earned by the 16 scholarship fund is hereby appropriated to the division of independent study. 17 Repealed by S.L. 1989, ch. 199, § 4. 18 **SECTION 3. AMENDMENT.** Subsection 1 of section 15.1-02-07 of the 1999 19 Supplement to the North Dakota Century Code is amended and reenacted as follows: 20 1. The superintendent of public instruction may lease surplus portions of real 21 property, including buildings and improvements, owned by the state and 22 administered by the superintendent of public instruction at the school for the blind, 23 and the school for the deaf, and the division of independent study. 24 SECTION 4. 29	SECTION 7. A new section to chapter 54-59 of the North Dakota Century Code is						
30	created and enacted as follows:						

1	<u>Nor</u>	th Dakota educational technology council - Powers and duties. The			
2	educational technology council shall:				
3	<u>1.</u>	Coordinate the use of technology and the development of technology systems to			
4		enhance educational opportunities for elementary and secondary education.			
5	<u>2.</u>	Cooperate with state agencies and other organizations to develop statewide			
6		educational technology systems.			
7	<u>3.</u>	Adopt bylaws for the conduct of its affairs.			
8	<u>4.</u>	Publish the informational material it deems necessary.			
9	<u>5.</u>	Conduct a continuing study to assess the needs, resources, and facilities that are			
10		available or which may be required to establish educational technology systems			
11		throughout the state.			
12	<u>6.</u>	Solicit and receive moneys from public and private sources and expend the			
13		moneys for educational technology.			
14	<u>7.</u>	Appoint a technology director who shall serve at the will of the council.			
15	<u>8.</u>	Hire the director of the division of independent study.			
16	SECTION 8. REPEAL. Chapter 15.1-05 of the North Dakota Century Code is				
17	repealed.				
18	8 SECTION 9. TRANSFER OF FUNDS. Any funds appropriated by the fifty-seventh				
19	9 legislative assembly to or for the purposes of the division of independent study, SENDIT				
20	technology services, and the center for innovation in instruction must be transferred to the				
21	information technology department for use by the educational technology council on the				
22	effective date of this Act.
