PROPOSED AMENDMENTS TO SENATE BILL NO. 2332

Page 1, line 1, after "A BILL" replace the remainder of the bill with "for an Act to amend and reenact sections 16.1-08.1-02 and 16.1-08.1-03 of the North Dakota Century Code, relating to the reporting of expenditures made for political purposes by candidates and political parties.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 16.1-08.1-02 of the 1999 Supplement to the North Dakota Century Code is amended and reenacted as follows:

16.1-08.1-02. Contributions <u>and expenditures</u> statement required of candidates.

- 1. Any candidate who is soliciting or accepting contributions <u>or making</u> <u>expenditures</u> for any political purpose shall make and file a statement in accordance with this section.
- 2. The candidate shall include in the statement the name and mailing address of all contributors who contributed in excess of two hundred dollars in the aggregate during the reporting period to the candidate, the amount of each reportable contribution, and the date each reportable contribution was received. The statement must also include a listing of the total amount of expenditures made for political purposes during the reporting period and identify to whom any expenditure in excess of two hundred dollars was made for political purposes during the reporting period.
- 3. The candidate shall file the statement in the office of the secretary of state no later than the twelfth day before the date of the election in which the candidate's name appears on the ballot or in which the candidate seeks election through write-in votes complete from the beginning of that calendar year through the twentieth day before the date of the election. The candidate shall file a complete statement for the entire calendar year no later than the thirty-first day of January of the following year, regardless of whether the candidate's name appeared on the ballot for any office during that calendar year or whether the candidate did not seek election at any election through write-in votes.
- 4. Even if the candidate has not received any contributions <u>or made any</u> <u>expenditures for political purposes</u> in excess of two hundred dollars during the reporting period, the candidate shall file a statement as required by this chapter.

SECTION 2. AMENDMENT. Section 16.1-08.1-03 of the 1999 Supplement to the North Dakota Century Code is amended and reenacted as follows:

16.1-08.1-03. Contributions <u>and expenditures</u> statement required of political parties.

1. Any political party that receives contributions <u>or makes expenditures for</u> <u>political purposes</u> in excess of two hundred dollars in the aggregate during the reporting period shall <u>make and</u> file a statement containing <u>in</u> <u>accordance with this section</u>. The statement <u>must include</u> a detailed list of all contributions received from a person or political committee which exceed two hundred dollars in amount. The statement must include the name and mailing address of all contributors listed, the amount of each reportable contribution, and the date each reportable contribution was received. The statement must also include a listing of the total amount of expenditures made for political purposes during the reporting period and identify to whom any expenditure in excess of two hundred dollars was made for political purposes during the reporting period.

- 2. A yearend statement covering the entire calendar year must be filed with the secretary of state no later than the thirty-first day of January of the following year. A preelection statement must be filed no later than the twelfth day before any election at which the party has endorsed or will nominate a candidate and must be complete from the beginning of that calendar year through the twentieth day before the election.
- 3. Even if the political party has not received any contributions <u>or made any</u> <u>expenditures for political purposes</u> in excess of two hundred dollars during the reporting period, the political party shall file a statement as required by this chapter."
