- 1 A BILL for an Act to amend and reenact section 15-40.2-12 and subsection 1 of section
- 2 57-15-14.2 of the North Dakota Century Code or in the alternative to amend and reenact
- 3 section 15.1-29-15 of the North Dakota Century Code, relating to the levy of property taxes for
- 4 tuition charges and transportation; and to provide an effective date.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 SECTION 1. AMENDMENT. If House Bill No. 1045 does not become effective, section 7 15-40.2-12 of the North Dakota Century Code is amended and reenacted as follows:
- 8 **15-40.2-12.** Levy for tuition charges permitted. The school board of any school 9 district approving the payment of tuition charges for resident students in grades seven through 10 twelve or required to make tuition payments under this chapter may levy an amount pursuant to 11 subdivision c of subsection 1 of section 57-15-14.2 sufficient to pay tuition charges.
 - SECTION 2. AMENDMENT. Section 15.1-29-15 of the North Dakota Century Code as created by House Bill No. 1045, as approved by the fifty-seventh legislative assembly, is amended and reenacted as follows:
 - **15.1-29-15.** Levy for tuition payments. If the board of a school district approves tuition payments for resident students in grades seven through twelve or if the board is required to make tuition payments under this chapter, the board may levy an amount sufficient to meet such payments, pursuant to subdivision c of subsection 1 of section 57-15-14.2.
