- 2 section 45-10.1-09, subsection 1 of section 45-10.1-14, subsection 1 of section 45-10.1-52,
- 3 subsection 3 of section 45-22-03, and subsection 1 of section 45-22-21.1 of the North Dakota
- 4 Century Code, relating to reporting requirements for limited partnerships and limited liability
