ENGROSSED HOUSE CONCURRENT RESOLUTION NO. 3021

1	A concurrent resolution expressing appreciation for passage of the Dakota Water Resources
2	Act and urging Congress to fully fund the federal share of the water projects in that Act.
3	WHEREAS, North Dakota and its Indian tribes lost more than 500,000 acres of valuable
4	river bottom lands as a result of construction of the Missouri River reservoirs under the federal
5	Flood Control Act of 1944, causing an annual loss of millions of dollars in economic activity as
6	well as other serious impacts to individuals, political subdivisions, and the state's Indian
7	Nations; and
8	WHEREAS, operation of the Pick-Sloan Missouri River dams has caused extensive
9	damage and erosion to the remaining riverbanks and sediment buildup in areas of the upper
10	reaches of the Oahe and Garrison reservoirs; and
11	WHEREAS, North Dakota was assured by Congress in the federal Flood Control Act of
12	1944 that the loss of this valuable land and economic return would be offset by completion of
13	the Garrison Diversion Unit; and
14	WHEREAS, project beneficiaries have not realized the promise of the Garrison
15	Diversion Unit; and
16	WHEREAS, construction of the Garrison Diversion Unit has been delayed numerous
17	times with construction costs increasing and the remaining benefits deferred with each delay;
18	and
19	WHEREAS, primary sources of water for many communities across North Dakota,
20	including on its Indian reservations, are unsafe and of poor quality and a safe, reliable supply of
21	water is necessary to preserve and improve the quality of life in rural North Dakota, and
22	projects such as the Southwest Water Pipeline Project, the Northwest Area Water Supply
23	Project, and other systems now being developed are needed to meet water supply needs; and
24	WHEREAS, failure to provide long-term water supply and management across North
25	Dakota will jeopardize future economic opportunities dependent on water, including industry,

•	agricultural processing, manufacturing, municipal growth, recreation, and fish and withine, and
2	that failure will adversely affect the entire state; and
3	WHEREAS, the Red River Basin needs a dependable supply of water for the cities of
4	Fargo and Grand Forks, smaller communities, rural water systems, industry, agricultural
5	processing, manufacturing, and other purposes, and to protect and enhance the economic
6	stability and quality of life for the growing population of the Red River Basin; and
7	WHEREAS, the Dakota Water Resources Act proposes an objective analysis of the
8	best ways to meet those needs and authorizes federal funding to implement the solution; and
9	WHEREAS, the Dakota Water Resources Act provides immediate funding authority for
10	the Native American and rural areas of the state through the existing municipal, rural, and
11	industrial grant program; and
12	WHEREAS, under the Dakota Water Resources Act, the state of North Dakota will be
13	required to provide cost share or repayment and operation and maintenance expenses for
14	delivery of water to the Red River Valley;
15	NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
16	OF NORTH DAKOTA, THE SENATE CONCURRING THEREIN:
17	That the Fifty-seventh Legislative Assembly expresses appreciation for passage of the
18	Dakota Water Resources Act and urges the Congress of the United States to fully fund the
19	federal share of the water projects in that Act; and
20	BE IT FURTHER RESOLVED, that the Secretary of State forward copies of this
21	resolution to the Governor, the Secretary of the Interior, the chairman of the Three Affiliated
22	Tribes, the chairman of the Standing Rock Sioux Tribe, and each member of the North Dakota
23	Congressional Delegation.
