| 5 | WHEREAS, grain industry consolidations, such as that involving Cargill, Incorporated, |
| 6 | and Continental Grain Company, have left a single entity controlling more than 40 percent of all |
| 7 | United States corn exports, 33 percent of all soybean exports, and at least 20 percent of all |
| 8 | wheat exports; and |
| 9 | WHEREAS, meat industry mergers have left the three largest meatpackers, IBP, |
| 10 | Cargill's Excel Corporation, and ConAgra's Monfort, controlling almost 80 percent of the cattle |
| 11 | slaughter market; and |
| 12 | WHEREAS, IBP, which has over \$14 billion in annual sales, is now set to merge with |
| 13 | Tyson Foods, Incorporated; and |
| 14 | WHEREAS, after the proposed merger, Tyson Foods, Incorporated, will have annual |
| 15 | sales in excess of \$23 billion; and |
| 16 | WHEREAS, the proposed merger of Tyson Foods, Incorporated, and IBP will create a |
| 17 | company that has a major global presence with unparalleled ability to develop innovative food |
| 18 | products and market them successfully through international distribution channels; and |
| 19 | WHEREAS, consolidation in the meatpacking and grain industries allows for a reduction |
| 20 | in prices paid to producers and an increase in the prices required of consumers; and |
| 21 | WHEREAS, consolidation in the meatpacking and grain industries leads to extensive |
| 22 | scale economies and the replacement of small high-cost operations with larger and more |
| 23 | efficient ones; and |
| 24 | WHEREAS, all producers and consumers need to understand the effects that |

anticompetitive practices have on their lives;
