- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the highway patrol;

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4	SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the	
5	funds as may be necessary, are appropriated out of any moneys in the general fund in the state	
6	treasury, not otherwise appropriated, and from special funds derived from federal funds and	
7	other income, to the highway patrol for the purpose of defraying its expenses, for the biennium	
8	beginning July 1, 2001, and ending June 30, 2003, as follows:	
9	Administration	\$2,164,675
10	Field operations	30,095,704
11	Law enforcement training academy	982,723
12	Total all funds	\$33,243,102
13	Less estimated income	13,629,443

SECTION 2. SPECIAL FUNDS TRANSFER. The less estimated income line item in section 1 of this Act includes the sum of \$6,200,000, or so much of the sum as may be necessary, from the state highway fund which may be transferred at the direction of the superintendent of the highway patrol for the purpose of defraying the expenses of the highway patrol during the biennium beginning July 1, 2001, and ending June 30, 2003.

SECTION 3. PAYMENTS TO HIGHWAY PATROL OFFICERS. Each patrol officer of the state highway patrol is entitled to receive from funds appropriated in section 1 of this Act an amount not to exceed \$170 per month for the biennium beginning July 1, 2001, and ending June 30, 2003. The payments are in lieu of reimbursement for meals and other expenses, except lodging, while in travel status within the state of North Dakota or while at their respective

- 1 home stations. The amounts must be paid without the presentation of receipts or other
- 2 memorandums at the time and in the same manner as salaries of members of the highway
- 3 patrol are paid.
- 4 SECTION 4. LEGISLATIVE INTENT PERFORMANCE MEASURE MONITORING. It
- 5 is the intent of the legislative assembly that the highway patrol monitor its actual to planned
- 6 expenditures and its actual to projected performance measures by program for the biennium
- 7 beginning July 1, 2001, and ending June 30, 2003. The highway patrol shall make this
- 8 information available as requested by the appropriations committees of the fifty-eighth
- 9 legislative assembly.
