- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the children's
- 2 services coordinating committee; and to provide a statement of legislative intent.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated from special funds derived from federal funds and other income to the children's services coordinating committee for the purpose of defraying the expenses of the children's services coordinating committee, for the biennium beginning July 1, 2001, and ending June 30, 2003, as follows:

9 Salaries and wages \$75,549

10 Operating expenses 65,901

11 Grants 7,680,361

12 Total all funds \$7,821,811

13 SECTION 2. GRANTS - BUDGET SECTION APPROVAL. Of the \$7,680,361

14 appropriated in the grants line item in section 1 of this Act, the children's services coordinating

15 committee shall provide grants of \$600,000 to the department of human services for the

partnership project that is providing services to children with serious emotional disorders in the

eight human service centers, \$200,000 to the department of human services for the Native

18 American alcohol and drug abuse education program, and \$50,000 to the sacred child project

19 during the biennium beginning July 1, 2001, and ending June 30, 2003. Any other statewide

grants distributed by the committee, unless specifically approved by the legislative assembly,

21 are subject to budget section approval.

SECTION 3. ADDITIONAL INCOME - EMERGENCY COMMISSION APPROVAL. All income of the children's services coordinating committee in excess of the estimated income line item appropriated in section 1 of this Act is appropriated to the children's services coordinating

2 spent only upon authorization of the emergency commission. 3 SECTION 4. LEGISLATIVE INTENT - FUNCTION OF REGIONAL AND TRIBAL 4 CHILDREN'S SERVICES COORDINATING COMMITTEES. It is the intent of the legislative 5 assembly that each regional and tribal children's services coordinating committee function as a 6 regional planning committee to monitor and coordinate children's services in each region and 7 that the regional and tribal children's services coordinating committees not directly provide 8 services or programs. 9 SECTION 5. REFINANCING FUND ALLOCATIONS.
