6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7	SECTION 1. PROJECT	AUTHORIZATIONS.	The industrial commission, acting as the	
8	North Dakota building authority, shall arrange for the funding of the projects authorized in this			
9	section, hereby declared to be in the public interest, through the issuance of evidences of			
10	indebtedness under chapter 54-17.2, during the biennium beginning July 1, 2001, and ending			
11	June 30, 2003. The proceeds of the evidences of indebtedness and other available funds are			
12	hereby appropriated during the biennium beginning July 1, 2001, and ending June 30, 2003, for			
13	the following projects:

The industrial commission shall issue evidences of indebtedness under this section with the condition that lease rental payments need not begin until July 1, 2003. This authority of the industrial commission to issue evidences of indebtedness ends June 30, 2003, but the industrial commission may continue to exercise all other powers granted to it under chapter 54-17.2 and this Act and to comply with any covenants entered into before that date.

23 **SECTION 2. BOND ISSUANCE REPAYMENT RESPONSIBILITY.** Of the total amount 24 of evidences of indebtedness issued under the provisions of section 1 of this Act, a total of

- 2 evidences of indebtedness issued for the project costs associated with the construction of the
- 3 projects authorized by this Act:

SECTION 3. STATE FACILITY ENERGY IMPROVEMENT PROJECT

7 **AUTHORIZATIONS.** The industrial commission, acting as the North Dakota building authority,

- 8 shall arrange for the funding of the projects authorized in this section, which are described in
- 9 the report filed by the division of community services of the office of management and budget
- 10 with the governor, dated August 30, 2000, and which are hereby declared to be in the public
- 11 interest, through the issuance of evidences of indebtedness under chapter 54-17.2 and section
- 12 54-44.5-08, during the biennium beginning July 1, 2001, and ending June 30, 2003. The
- 13 proceeds of the evidences of indebtedness and other available funds are hereby appropriated
- 14 during the biennium beginning July 1, 2001, and ending June 30, 2003, for the following
- 15 projects:
