4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 4-34-01 of the 1999 Supplement to the North 6 Dakota Century Code is amended and reenacted as follows:
- 7 **4-34-01. Purposes.** The purposes of this chapter are:
 - To provide and participate in programs to increase the consumption of domestic beef through such means as advertising, research, consumer information, industry information, sales promotion, and education, but at no time may false or unwarranted claims be made on behalf of the beef industry.
 - To support beef promotion, research, and education activities of the national beef promotion and marketing organizations with not less than fifty percent of the assessments collected.
 - To initiate, encourage, and sponsor research designed to solve problems in the beef industry.
- 17 4. To enhance the sale and production of North Dakota beef cattle.
- 18 **SECTION 2. AMENDMENT.** Section 4-34-03 of the 1999 Supplement to the North 19 Dakota Century Code is amended and reenacted as follows:
- 20 4-34-03. North Dakota beef commission Appointments Vacancies -
- 21 Qualifications.
 - 1. There is hereby created a North Dakota beef commission consisting of nine members who must be appointed by the governor. The commission must be composed of three beef producers, one cattle feeder, one dairy producer, one

1 public livestock market representative, and three representatives at large. The 2 commission may also appoint up to two nonvoting ex officio members. 3 Three initial members must be appointed for one year; three members must be 4 appointed for two years; and three members must be appointed for three years. 5 All subsequent members must be appointed for three years unless the 6 appointment is to fill a vacancy in which case such appointment must be for the 7 unexpired term. No members may serve more than two successive three-year 8 terms. In the event a position on the commission becomes vacant for any reason, 9 the unexpired term of such position must be filled in the same mode and manner 10 as the original appointments. 11 <u>3.</u> Each member must be: 12 <u>a.</u> Be a United States citizen and a resident of this state, must be or have been; 13 <u>b.</u> Be actually engaged in that phase of the cattle industry the member 14 represents; 15 Have been actually engaged in that phase of the cattle industry for a period of <u>C.</u> 16 five years; and must have 17 Have during that period derived a substantial portion of the member's income d. 18 therefrom.
