**ENGROSSED HOUSE BILL NO. 1114**

(At the request of the Department of Human Services)

1 A BILL for an Act to authorize the department of human services to convey certain land in  
2 Stutsman County, North Dakota, to the city of Jamestown; and to declare an emergency.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. Transfer of land authorized.** The department of human services may  
5 convey the land described in subsection 1 to the city of Jamestown, North Dakota, for the price  
6 and on the terms as determined by the department of human services and may convey the land  
7 described in subsection 2 to the city of Jamestown, North Dakota, for two hundred dollars per  
8 acre or the most recent appraised value, whichever is higher. The land to be conveyed is a  
9 part of the grounds of the state hospital described as follows:

10 1. A tract of land located within the SW 1/4 of Section 1, Township 139 North,  
11 Range 64 West of the Fifth Principal Meridian, Stutsman County, North Dakota,  
12 being more particularly described as follows:  
13 Commencing at the southwest corner of said Section 1; thence S90 degrees  
14 00'00"E, along the south line of the SW 1/4 of said Section 1, 75.00 feet to the  
15 point of beginning; thence N0 degrees 27'26"W, parallel with the west line of  
16 the SW 1/4 of said Section 1, 1,204.23 feet to a point on the south line of an  
17 existing parcel; thence N89 degrees 50'00"E, along the south line of said  
18 existing parcel, 44.60 feet; thence N1 degrees 42'11"E, along the easterly line  
19 of said existing parcel, 1,003.47 feet to a point on the southerly right-of-way  
20 line of Interstate Highway 94; thence southeasterly, along a 5 degrees 00'00"  
21 spiral right-of-way curve, said curve having a chord bearing of S72 degrees  
22 51'18"E and a chord length of 81.38 feet, a spiral length of 81.38 feet to the  
23 beginning of a circular right-of-way curve, said curve having a chord bearing  
24 of S82 degrees 10'15"E and a chord length of 900.88 feet; thence along said

- 1 circular right-of-way curve an arc length of 904.21 feet; thence S2 degrees  
2 09'28"W, 2062.12 feet to a point on the south line of the SW 1/4 of said  
3 Section 1; thence N90 degrees 00'00"W, along the south line of the SW 1/4 of  
4 said Section 1, 957.43 feet to the point of beginning.  
5 Bearings for the above description are based on an assumed bearing of N90  
6 degrees 00'00"W along the south line of said Section 1. Said tract contains  
7 47.37 acres more or less.
- 8 2. A tract of land located within the NE 1/4 of Section 1, Township 139 North,  
9 Range 64 West of the Fifth Principal Meridian, Stutsman County, North Dakota,  
10 being more particularly described as follows:  
11 Commencing at a point 1,710 feet south of the Northwest corner of the NE  
12 1/4 of Section 1, Township 139 North, Range 64 West, to the point of  
13 beginning; thence East 600 feet; thence North 480 feet; thence West 600  
14 feet; thence South 480 feet to the point of beginning, all of said lines running  
15 parallel to the section lines.
- 16 3. Sections 54-01-05.2 and 54-01-05.5 do not apply to the transfer of the land  
17 described in subsection 2.
- 18 **SECTION 2. EMERGENCY.** This Act is declared to be an emergency measure.
