# REMARKS OF MISS AMERICA, ANGELA PEREZ BARAQUIO Character in the Classroom: Teaching Values, Valuing Teachers

Incidents like the Columbine school massacre and other acts of violence by youth have led to increased discussion about the role teachers play in developing their students' core ethics and values. It is widely agreed that teachers, more than any other adults besides parents, directly influence the character attributes youngsters develop. Through formal instruction, coaching and everyday behavior, teachers communicate and pass on their own traits and ethics to children.

From parents to teachers to school administrators to elected officials, everyone agrees that a renewed emphasis on character education is urgently needed to support the ethical, social and academic development of our youth. Children are dying every day from drug overdoses, violence and suicides because they have fewer and fewer decent role models to influence them. Schools can help by paying greater attention to establishing the caring environment that our children need.

In addition to improving our focus on providing students with character education, we must also increase the value we place on teachers who are at the forefront of helping our children succeed. Communities need to place greater emphasis on the workplace conditions teachers face. Many of our schools are in need of basic building repairs or renovations. At the same time, 22 percent of all new teachers leave the profession within three years not only because they can't **afford** to teach anymore, but because the rewards don't outweigh the challenges they face. If predictions hold true, by 2010 our nation's classrooms will suffer from a shortage of up to one million teachers.

As an educator myself, I'm well aware of the challenges my colleagues face. They are all too often undervalued, unappreciated and inadequately compensated. Many times they are forced to reach into their own pockets for much-needed supplies and teaching tools. Despite their sacrifices, when the character of one of their students comes into question, teachers may shoulder unnecessary blame. If America's teachers are to be responsible for teaching our children to become honorable people, then America's teachers need to be treated like honorable people.

Despite the severity of these problems, they can be overcome. We must correct the errors of our past and actively support teachers in providing character education. We must make our communities places where teachers are valued first, not last. We must correct the inequity in pay scales where, according to American Federation of Teachers' figures, new teachers earn approximately 40 percent less than the entry-level salaries for engineers and computer scientists. And we must provide teachers with adequate resources - in the classroom, the lab and the gymnasium. Correcting these problems rests not only with administrators and legislators. Every American is responsible for demonstrating value for the role teachers play in shaping our country's future generations.

As Miss America 2001, I will dedicate my efforts to communicating the importance of teaching values **while** valuing teachers.

Throughout the coming months, I will champion three core principles. First, I will work to see that every educational institution adopts or creates a formal, quality initiative that infuses character development into its daily school culture and curriculum. Second, I will encourage schools to consider the various character education options that exist so each can customize its efforts to meet the unique needs of its own students. Third, I will serve as a prominent voice for all teachers in their fight to achieve quality compensation for quality education. Beyond the financial aspects of teachers' compensation, they must also receive other support such as appropriate resources for their classrooms, professional development opportunities and respect.

Specifically, I will speak both as Miss America and as a professional educator, shining our Organization's spotlight on these important messages:

I will represent the interests of the character development movement in America, while standing on behalf of my fellow teachers to draw attention to the critical role they play in the lives of our nation's youth;

I will reach out to students, encouraging them to open their minds and hearts to the messages of good character:

I will encourage parents to value their children by valuing their children's teachers. I will especially ask those parents who can effect change in their communities to do so; and

I will challenge education administrators, government officials, civic leaders, business people and other concerned individuals to transform rhetoric into action by joining together in support of character education - and the teachers who are responsible for it - within local schools and throughout their communities.

All of these promises are based on a single goal: When I complete my year as Miss America and resume my career as a professional educator, teaching values and valuing teachers will have greater significance for hundreds of thousands of deserving men and women who comprise the ranks of America's teachers. In my dual roles as Miss America and a teacher, I will help young people develop a greater understanding of and access to positive character development. My ultimate hope is that our children will someday **feel** the impact of our collective efforts today.

Except as otherwise provided in sections 20.1-03-07.2 and 20.1-03-07.3 and this section, a nonresident may not hunt waterfowl unless that person first obtains a nonresident waterfowl hunting license, in addition to a nonresident small game hunting license. The nonresident waterfowl hunting license entitles the nonresident to hunt waterfowl for any period of fourteen consecutive days, any period of seven consecutive days, or any two periods of seven consecutive days each. A license authorizing the fourteen-day hunting period allows hunting in a specified waterfowl hunting zone.A license authorizing one 7 day hunting period allows hunting statewide. A license authorizing two 7-day hunting periods allows hunting in a specified zone during each period. The governor, in the governor's proclamation, shall specify various waterfowl hunting zones for which nonresident waterfowl hunting licenses will be available, and may specify the number of licenses which may be issued in each zone and the manner in which they are to be issued. A nonresident all season waterfowl hunting license allows hunting in zone 1. A combination nonresident all season waterfowl and nonresident small game hunting license allows hunting in zone 1. A nonresident who purchases a nonresident all season waterfowl hunting license is not required to purchase a nonresident small game hunting license and the combination nonresident all season waterfowl and nonresident small game hunting license entitles the nonresident to hunt waterfowl in zone 1 and upland game statewide. Zones and the maximum number of licenses that may be issued in each zone are:
  - Zone 1 that portion of the state north of a line described as follows: North Dakota highway 200 beginning at the Minnesota border, thence west to its intersection with United States highway 52, thence northwest along United States highway 52 to its intersection with United States highway 2, thence west along United States highway 2 to the Montana border - up to sixteen thousand licenses.
  - 2. Zone 2 that portion of the state south of North Dakota highway 200 and east of United States highway 281 up to two thousand licenses.
  - 3. Zone 3 the remainder of the state up to four thousand licenses.

The governor, in the governor's proclamation, may specify the number and the manner in which licenses are to be issued. The governor shall make fifteen percent of the nonresident waterfowl hunting licenses in any zone available to certified guides licensed in this state until July first of each year. Any licenses designated for certified guides remaining after July first of each year must be made available to nonresidents. A nonresident is entitled to purchase only one nonresident waterfowl hunting license per year.

**SECTION 2.** Two new subsections to section 20.1-03-12 of the 1999 Supplement to the North Dakota Century Code are created and enacted as follows:

For a nonresident all season waterfowl hunting license, one hundred thirty dollars.

For a combination nonresident all season waterfowl and nonresident small game hunting license, one hundred seventy dollars.

WHEREAS, the state of North Dakota and the Indian tribes along the Missouri River sacrificed a total of 550,000 acres of land for the Pick-Sloan Project, including prime bottomlands and farmland along the Missouri River; lost homes and farmhouses; more than 2,000 jobs; personal income of more than \$45 million per year; business income of more than \$100 million per year; entire communities including the capitals of the Indian reservations; infrastructure, including hospitals, churches, cemeteries, schools, transportation networks, and water and sewer systems; local industry, including a saw mill, grain elevators, and feedlots; and in the case of the Indian tribes, a majority of their ancestral homelands; and

WHEREAS, in an attempt to mitigate a portion of the losses occurring because of the Pick-Sloan Project in South Dakota, pursuant to the Water Resources Development Acts of 1999 and 2000, the Congress of the United States directed the Secretary of the Army to transfer to the Department of Game, Fish and Parks of the state of South Dakota land located above the top of the exclusive flood pool of the Oahe, Big Bend, Fort Randall, and Gavins Point Projects of the Pick-Sloan Missouri River Basin program, acquired by the Secretary of the Interior for the implementation of the Pick-Sloan Missouri River Basin program, located outside the external boundaries of a reservation of an Indian tribe, and located within the state of South Dakota and further directed the Secretary of the Army to transfer to the Secretary of the Interior land located above the top of the exclusive flood pool of the Big Bend and Oahe Projects of the Pick-Sloan Missouri River Basin program acquired by the Secretary of the Army for the implementation of the Pick-Sloan Missouri River Basin program and located within the internal boundaries of the reservation of the Cheyenne River Sioux Tribe and the Lower Brule Sioux Tribe for the use of the Indian tribes in perpetuity; and

**WHEREAS**, the Water Resources Development Acts of 1999 and 2000 are controversial for a number of reasons, and, if applied to the state of North Dakota, do not completely meet the needs of the state or the affected Indian tribes; and

WHEREAS, in considering similar legislation that may apply to the state of North Dakota and the Indian tribes along the Missouri River in this state, the Congress of the United States should ensure that the interests of all persons and entities, including the affected Indian tribes, in lands and resources on those lands that are adjacent to Lake Sakakawea and Lake Oahe be protected, including, the protection of the interests of the state of North Dakota and Indian tribes, and the wildlife, recreational, and cultural and historic resources of those lands:

# NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF NORTH DAKOTA, THE SENATE CONCURRING THEREIN:
