Reengrossed HB 1223 allows leased property to qualify for the geothermal, solar, or wind energy tax credit, and alters the credit to be 3% of the cost of acquisition and installation per year for five years.

For each \$1,000,000 wind tower installed in ND, the property owner or leasor would receive a tax credit equal to \$30,000 or their income tax liability, whichever is less, for the first five years of operation. The baseline forecast does not specifically include the building of large-scale wind-powered electrical generating facilities in the next beinnium. It is unknown whether a developer of such a facility would incur an income tax liability sufficient to utilize all or part of this credit.
