1 A BILL for an Act to provide for redistricting of the legislative assembly and to authorize the

2 secretary of state to modify election deadlines and procedures; to create and enact a new

3 section to chapter 54-03 of the North Dakota Century Code, relating to legislative redistricting;

4 to amend and reenact sections 54-03-01.5, 54-03-01.8, and 54-03-01.10 of the North Dakota

5 Century Code, relating to legislative redistricting and terms of senators and representatives; to

6 repeal section 54-03-01.9 of the North Dakota Century Code, relating to legislative redistricting;

7 to provide a statement of legislative intent; and to provide an effective date.

8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

9 SECTION 1. AMENDMENT. Section 54-03-01.5 of the 2001 Supplement to the North 10 Dakota Century Code is amended and reenacted as follows:

11

54-03-01.5. Legislative apportionment redistricting requirements. A legislative 12 apportionment redistricting plan based on any census taken after 1989 1999 must meet the 13 following requirements:

- 14 1. The senate must consist of forty-nine forty-seven members and the house must 15 consist of ninety-eight ninety-four members.
- 16 2. Except as provided in subsection 3, one senator and two representatives must be 17 apportioned to each senatorial district. Representatives may be elected at large or 18 from subdistricts.
- 19 3. Multimember senate districts providing for two senators and four representatives 20 are authorized only when a proposed single member senatorial district includes a 21 federal facility or federal installation, containing over two-thirds of the population of 22 the proposed single member senatorial district.
- 23 4. Legislative districts and subdistricts must be compact and of contiguous territory.

1	5. Legislative districts must be as nearly equal in population as is practicable.
2	Population deviation from district to district must be kept at a minimum. The total
3	population variance of all districts, and subdistricts if created, from the average
4	district population may not exceed recognized constitutional limitations.
5	SECTION 2. AMENDMENT. Section 54-03-01.8 of the 2001 Supplement to the North
6	Dakota Century Code is amended and reenacted as follows:
7	54-03-01.8. Staggering of the terms of senators. A senator from an even-numbered
8	odd-numbered district must be elected in 1992 2002 for a term of four years and a senator from
9	an odd-numbered even-numbered district must be elected in 1994 2004 for a term of four
10	years. The senator from district forty one must be elected in 1992 for a term of two years. A
11	senator from a an even-numbered district in which there is another incumbent senator as a
12	result of legislative redistricting must be elected in 1992 2002 for a term of four two years.
13	Based on that requirement, districts six, ten, fourteen, twenty-eight, and thirty-six must elect
14	senators in 1992.; based on this requirement, district twenty must elect a senator in 2002. A
15	senator from an odd-numbered district in which there is another incumbent senator must be
16	elected in 2002 for a term of four years; based on this requirement, districts twenty-seven and
17	thirty-one must elect senators in 2002. The term of a senator from an even-numbered district
18	who is placed in an odd-numbered district as a result of legislative redistricting expires as of
19	December 1, 2002; based on this requirement, the term of the senator elected in district twelve
20	in 2000 expires as of December 1, 2002, and district twenty-three must elect a senator in 2002.
21	The senator from district twelve must be elected in 2002 for a term of two years.
22	SECTION 3. AMENDMENT. Section 54-03-01.10 of the 2001 Supplement to the North
23	Dakota Century Code is amended and reenacted as follows:
24	54-03-01.10. Staggering of terms of representatives. The term of office of a
25	representative is four years, except a. A representative from an even-numbered
26	odd-numbered district must be elected in 1998 2002 for a term of two four years and a
27	representative from an even-numbered district must be elected in 2004 for a term of four years.
28	A representative from an even-numbered district in which there are more than two incumbent
29	representatives as a result of legislative redistricting must be elected in 2002 for a term of two
30	years; based on this requirement, districts twenty and twenty-eight must elect two
31	representatives in 2002. A representative from an odd-numbered district in which there are

1	more than	two incumbent representatives as a result of legislative redistricting must be elected
2	<u>in 2002 for</u>	a term of four years; based on this requirement, districts twenty-three, thirty-one,
3	and thirty-tl	hree must elect representatives in 2002. An even-numbered district in which there is
4	only one in	cumbent representative elected from that district in 2000 must elect one
5	representat	tive in 2002 for a term of two years; based on this requirement, district twenty-four
6	must elect	a representative in 2002. The representatives from district twelve must be elected in
7	2002 for a t	term of two years.
8	SE	CTION 4. A new section to chapter 54-03 of the North Dakota Century Code is
9	created and	d enacted as follows:
10	Leg	gislative redistricting. Each legislative district is entitled to one senator and two
11	representat	tives. The legislative districts of the state are formed as follows:
12	<u>1.</u>	District 1 consists of that part of the city of Williston and that part of Williston
13		Township in Williams County bound by a line commencing at the point where the
14		centerline of thirty-second avenue intersects the centerline of United States
15		highway 2, thence south on thirty-second avenue to the shoreline of Lake
16		Sakakawea, thence east on the shoreline of Lake Sakakawea until its intersection
17		with the west boundary of Stony Creek Township, thence north on a straight line
18		until its intersection with the centerline of broadway, thence east on broadway until
19		its intersection with the city limit as the city limit turns north, thence north and west
20		on the city limit until its intersection with the west boundary of Stony Creek
21		Township, thence north on the west boundary of Stony Creek Township until its
22		intersection with the southeast corner of Missouri Ridge Township, thence west on
23		the south boundary of Missouri Ridge Township until its intersection with the
24		centerline of United States highway 2, thence south on United States highway 2
25		until its intersection with the centerline of forty-second street, thence west on
26		forty-second street and continuing west on fifty-third street until its intersection with
27		the centerline of one hundred thirty-eighth avenue, thence south on one hundred
28		thirty-eighth avenue to the point of beginning.
29	<u>2.</u>	District 2 consists of all of Burke County and Divide County; all of Williams County
30		except that portion contained in District 1; and Bicker, Powers Lake, Powers,

1		Lostwood, White Earth, Sorkness, Cottonwood, James Hill, Myrtle, Manitou, Ross,
2		and Idaho townships in Mountrail County.
3	<u>3.</u>	District 3 consists of Sundre and Surrey townships in Ward County; and that part
4		of the city of Minot and that part of Nedrose Township in Ward County bound by a
5		line commencing at the intersection of the centerline of nineteenth avenue and the
6		centerline of north broadway, thence south on broadway until its intersection with
7		the centerline of burdick expressway, thence east on burdick expressway until its
8		intersection with the centerline of third street, thence south on third street until its
9		intersection with the centerline of eleventh avenue southeast, thence east on
10		eleventh avenue southeast until its intersection with the centerline of hiawatha
11		street, thence south on hiawatha street until its intersection with the centerline of
12		sixteenth avenue southeast, thence east on sixteenth avenue southeast until its
13		intersection with the centerline of thirteenth street southeast, thence south on
14		thirteenth street southeast until its intersection with the south boundary of Nedrose

24		airport road until its intersection with the centerline of nineteenth avenue, thence
25		west on nineteenth avenue to the point of beginning.
26	<u>4.</u>	District 4 consists of all of Mountrail County except that portion contained in
27		District 2; Burt, Rolling Green, Lund, Linton, Vang, Torning, Freedom, Willis, New
28		Prairie, Sawyer, Orlien, Anna, Rice Lake, Hilton, Gasman, Newman, Brillian,
29		Hiddenwood, Ryder, Cameron, Spring Lake, Rushville, lota Flat, and Greely
30		townships in Ward County; those portions of McKenzie County and Mercer County
31		within the Fort Berthold reservation; that part of Dunn County within the Fort

- Berthold reservation; and Halliday unorganized township in Dunn County including
 the cities of Dodge, Dunn Center, and Halliday; and all of McLean County except
 that portion contained in District 8.

5		County.
6	<u>7.</u>	District 7 consists of all of McHenry County, Pierce County, and Sheridan County;
7		and Pleasant Lake, Knox, York, Leeds, Irvine, Iowa, Twin Lake, Beaver, Lake
8		Ibsen, Normania, Impark, Broe, Butte Valley, McClellan, Riggin, Albert, and Eldon
9		townships in Benson County.
10	<u>8.</u>	District 8 consists of Andrews, Otis, Butte, Dogden, Greatstone, Horseshoe Valley,
11		Aurena, Byersville, Snow, Malcolm, Medicine Hill, Wise, Lake Williams, Turtle
12		Lake, Victoria, Longfellow, and Mercer townships in McLean County; south
13		McLean unorganized township in McLean County including the city of Washburn;
14		all of the city of Wilton in McLean County and Burleigh County; Underwood
15		unorganized township including the cities of Riverdale and Underwood in McLean
16		County; east McLean unorganized township in McLean County; Painted Woods,
17		Glenview, Naughton, and Gibbs townships in Burleigh County; and that part of
18		Burnt Creek-Riverview unorganized township, Hay Creek Township, and Apple
19		Creek Township in Burleigh County and the city of Bismarck bound by a line
20		commencing at the intersection of the centerline of United States highway 83 and

22		on United States highway 83 until its intersection with the centerline of interstate

26		its intersection with the centerline of fifty-second street, thence south on
27		fifty-second street until its intersection with the centerline of apple creek road,
28		thence east on apple creek road until its intersection with the east boundary of
29		Apple Creek Township, thence north on the east boundary of Apple Creek
30		Township, the east boundary of Gibbs Township, and the east boundary of
31		Naughton Township to the northeast corner of Naughton Township, thence west

1		on the north boundary of Naughton Township and Burnt Creek-Riverview
2		unorganized township to the point of beginning.
3	<u>9.</u>	District 9 consists of Rolette County.
4	<u>10.</u>	District 10 consists of Cavalier County; all of Towner County except that portion
5		contained in District 15; and all of Pembina County except that portion contained in
6		District 16.
7	<u>11.</u>	District 11 consists of that part of the city of Fargo in Cass County bound by a line
8		commencing at the intersection of an extended line from the centerline of eleventh
9		avenue south and the centerline of the Red River, thence west on eleventh avenue
10		south until its intersection with the centerline of United States highway 81, thence
11		north on United States highway 81 until its intersection with the centerline of ninth
12		avenue south, thence west on ninth avenue south until its intersection with the
13		centerline of Cass County drain number three, thence north along Cass County
14		drain number three until its intersection with the centerline of sixth avenue south,
15		thence west on sixth avenue south until its intersection with the centerline of
16		twenty-fifth street, thence north on twenty-fifth street until its intersection with the
17		centerline of fifth avenue south, thence west on fifth avenue south and an
18		extended straight line until its intersection with the centerline of interstate
19		highway 29, thence south on interstate highway 29 until its intersection with the
20		centerline of thirteenth avenue south, thence east on thirteenth avenue south until
21		its intersection with the centerline of thirty-fourth street, thence south on
22		thirty-fourth street until its intersection with the centerline of fifteenth avenue south,

1		Fargo and the city of West Fargo in Cass County bound by a line commencing at
2		the intersection of an extended straight line of the centerline of fifty-second avenue
3		south and the centerline of the Red River, thence west on fifty-second avenue
4		south until its intersection with the centerline of United States highway 81, thence
5		south on United States highway 81 until its intersection with the centerline of
6		sixty-fourth avenue south, thence west on sixty-fourth avenue south until its
7		intersection with the centerline of Cass County drain number fifty-three, thence
8		north on Cass County drain number fifty-three until its intersection with the
9		centerline of fifty-second avenue south, thence west on fifty-second avenue south
10		until its intersection with the centerline of interstate highway 29, thence north on
11		interstate highway 29 until its intersection with the centerline of an extended
12		straight line from seventeenth avenue south, thence east on that line and
13		seventeenth avenue south until its intersection with the centerline of thirty-fifth
14		street, thence north on thirty-fifth street until its intersection with the centerline of
15		fifteenth avenue south, thence east on fifteenth avenue south until its intersection

30		West Fargo in Cass County bound by a line commencing at the intersection of the
31		centerline of main avenue and the centerline of seventeenth street, thence west on

1		main avenue until its intersection with the centerline of center street, also known as
2		state highway 294, thence north on center street until its intersection with the
3		centerline of twelfth avenue north, thence west on twelfth avenue north and
4		thirty-sixth avenue until its intersection with the centerline of thirty-eighth street,
5		thence south on thirty-eighth street until its intersection with the centerline of
6		thirty-eighth avenue, thence east and south on thirty-eighth avenue following
7		township roads until its intersection with the east boundary of Mapleton Township,
8		thence south on a straight line following the east boundary of Mapleton Township
9		until its intersection with the southwest corner of Barnes Township, thence east on
10		the south boundary of Barnes Township until its intersection with fifty-seventh
11		street, thence north on fifty-seventh street and an extended straight line until its
12		intersection with the centerline of interstate highway 94, thence east on interstate

14		limit, thence north following the city limit and seventeenth street to the point of
15		beginning.
16	<u>14.</u>	District 14 consists of all of Wells County and Kidder County; Esmond, Isabel, Rich
17		Valley, Hesper, East Fork, and Arne townships in Benson County; and all of
18		Burleigh County except those portions contained in Districts 8, 30, 32, 35, and 47.
19	<u>15.</u>	District 15 consists of all of Ramsey County; and Atkins, Bethel, Cando, Coolin,
20		Maza, Olson, Springfield, and Zion townships in Towner County.
21	<u>16.</u>	District 16 consists of Walsh County; and Drayton, Lincoln, and Midland townships
22		in Pembina County.
23	<u>17.</u>	District 17 consists of all of Brenna Township in Grand Forks County; and that part
24		of Grand Forks Township and that part of the city of Grand Forks in Grand Forks
25		County bound by a line commencing at the intersection of an extended straight line
26		of the centerline of lanark avenue and the centerline of the Red River, thence
27		southwest on lanark avenue until its intersection with the centerline of lincoln drive,
28		thence west on lincoln drive and eighth avenue south until the intersection of the
29		centerline of eighth avenue south and the centerline of belmont road, thence south
30		on belmont road until its intersection with the centerline of tenth avenue south,
31		thence west on tenth avenue south until its intersection with the centerline of

1		washington street, thence south on washington street until its intersection with the
2		centerline of thirty-second avenue south, thence west on thirty-second avenue
3		south until its intersection with the centerline of forty-second street, thence north
4		on forty-second street until its intersection with the centerline of the burlington
5		northern santa fe railway right of way, thence west on the burlington northern santa
6		fe railway right of way until its intersection with the centerline of fifty-fifth street,
7		thence north on fifty-fifth street until its intersection with the centerline of gateway
8		drive, thence west on gateway drive and United States highway 2 until its
9		intersection with the northwest corner of Brenna Township, thence south on the
10		west boundary of Brenna Township to the southwest corner of Brenna Township,
11		thence east on the south boundary of Brenna Township and the south boundary of
12		Grand Forks Township to the centerline of the Red River, thence north on the Red
13		River to the point of beginning.
14	<u>18.</u>	District 18 consists of Blooming, Falconer, and Rye townships in Grand Forks
15		County; and that portion of the city of Grand Forks and Mekinock Township in
16		Grand Forks County bound by a line commencing at the intersection of an
17		extended straight line of the centerline of lanark avenue and the centerline of the
18		Red River, thence southwest on lanark avenue until its intersection with the
19		centerline of lincoln drive, thence west on lincoln drive and eighth avenue south
20		until the intersection of the centerline of eighth avenue south and the centerline of
21		belmont road, thence south on belmont road until its intersection with the
22		centerline of tenth avenue south, thence west on tenth avenue south until its
23		intersection with the centerline of washington street, thence south on washington
24		street until its intersection with the centerline of library circle, thence west and
25		northwest on library circle until its intersection with the centerline of twentieth
26		avenue south, thence west on twentieth avenue south until its intersection with the
27		centerline of twentieth street, thence north on twentieth street and an extended
28		straight line until its intersection with the centerline of the burlington northern
29		santa fe railway right of way, thence east on the burlington northern santa fe
30		railway right of way until its intersection with the centerline of washington street,
31		thence north on washington street until its intersection with the centerline of sixth

1		avenue north, thence west on sixth avenue north until its intersection with the
2		centerline of twentieth street, thence north on twentieth street until its intersection
3		with the centerline of gateway drive, thence west on gateway drive and United
4		States highway 2 until its intersection with the south entrance of the Grand Forks
5		air force base, known as eielson street, thence north on eielson street until its
6		intersection with the centerline of seventh avenue, thence east on seventh avenue
7		until the extended centerline of seventh avenue intersects with the centerline of
8		j street, thence south on j street until its intersection with the centerline of juniper
9		avenue, thence east on juniper avenue until its extended centerline intersects the
10		west boundary of Blooming Township, thence north on the west boundary of
11		Blooming Township to the northwest corner of Blooming Township, thence east on
12		the north boundary of Blooming Township, Rye Township, and Falconer Township
13		to the centerline of the Red River, thence south on the Red River to the point of
14		beginning.
15	<u>19.</u>	District 19 consists of all of Grand Forks County except those portions contained in
16		Districts 17, 18, 20, 42, and 43.
17	<u>20.</u>	District 20 consists of all of Steele County and Traill County; all of the city of
18		Reynolds in Grand Forks County and Traill County; and Pierce, Lake Town,
19		Dazey, Sibley Trail, Baldwin, Ellsbury, Uxbridge, Edna, Rogers, Ashtabula, Grand
20		Prairie, Minnie Lake, Brimer, Anderson, Stewart, Getchell, Noltimier, Weimer, Alta,
21		Oriska, Eckelson, Hobart, and Potter townships in Barnes County.
22	<u>21.</u>	District 21 consists of that part of the city of Fargo and that part of the city of West
23		Fargo in Cass County bound by a line commencing at the intersection of an
24		extended line from the centerline of eleventh avenue south and the centerline of
25		the Red River, thence west on eleventh avenue south until its intersection with the
26		centerline of United States highway 81, thence north on United States highway 81
27		until its intersection with the centerline of ninth avenue south, thence west on ninth
28		avenue south until its intersection with the centerline of Cass County drain number
29		three, thence north on Cass County drain number three until its intersection with
30		the centerline of sixth avenue south, thence west on sixth avenue south until its
31		intersection with the centerline of twenty-fifth street, thence north on twenty-fifth

1		street until its intersection with the centerline of fifth avenue south, thence west on
2		fifth avenue south and an extended straight line until its intersection with the

15	<u>23.</u>	District 23 consists of all of Eddy County, Griggs County, and Nelson County; and
16		all of Benson County except those portions contained in Districts 7 and 14.
17	<u>24.</u>	District 24 consists of all of Barnes County except that portion contained in
18		District 20; that part of the city of Enderlin in Ransom County; and Fort Ransom,
19		Moore, Northland, Preston, Liberty, Springer, Tuller, Casey, Hanson, Elliott, Island
20		Park, Big Bend, Isley, Alleghany, and Bale townships in Ransom County.
21	<u>25.</u>	District 25 consists of Walcott, Eagle, Colfax, Abercrombie, Ibsen, Dwight,
22		Mooreton, Center, Brandenburg, Summit, Waldo, De Villo, Fairmount, Greendale,
23		and LaMars townships in Richland County and the city of Hankinson in Richland
24		County.

District 47 consists of that part of the city of Bismarck and that part of Hay Creek 25 Township and Burnt Creek-Riverview unorganized township bound by a line 26 commencing at the intersection of the centerline of interstate highway 94 and the 27 centerline of the Missouri River, thence east on interstate highway 94 until its 28 intersection with the centerline of divide avenue, thence south and east on divide 29 avenue until its intersection with the centerline of fourth street, thence north on 30 fourth street until its intersection with the centerline of interstate highway 94, 31 thence east on interstate highway 94 until its intersection with the centerline of

United States highway 83, thence north on United States highway 83 until its
intersection with the north boundary of Burnt Creek-Riverview unorganized
township, thence west on the north boundary of Burnt Creek-Riverview
unorganized township until its intersection with the centerline of the Missouri River,
thence south on the Missouri River to the point of beginning.
SECTION 5. REPEAL. Section 54-03-01.9 of the North Dakota Century Code is
repealed.
SECTION 6. SECRETARY OF STATE TO MODIFY ELECTION DEADLINES AND
PROCEDURES. If, as a result of a delay in implementation of this Act, it becomes necessary
to modify election deadlines and procedures for the conduct of the 2002 primary election, the
secretary of state, in consultation with city and county election officials, shall adopt modified
election deadlines and procedures to allow the conduct of the 2002 primary election as
scheduled. The modified deadlines and procedures may address filing and publishing
deadlines and any other matters necessary to accommodate the conduct of the primary
election.
SECTION 7. LEGISLATIVE INTENT - BOUNDARIES. It is the intent of the legislative
assembly that although this Act is effective on December 7, 2001, the members of the
legislative assembly elected under the redistricting plan effective on December 6, 2001, shall
continue to serve until implementation of this Act. Any reference in the legislative district
descriptions to a city limit or the Fort Berthold reservation boundary as a boundary line refers to
the limit or boundary as it existed on January 1, 2000, as shown on the 2000 census maps. A
legislative district boundary using the Fort Berthold reservation or city limit lines does not
migrate as the Fort Berthold reservation boundary or city limits migrate. For purposes of
legislative district descriptions, unless cities are otherwise specifically named, townships

- 25 encompass all the territory within their outer boundaries.

SECTION 8. EFFECTIVE DATE. This Act becomes effective on December 7, 2001.
