- 1 A BILL for an Act to amend and reenact sections 57-15-12 and 57-15-12.2 of the North Dakota
- 2 Century Code, relating to park district general fund levy limitations and an excess levy for a
- 3 comprehensive health care program for district employees; and to provide an effective date.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 57-15-12 of the North Dakota Century Code is 6 amended and reenacted as follows:
- 7 **57-15-12. General fund levy limitations in park districts.** The aggregate amount
- 8 levied for park district general fund purposes, exclusive of levies to pay interest on bonded debt
- 9 and levies to pay and discharge the principal thereof, and levies to pay the principal and interest
- 10 on special assessments assessed and levied against park board properties by other
- 11 municipalities, may not exceed the sum of the number of mills levied by the park district in
- 12 taxable year 2000 for the general fund under section 57-15-12 including any additional levy
- 13 approved by the electors, the insurance reserve fund under section 32-12.1-08, the employee
- 14 health care program under section 40-49-12, the public recreation system under section
- 15 40-55-09 including any additional levy approved by the electors, forestry purposes under
- 16 section 57-15-12.1 except any additional levy approved by the electors, pest control under
- 17 section 4-33-11, and handicapped person programs and activities under section 57-15-60. A
- 18 park district may increase its general fund levy under this section to any number of mills
- 19 approved by a majority of the electors of the park district voting on the question at a regular or
- 20 special park district election, up to a maximum levy under this section of thirty-five thirty-four
- 21 mills on the dollar of the taxable valuation of the district for the current year.
- 22 **SECTION 2. AMENDMENT.** Section 57-15-12.2 of the North Dakota Century Code is
- 23 amended and reenacted as follows:

1 57-15-12.2. Exceptions to tax levy limitations for park districts. The general fund levy limitations specified in section 57-15-12 do not apply to the following levies in a park 2 3 district: 4 1. Levying a tax for an employees' pension fund according to sections 40-49-21 and 5 40-49-22 and a park district may levy a tax not exceeding the amount necessary 6 for the district's annual contribution to the employees' pension fund. 7 2. Levying an additional tax approved by the electors providing for forestry activities in 8 accordance with section 57-15-12.1 in an amount not exceeding three mills. 9 3. Levying a tax for parks and recreational facilities in accordance with section 10 57-15-12.3 in an amount not exceeding five mills. 11 <u>4.</u> A park district levying a tax for a comprehensive health care program for district 12 employees in accordance with section 40-49-12 may levy a tax not exceeding two 13 mills. 14 **SECTION 3. EFFECTIVE DATE.** This Act is effective for taxable years beginning after 15 December 31, 2002.
