- 1 A BILL for an Act to amend and reenact sections 39-08-09 and 39-08-10 of the North Dakota
- 2 Century Code, relating to a notice of accident to law enforcement.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 39-08-09 of the North Dakota Century Code is
amended and reenacted as follows:

- 6 **39-08-09.** Immediate notice of accident Penalty.
- 7 The driver of a vehicle involved in an accident resulting in injury to or death of any 1. 8 person, or property damage to an apparent extent of at least one thousand dollars, 9 shall immediately give notice of the accident to the local police department if the 10 accident occurs within a municipality, otherwise to the office of the county sheriff or 11 the state highway patrol. This duty to notify does not apply to a driver of a vehicle 12 involved in an accident with a deer, unless the collision results in injury to or death 13 of any person. Any person who violates this section must be assessed a fine of 14 fifty dollars. The name of the motor vehicle insurance policy carrier and the policy 15 number of the driver, or if the driver is not the owner of the vehicle, then the motor 16 vehicle insurance policy carrier and the policy number of the owner of the vehicle, 17 must be furnished to the law enforcement officer investigating the accident or 18 furnished in the driver's written report to the director for an accident involving a 19 collision with a deer resulting in damage to no property other than the vehicle as 20 required under section 39-08-10. If the driver does not have the required 21 information concerning insurance to furnish to the investigating law enforcement 22 officer, then within five days of the accident the driver shall supply that information 23 to the driver's license division in the form the division requires.
