BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA: 4

- SECTION 1. Medical assistance buy-in program for disabled. The department of human services shall establish and implement a buy-in program to provide medical assistance to an individual who meets the definition of disabled under the supplemental security income program under title XVI of the federal Social Security Act, who is at least eighteen but less than sixty-five years of age, and who is gainfully employed a minimum of forty hours per month. The program must:
 - Be made available to an individual with a disability who is a member of a family the 1. total annual income of which is less than two hundred fifty percent of the most recently revised official poverty line published by the federal office of management and budget for the family;
 - 2. Provide for an asset limit of three thousand dollars with an additional asset limit of ten thousand dollars if the additional asset limit is earned while an eligible individual is enrolled in the program;
 - Require the payment of a premium that is based upon a sliding scale which may 3. not be less than two and one-half percent nor more than seven and one-half percent of the individual's income;
- 21 4. Include a one-time program enrollment fee of one hundred dollars;
- 22 5. Provide for the same medical review requirements that are required under the 23 federal Ticket to Work and Work Incentives Improvement Act of 1999 [42 U.S.C. 1320b-19];
