- 1 A BILL for an Act to create and enact a new section to chapter 25-03.1 of the North Dakota
- 2 Century Code, relating to interstate contracts for the treatment of individuals with mental illness
- 3 or chemical dependency.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** A new section to chapter 25-03.1 of the North Dakota Century Code is 6 created and enacted as follows:

7 Interstate contracts for treatment of mental illness or chemical dependency.

- For purposes of this section, "bordering state" means Minnesota, Montana, or
 South Dakota.
- 10 2. Unless prohibited by another law and subject to the exceptions in subsection 3, the 11 department may contract with any appropriate treatment facility in a bordering state 12 for the treatment of mental illness or chemical dependency for residents of North 13 Dakota. The department may also contract with any public or private agency or 14 facility to provide treatment of mental illness or chemical dependency in North 15 Dakota to residents of a bordering state. An individual who receives treatment for 16 mental illness or chemical dependency in another state under this section is 17 subject to the laws of the state in which treatment is provided. An individual who 18 receives treatment in another state under this section must be informed of the 19 consequences of receiving treatment in another state, including the implications of 20 the differences in state laws.
- 21 3. A contract may not be entered under this section for treatment to individuals who:
 - a. Are serving a sentence after conviction of a criminal offense;
- 23 b. Are on probation or parole;

The department may enter negotiations with appropriate personnel of a bordering 16 state to develop an agreement that conforms to the requirements of this section. 17 An agreement with a bordering state must enable the placement in North Dakota of 18 individuals who are on emergency holds or who have been involuntarily committed 19 as mentally ill or chemically dependent in a bordering state and enable the 20 temporary placement in a bordering state of patients who are on emergency holds 21 in North Dakota under chapter 25-03.1. An agreement with a bordering state must 22 also provide that the North Dakota courts retain jurisdiction over North Dakota 23 residents, and that the bordering state affords to North Dakota residents the rights 24 afforded to them under North Dakota law. Individuals committed by a court of a 25 bordering state and placed in North Dakota facilities continue to be in the legal 26 custody of the bordering state. The bordering state's laws governing length of 27 commitment, reexaminations, and extension of commitment must continue to apply 28 to these residents. In all other respects, residents of a bordering state placed in 29 North Dakota facilities are subject to North Dakota laws. An agreement with a 30 bordering state must specify that responsibility for payment for the cost of care of a 31 resident of a bordering state remains with the bordering state of which that
